24 conditions and limitations:

25 (1) Notwithstanding the provisions in this section, the committee
26 may adjust the due dates for projects included on the committee's
27 2007-09 work plan as necessary to efficiently manage workload.

28 (2) \$100,000 of the general fund--state appropriation for fiscal
29 year 2008 is provided solely for the joint legislative audit and review
30 committee to conduct a review of the method used to determine lease
31 rates for state-owned aquatic lands. The review shall include
32 classification of current lease base and lease rates by category of use
33 such as marinas; a review of previous studies of formulas for
34 state-owned aquatic land leases; and identification of pros and cons of
35 alternative approaches to calculating aquatic lands lease rates. The
36 committee shall complete the review by June 2008.

1 (3) \$100,000 of the general fund--state appropriation for fiscal
2 year 2008 and \$50,000 of the general fund--state appropriation for
3 fiscal year 2009 are provided solely for the joint legislative audit
4 and review committee to conduct an evaluation and comparison of the
5 cost efficiency of rental housing voucher programs versus other housing
6 projects intended to assist low-income households, including
7 construction and rehabilitation of housing units. The study will
8 consider factors including administrative costs, capital costs, and
9 other operating costs involved in operating voucher and other housing
10 programs. The study will compare the number of households that can be
11 served by voucher and other housing programs, given a set amount of
12 available funds. The department of community, trade, and economic
13 development, the housing finance commission, housing authorities,
14 community action agencies, and local governments shall provide the
15 joint legislative audit and review committee with information necessary
16 for the study. The joint legislative audit and review committee shall
17 solicit input regarding the study from interested parties, including
18 representatives from the affordable housing advisory board, the
19 department of community, trade, and economic development, the housing
20 finance commission, representatives from the private rental housing
21 industry, housing authorities, community action agencies, county and
22 city governments, and nonprofit and for-profit housing developers. The
23 joint legislative audit and review committee shall present the results
24 of the study to the legislature by December 31, 2008.

25 (4) \$100,000 of the general fund--state appropriation for fiscal
26 year 2008 is provided solely for a cost analysis of the programs and
27 activities administered by the department of fish and wildlife. In
28 conducting the study, the committee shall specifically identify the
29 total costs that support both hunting and fishing programs as well as
30 nongame programs, including appropriate shares of the agency's
31 administrative and indirect costs. The committee shall compare the
32 cost analysis to revenues that currently support the programs,
33 including the level of support received from game licenses and fees.
34 The committee shall base its analysis on available management
35 information and shall provide the results of its analysis to the
36 legislature by January 2008.

7 legislative audit and review committee shall conduct an analysis of the

9 within the department of social and health services children's
10 administration. The committee shall conduct an analysis of the
11 qualifications used by other states for equivalent categories of social
12 workers. The committee shall analyze the strengths and weaknesses of
13 Washington's qualifications relative to the other states. The findings
14 shall be reported to the legislature by December 1, 2007.

15 (7) Within amounts provided in this section, the committee shall
16 conduct a review of the eligibility requirements and eligibility review
17 processes that apply to any state program that offers individual health
18 care coverage for qualified recipients.

5 legislative audit and review committee shall conduct a preaudit for a
6 comprehensive review of boards and commissions. The preaudit study
7 will inventory the existing boards/commissions, identify criteria for
8 selecting entities for further review, propose the scope and objectives
9 of those reviews, and identify resource and schedule options for the
10 committee to consider before proceeding.

11 (13) The joint legislative audit and review committee shall develop
12 a framework for future efforts to quantify and analyze health care
13 spending across all sectors of the state. This effort would focus on
14 identifying the relevant types of spending in the public and private
15 sectors, the availability of information on each of those types of
16 spending, and the extent to which that available information could be
17 tracked over time. In conducting this work, the committee shall work
18 with the legislative evaluation and accountability program committee
19 and the University of Washington's institute for health metrics and
20 evaluation, as appropriate. The committee shall provide a report by
21 January 2009.

37 conditions and limitations:

1 (1) \$3,900,000 of the general fund--state appropriation for fiscal
2 year 2008 and \$3,900,000 of the general fund--state appropriation for
3 fiscal year 2009 are provided solely for court-appointed special
4 advocates in dependency matters. The administrator for the courts,
5 after consulting with the association of juvenile court administrators
6 and the association of court-appointed special advocate/guardian ad
7 litem programs, shall distribute the funds to volunteer court-appointed
8 special advocate/guardian ad litem programs. The distribution of
9 funding shall be based on the number of children who need volunteer
10 court-appointed special advocate representation and shall be equally
11 accessible to all volunteer court-appointed special advocate/guardian
12 ad litem programs. The administrator for the courts shall not retain

11 administrator for the courts no later than 45 days after the end of the
12 fiscal year. The administrator for the courts shall electronically
13 transmit this information to the chairs and ranking minority members of
14 the house of representatives appropriations committee and the senate
15 ways and means committee no later than 60 days after a fiscal year
16 ends. These reports are deemed informational in nature and are not for
17 the purpose of distributing funds.

18 (4) The distributions made under this subsection and distributions
19 from the county criminal justice assistance account made pursuant to
20 section 801 of this act constitute appropriate reimbursement for costs
21 for any new programs or increased level of service for purposes of RCW
22 43.135.060.

23 (5) \$325,000 of the general fund--state appropriation for fiscal
24 year 2008 is provided solely for the completion of the juror pay pilot
25 and research project.

26 (6) \$1,000,000 of the general fund--state appropriation for fiscal
27 year 2008 and \$1,000,000 of the general fund--state appropriation for
28 fiscal year 2009 are provided solely for improving interpreter services
29 at the trial court level.

30 (a) Of these amounts, \$340,000 for fiscal year 2008 is provided
31 solely to assist trial courts in developing and implementing language
32 assistance plans. The administrator of the courts, in consultation
33 with the interpreter commission, shall adopt language assistance plan
34 standards consistent with chapters 2.42 and 2.43 RCW. The standards
35 shall include guidelines on local community input, provisions on
36 notifying court users on the right and methods to obtain an
37 interpreter, information on training for judges and court personnel,

1 procedures for identifying and appointing an interpreter, access to
2 translations of commonly used forms, and processes to evaluate the
3 development and implementation of the plan.

4 (b) Of these amounts, \$610,000 for fiscal year 2008 and \$950,000
5 for fiscal year 2009 are provided solely to assist trial courts with
6 interpreter services. In order to be eligible for assistance, a trial
7 court must have completed a language assistance plan consistent with
8 the standards established in (a) of this subsection that is approved by
9 the administrator of the courts and submit the amounts spent annually
10 on interpreter services for fiscal years 2005, 2006, and 2007. The
11 funding in this subsection (b) shall not be used to supplant existing
12 funding and cannot be used for any purpose other than assisting trial
13 courts with interpreter services. At the end of the fiscal year,
14 recipients shall report to the administrator of the court the amount
15 the trial court spent on interpreter services.

16 (c) \$50,000 for fiscal year 2008 and \$50,000 for fiscal year 2009
17 are provided solely to the administrator of the courts for
18 administration of this subsection. By December 1, 2009, the
19 administrator of the courts shall report to the appropriate policy and
20 fiscal committees of the legislature: (i) The number of trial courts
21 in the state that have completed a language assistance plan; (ii) the
22 number of trial courts in the state that have not completed a language
23 assistance plan; (iii) the number of trial courts in the state that
24 received assistance under this subsection, the amount of the
25 assistance, and the amount each trial court spent on interpreter
26 services for fiscal years 2005 through 2008 and fiscal year 2009 to

7 dependent on successful data exchange to their regular meetings for
8 consultation as nonvoting members.

29 appropriation for fiscal year 2009 are provided solely for a
30 nonviolence and leadership training program provided by the institute
31 for community leadership. The program shall provide a request for
32 proposal process, with up to 80 percent funding, for nonviolence
33 leadership workshops serving at least 12 school districts with direct
34 programming in 36 elementary, middle, and high schools throughout
35 Washington state.

36 (vii) \$100,000 of the general fund--state appropriation for fiscal
37 year 2008 and \$100,000 of the general fund--state appropriation for
38 fiscal year 2009 are provided solely for a pilot youth suicide

1 prevention and information program. The office of superintendent of
2 public instruction will work with selected school districts and
3 community agencies in identifying effective strategies for preventing
4 youth suicide.

5 (viii) \$800,000 of the general fund--state appropriation for fiscal
6 year 2008 and \$800,000 of the general fund--state appropriation for
7 fiscal year 2009 are provided solely for programs to improve safety and
8 emergency preparedness and planning in public schools, as generally

10 (b) TECHNOLOGY

11 \$1,939,000 of the general fund--state appropriation for fiscal year
12 2008 and \$1,939,000 of the general fund--state appropriation for fiscal
13 year 2009 are provided solely for K-20 telecommunications network
14 technical support in the K-12 sector to prevent system failures and
15 avoid interruptions in school utilization of the data processing and
16 video-conferencing capabilities of the network. These funds may be
17 used to purchase engineering and advanced technical support for the
18 network.

19 (c) GRANTS AND ALLOCATIONS

20 (i) \$652,000 of the general fund--state appropriation for fiscal
21 year 2008 and \$1,329,000 of the general fund--state appropriation for
22 fiscal year 2009 are provided solely to expand the special services
23 pilot project to include up to seven participating districts. The
24 office of the superintendent of public instruction shall allocate these
25 funds to the district or districts participating in the pilot program

4 year 2008 and \$146,000 of the general fund--state appropriation for
5 fiscal year 2009 are provided solely for the Washington civil liberties
6 education program.

7 (v) \$1,000,000 of the general fund--state appropriation for fiscal
8 year 2008 and \$1,000,000 of the general fund--state appropriation for
9 fiscal year 2009 are provided solely for the Washington state achievers
10 scholarship program. The funds shall be used to support community
11 involvement officers that recruit, train, and match community volunteer
12 mentors with students selected as achievers scholars.

13 (vi) \$294,000 of the general fund--state appropriation for fiscal
14 year 2008 and \$294,000 of the general fund--state appropriation for
15 fiscal year 2009 are provided solely for the Lorraine Wojahn dyslexia
16 pilot reading program in up to five school districts.

17 (vii) \$75,000 of the general fund--state appropriation for fiscal
18 year 2008 and \$75,000 of the general fund--state appropriation for
19 fiscal year 2009 are provided solely for developing and disseminating
20 curriculum and other materials documenting women's role in World War
21 II.

22 (viii) \$175,000 of the general fund--state appropriation for fiscal
23 year 2008 and \$175,000 of the general fund--state appropriation for
24 fiscal year 2009 are provided solely for incentive grants for districts
25 and pilot projects to develop preapprenticeship programs. Incentive
26 grant awards up to \$10,000 each shall be used to support the program's
27 design, school/business/labor agreement negotiations, and recruiting
28 high school students for preapprenticeship programs in the building
29 trades and crafts.

30 (ix) \$3,220,000 of the general fund--state appropriation for fiscal
31 year 2008 and \$3,220,000 of the general fund--state appropriation for
32 fiscal year 2009 are provided solely for the dissemination of the
33 Navigation 101 curriculum to all districts, including disseminating
34 electronic student planning tools and software for analyzing the impact
35 of the implementation of Navigation 101 on student performance, and
36 grants to at least one hundred school districts each year for the
37 implementation of the Navigation 101 program. The implementation
38 grants will be limited to a maximum of two years and the school

1 districts selected shall represent various regions of the state and
2 reflect differences in school district size and enrollment
3 characteristics.

4 (x) \$36,000 of the general fund--state appropriation for fiscal
5 year 2008 and \$36,000 of the general fund--state appropriation for

7 education. Of this amount, \$25,000 each year is provided solely for
8 competitive grants to school districts for curriculum alignment,
9 development of innovative civics projects, and other activities that
10 support the civics assessment established in chapter 113, Laws of 2006.

11 (xi) \$2,500,000 of the general fund--state appropriation for fiscal
12 year 2008 and \$2,500,000 of the general fund--state appropriation for
13 fiscal year 2009 are provided solely for the implementation of Second
14 Substitute House Bill No. 1573 (authorizing a statewide program for
15 comprehensive dropout prevention, intervention, and retrieval). If the
16 bill is not enacted by June 30, 2007, the amounts provided in this
17 subsection shall lapse.

18 (xii) \$25,000 of the general fund--state appropriation for fiscal
19 year 2008 and \$25,000 of the general fund--state appropriation for
20 fiscal year 2009 are provided solely for the communities in school
21 program in Pierce county.

22 (xiii) \$500,000 of the general fund--state appropriation for fiscal
23 year 2008 and \$500,000 of the general fund--state appropriation for

12 (1) Funding for special education programs is provided on an excess
13 cost basis, pursuant to RCW 28A.150.390. School districts shall ensure
14 that special education students as a class receive their full share of

(c) The health care authority shall deposit any moneys received on behalf of the uniform medical plan as a result of rebates on prescription drugs, audits of hospitals, subrogation payments, or any other moneys recovered as a result of prior uniform medical plan claims payments, into the public employees' and retirees' insurance account to be used for insurance benefits. Such receipts shall not be used for administrative expenditures.

(2) The health care authority, subject to the approval of the public employees' benefits board, shall provide subsidies for health benefit premiums to eligible retired or disabled public employees and school district employees who are eligible for medicare, pursuant to RCW 41.05.085. From January 1, 2008, through December 31, 2008, the subsidy shall be \$164.08. Starting January 1, 2009, the subsidy shall be \$182.89 per month.

27 through funding for new enrollments and financial aid, and other
28 educational improvement efforts. During the 2007-2009 fiscal biennium,
29 moneys in the account may also be transferred into the state general
30 fund.

31 **Sec. 917.** RCW 90.48.390 and 1991 sp.s. c 13 s 84 are each amended
32 to read as follows:

33 The coastal protection fund is established to be used by the
34 department as a revolving fund for carrying out the purposes of
35 restoration of natural resources under this chapter and chapter 90.56

1 RCW. To this fund there shall be credited penalties, fees, damages,
2 charges received pursuant to the provisions of this chapter and chapter
3 90.56 RCW, compensation for damages received under this chapter and
4 chapter 90.56 RCW, and an amount equivalent to one cent per gallon from
5 each marine use refund claim under RCW 82.36.330.

6 Moneys in the fund not needed currently to meet the obligations of
7 the department in the exercise of its powers, duties, and functions
8 under RCW 90.48.142, 90.48.366, 90.48.367, and 90.48.368 shall be
9 deposited with the state treasurer to the credit of the fund. During
10 the 2007-2009 fiscal biennium, the coastal protection fund may also be
11 used for a standby rescue tug at Neah Bay.

12 NEW SECTION. **Sec. 918.** If any provision of this act or its
13 application to any person or circumstance is held invalid, the
14 remainder of the act or the application of the provision to other
15 persons or circumstances is not affected.

16 NEW SECTION. **Sec. 919.** This act is necessary for the immediate
17 preservation of the public peace, health, or safety, or support of the
18 state government and its existing public institutions, and takes effect
19 immediately.
