2 the 2015-2017 fiscal biennium, making capital reappropriations for  
3 the 2017-2019 fiscal biennium, and making new appropriations for the  
4 school construction assistance program for the 2017-2019 fiscal

13 informational purposes only and do not constitute legislative  
14 approval of these amounts. "Prior biennia" typically refers to the  
15 immediate prior biennium for reappropriations, but may refer to  
16 multiple biennia in the case of specific projects. A "future biennia"  
17 amount is an estimate of what may be appropriated for the project or  
18 program in the 2019-2021 biennium and the following three biennia; an  
19 amount of zero does not necessarily constitute legislative intent to  
20 not provide funding for the project or program in the future.

1 (2) "Reappropriations" in this act are appropriations and, unless  
2 the context clearly provides otherwise, are subject to the relevant  
3 conditions and limitations applicable to appropriations.  
4 Reappropriations shall be limited to the unexpended balances  
5 remaining on June 30, 2017, from the 2015-2017 biennial  
6 appropriations for each project.

PART 7

MISCELLANEOUS PROVISIONS

NEW SECTION. **Sec. 7001.** To ensure that major construction projects are carried out in accordance with legislative and executive intent, appropriations in this act in excess of \$5,000,000, or \$10,000,000 for higher education institutions, may not be expended or encumbered until the office of financial management has reviewed and approved the agency's predesign. The predesign document must include, but not be limited to, program, site, and cost analysis, and an analysis of the life-cycle costs of the alternatives explored, in accordance with the predesign manual adopted by the office of financial management.

NEW SECTION. **Sec. 7002.** For facilities with an area of 5,000 square feet or greater, the results of a life-cycle cost analysis of building systems must be a primary consideration in the selection of a building design. Construction may proceed only upon providing to the office of financial management the life-cycle costs.

NEW SECTION. **Sec. 7003.** To improve monitoring of major construction projects, progress reports must be submitted by the agency administering the project to the office of financial management and to the fiscal committees of the house of representatives and senate. Reports must be submitted on July 1st and December 31st each year in a format to be determined by the office of financial management.

NEW SECTION. **Sec. 7004.** (1) Allotments for appropriations in this act shall be provided in accordance with the capital project review requirements adopted by the office of financial management and in compliance with RCW 43.88.110. Projects that will be employing alternative public works construction procedures under chapter 39.10 RCW are subject to the allotment procedures defined in this section and RCW 43.88.110.

(2) Each project is defined as proposed in the legislative budget notes or in the governor's budget document.

NEW SECTION. **Sec. 7005.** (1) The office of financial management may authorize a transfer of appropriation authority provided for a



1 capital project that is in excess of the amount required for the  
2 completion of such project to another capital project for which the  
3 appropriation is insufficient. No such transfer may be used to expand  
4 the capacity of any facility beyond that intended in making the  
5 appropriation. Such transfers may be effected only between capital  
6 appropriations to a specific department, commission, agency, or  
7 institution of higher education and only between capital projects  
8 that are funded from the same fund or account. No transfers may occur  
9 between projects to local government agencies except where the grants  
10 are provided within a single omnibus appropriation and where such  
11 transfers are specifically authorized by the implementing statutes  
12 that govern the grants.

13 (2) The office of financial management may find that an amount is  
14 in excess of the amount required for the completion of a project only  
15 if: (a) The project as defined in the notes to the budget document is  
16 substantially complete and there are funds remaining; or (b) bids  
17 have been let on a project and it appears to a substantial certainty  
18 that the project as defined in the notes to the budget document can  
19 be completed within the biennium for less than the amount  
20 appropriated in this act.

21 (3) For the purposes of this section, the intent is that each  
22 project be defined as proposed to the legislature in the governor's  
23 budget document, unless it clearly appears from the legislative  
24 history that the legislature intended to define the scope of a  
25 project in a different way.

26 (4) A report of any transfer effected under this section, except  
27 emergency projects or any transfer under \$250,000, shall be filed  
28 with the legislative fiscal committees of the senate and house of  
29 representatives by the office of financial management at least thirty  
30 days before the date the transfer is effected. The office of  
31 financial management shall report all emergency or smaller transfers  
32 within thirty days from the date of transfer.

33 NEW SECTION. **Sec. 7006.** (1) It is expected that projects be  
34 ready to proceed in a timely manner depending on the type or phase of  
35 the project or program that is the subject of the appropriation in  
36 this act. Except for major projects that customarily may take more  
37 than two biennia to complete from predesign to the end of  
38 construction, or large infrastructure grant or loan programs  
39 supporting projects that often take more than two biennia to

1 complete, the legislature generally does not intend to reappropriate  
2 funds more than once, particularly for smaller grant programs, local/  
3 community projects, and minor works.

4 (2) Agencies shall expedite the expenditure of reappropriations

6 infrastructure resources; (b) accelerate environmental rehabilitation  
7 and restoration projects for the improvement of the state's natural  
8 environment; (c) reduce additional costs associated with acquisition  
9 and construction inflationary pressures; and (d) provide additional  
10 employment opportunities associated with capital expenditures.

11 (3) To the extent feasible, agencies are directed to accelerate  
12 expenditure rates at their current level of permanent employees and  
13 shall use contracted design and construction services wherever  
14 necessary to meet the goals of this section.

15 NEW SECTION. **Sec. 7007.** (1) Any building project that receives  
16 over \$10,000,000 in funding from the capital budget must be built to  
17 sustainable standards. "Sustainable building" means a building that  
18 integrates and optimizes all major high-performance building  
19 attributes, including energy efficiency, durability, life-cycle  
20 performance, and occupant productivity. The following design and  
21 construction attributes must be integrated into the building project:

22 (a) Employ integrated design principles: Use a collaborative,  
23 integrated planning and design process that initiates and maintains  
24 an integrated project team in all stages of a project's planning and  
25 delivery. Establish performance goals for siting, energy, water,  
26 materials, and indoor environmental quality along with other  
27 comprehensive design goals and ensures incorporation of these goals  
28 throughout the design and life-cycle of the building. Considers all  
29 stages of the building's life-cycle, including deconstruction.

30 (b) Commissioning: Employ commissioning practices tailored to the  
31 size and complexity of the building and its system components in  
32 order to verify performance of building components and systems and  
33 help ensure that design requirements are met. This should include an  
34 experienced commissioning provider, inclusion of commissioning  
35 requirements in construction documents, a commissioning plan,  
36 verification of the installation and performance of systems to be  
37 commissioned, and a commissioning report.

38 (c) Optimize energy performance: Establish a whole building  
39 performance target that takes into account the intended use,

1 occupancy, operations, plug loads, other energy demands, and design  
2 to earn the ENERGY STAR targets for new construction and major  
3 renovation where applicable. For new construction target low energy  
4 use index. For major renovations, reduce the energy use by fifty  
5 percent below prerenovations baseline.

6 (d) On-site renewable energy: Meet at least thirty percent of the  
7 hot water demand through the installation of solar hot water heaters,  
8 when life-cycle cost effective. Implement renewable energy generation  
9 projects on agency property for agency use, when life-cycle cost  
10 effective.

11 (e) Measurement and verification: Install building level  
12 electricity meters in new major construction and renovation projects  
13 to track and continuously optimize performance. Include equivalent  
14 meters for natural gas and steam, where natural gas and steam are  
15 used. Install dashboards inside buildings to display and incentivize  
16 occupants on energy use.

17 (f) Benchmarking: Compare actual performance data from the first  
18 year of operation with the energy design target. Verify that the  
19 building performance meets or exceeds the design target. For other  
20 building and space types, use an equivalent benchmarking tool for  
21 laboratory buildings. Web-based data collection and dashboards must  
22 also be provided.

23 NEW SECTION. **Sec. 7008.** State agencies, including institutions  
24 of higher education, shall allot and report full-time equivalent  
25 staff for capital projects in a manner comparable to staff reporting  
26 for operating expenditures.

27 NEW SECTION. **Sec. 7009.** Executive Order No. 05-05,  
28 archaeological and cultural resources, was issued effective November  
29 10, 2005. Agencies shall comply with the requirements set forth in  
30 this executive order.

31 NEW SECTION. **Sec. 7010.** To carry out the provisions of this  
32 act, the governor may assign responsibility for predesign, design,  
33 construction, and other related activities to any appropriate agency.

34 NEW SECTION. **Sec. 7011.** If any federal moneys appropriated by  
35 this act for capital projects are not received by the state, the  
36 department or agency to which the moneys were appropriated may

1 replace the federal moneys with funds available from private or local  
2 sources. No replacement may occur under this section without the  
3 prior approval of the director of financial management in  
4 consultation with the senate ways and means committee and the house  
5 of representatives capital budget committee.

6 NEW SECTION. **Sec. 7012.** (1) Unless otherwise stated, for all  
7 appropriations under this act that require a match of nonstate money  
8 or in-kind contributions, the following requirement, consistent with  
9 RCW 43.88.150, shall apply: Expenditures of state money shall be  
10 timed so that the state share of project expenditures never exceeds  
11 the intended state share of total project costs.

12 (2) Provision of the full amount of required matching funds is  
13 not required to permit the expenditure of capital budget  
14 appropriations for phased projects if a proportional amount of the  
15 required matching funds is provided for each distinct, identifiable  
16 phase of the project.

17 NEW SECTION. **Sec. 7013.** If any provision of this act or its  
18 application to any person or circumstance is held invalid, the  
19 remainder of the act or the application of the provision to other  
20 persons or circumstances is not affected.

21 NEW SECTION. **Sec. 7014.** This act is necessary for the immediate  
22 preservation of the public peace, health, or safety, or support of  
23 the state government and its existing public institutions, and takes  
24 effect immediately.
