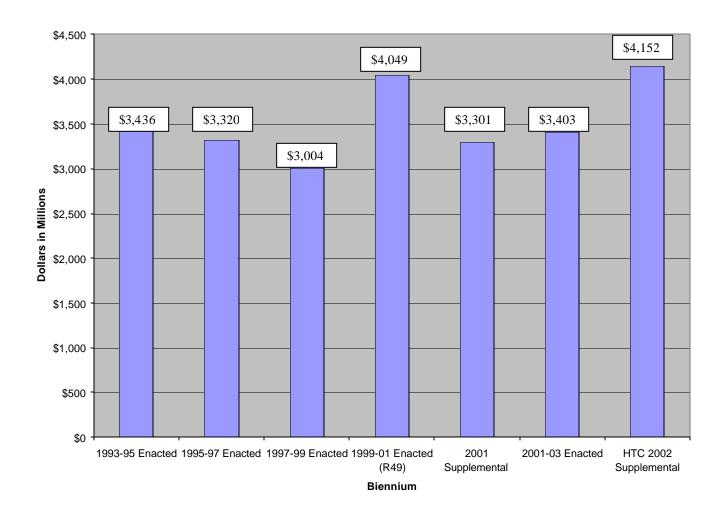

2002 Supplemental Transportation Budget

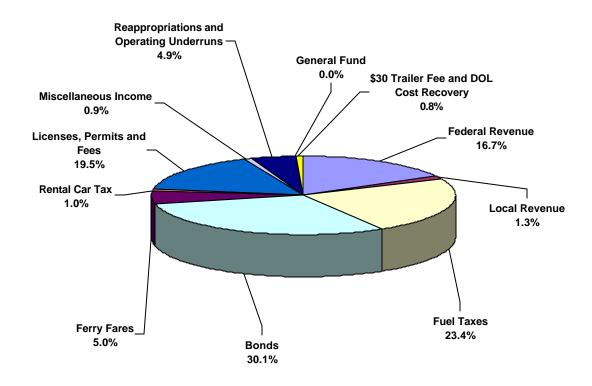

Revisions to the 2001-03 Enacted Transportation Budget

Department of Transportation

- \$800 Million for construction of a second bridge over the Tacoma Narrows.
- \$14.9 Million for increased self-insurance liability premiums.
- \$11.7 Million in savings for ferry fuel.
- \$1 Million for ferry insurance premium increase.
- \$900,000 for maintaining existing levels of passenger rail service.
- \$518,000 reduction for motorist information panel program.
- \$398,000 for US v. Washington (Culverts).
- \$350,000 for grants to local airports.
- \$147,000 state match for federal aviation planning grants.
- \$75.6 Million reduction to the improvement program associated with the following projects:
 - o SR 167 North Sumner New Interchange
 - o SR 202 SR 520 to Sahalee Way Widening
 - o SR 510 Martin Way to Pacific Ave
 - o SR 527 164th St SE to 132nd St SE

County Road Administration Board

• \$8.7 Million for additional grants to counties.

Transportation Improvement Board

• \$25.9 Million for additional mobility improvement grants to local jurisdictions.

Washington State Patrol

- \$137,000 for Weigh in Motion maintenance.
- \$ 1.9 Million for Sate Ferry Security.
- \$ 243.000 for MCSAP Grant Increase.
- \$12.6 Million for one time General Fund assistance.
- \$1 Million reduction for technical adjustments.
