13 apparatus on state roadways. The study shall determine, at a
14 minimum, the various types of fire-fighting apparatus currently in
15 use on state roadways; the size, weight and load effect of fire-
16 fighting apparatus that are currently in use or that potentially
17 could be in use on the state roadways, as well as on state bridges;
18 and the effect on public safety. The study may examine state and
19 federal laws that affect fire-fighting apparatuses. House of
20 representatives transportation committee cochairs shall each appoint
21 one member from their respective caucus to serve as cochair of the
22 study group. The study shall be staffed by house of representatives
23 transportation committee staff. The study group will report back to
24 the house of representatives transportation committee by January 1,
25 2002.

26 (5) The legislative transportation committee shall conduct a
27 feasibility study of potential for economic partnerships between the
28 Washington state ferries and local government entities, including but
29 not limited to port districts. The study is intended to improve
30 ferry terminals. The study shall, at a minimum, identify the market,
31 physical, and economic factors that should be examined in determining
32 whether an economic or commercial development partnership project on
33 or around Washington state ferry terminals is likely to produce
34 revenue for the partners. The study shall apply those factors to an
35 analysis of each terminal used by Washington state ferries and
36 recommend whether further exploration of state and local partnerships
37 would be of potential economic benefit to the partners. The entity
38 selected to perform the study through the request for proposals
39 process will report back to the transportation committees of the
40 legislature by December 1, 2001.

41 (6) The legislative transportation committee, in cooperation with
42 an areawide transportation system or systems, shall undertake an
43 evaluation of providing locally sponsored transit services in a local
44 community supplemental to those services provided by an areawide
45 system. The evaluation shall address:

- 46 (a) The costs and benefits of providing such services;
- 47 (b) The impact of such service on ridership on the areawide
48 system and on any regional systems;
- 49 (c) Funding options for supplemental services; and
- 50 (d) Institutional arrangements affecting the institution of
51 supplemental services.

52 The committee shall work with the department of transportation,
53 areawide transit providers, community officials, private businesses,
54 labor organizations, and others as appropriate in conducting the
55 evaluation, and in developing a pilot project if feasible. The
56 committee shall provide an interim progress report to the legislature
57 by January 2002. The committee shall report its findings to the
58 legislature not later than December 1, 2002.

1 (7) The legislative transportation committee shall convene a task
2 force on airport siting. The task force shall include legislators,
3 representatives from Washington ports, representatives from the
4 economic development community, and other interested parties. The
5 task force shall examine and make recommendations on potential
6 airport siting legislation. The task force shall report its findings
7 and recommendations to the legislature by December 1, 2002.

8 (8) The legislative transportation committee shall undertake an
9 evaluation of the statutory exemptions for transportation taxes,
10 including but not limited to motor vehicle fuel taxes. The committee
11 shall report its findings to the legislature by December 1, 2002.

12 (9) The legislative transportation committee shall conduct a
13 study of whether the current two local transit agency approach best
14 meets Snohomish County's need for transit service. The committee
