(2) Allocations for certificated staff salaries for the 2007-08 and 14 15 2008-09 school years shall be determined using formula-generated staff units calculated pursuant to this subsection. Staff allocations for 16 small school enrollments in (e) through (g) of this subsection shall be 17 reduced for vocational full-time equivalent enrollments. 18 Staff allocations for small school enrollments in grades K-6 shall be the 19 20 greater of that generated under (a) of this subsection, or under (d) 21 and (e) of this subsection. Certificated staffing allocations shall be as follows: 2.2

The regional universities and The Evergreen State College may implement an increase no greater than five 8 percent over tuition fees charged to full-time resident undergraduate 9 10 students for the 2007-08 academic year. The state board for community and technical colleges may implement an increase no greater than an 11 <u>average of</u> two percent over tuition and fees charged to ((full-time)) 12 13 resident students for the 2007-08 academic year.
