If the department receives unanticipated unrestricted federal moneys, those moneys shall be spent for services authorized in this act or in any other legislation providing appropriation authority, and an equal amount of appropriated state general fund moneys shall lapse. Upon the lapsing of any moneys under this subsection, the office of financial management shall notify the legislative fiscal committees. As used in this subsection, "unrestricted federal moneys" includes block grants and other funds that federal law does not require to be spent on specifically defined projects or matched on a formula basis by state funds.
- (3)(a) The health care authority and the department are authorized to develop an integrated health care program designed to slow the progression of illness and disability and better manage medicaid expenditures for the aged and disabled population. Under ((this)) the Washington medicaid integration partnership (WMIP) and the medicare

integrated care project (MICP), the health care authority and the 1 2 department may combine and transfer such medicaid funds appropriated under sections 204, 206, 208, and 213 of this act as may be necessary 3 4 to finance a unified health care plan for the WMIP and the MCIP program enrollment. The WMIP pilot projects shall not exceed a daily 5 6 enrollment of 6,000 persons, nor expand beyond one county during the 2011-2013 fiscal biennium. The amount of funding assigned from each 7 8 program may not exceed the average per capita cost assumed in this act 9 for individuals covered by that program, actuarially adjusted for the health condition of persons enrolled, times the number of clients 10 11 In implementing the WMIP and the MICP, the health care 12 authority and the department may: $((\frac{a}{a}))$ (i) Withhold from calculations of "available resources" as set forth in RCW 71.24.025 a 13 sum equal to the capitated rate for enrolled individuals; and $((\frac{b}{b}))$ 14 (ii) employ capitation financing and risk-sharing arrangements in 15 collaboration with health care service contractors licensed by the 16 office of the insurance commissioner and qualified to participate in 17 both the medicaid and medicare programs. The health care authority and 18 19 the department shall conduct an evaluation of the WMIP((τ)) by October 15, 2012, and of the MICP measuring changes in participant health 20 21 outcomes, changes in patterns of service utilization, participant 22 satisfaction, participant access to services, and the state fiscal 23 impact.

(b) Effective January 1, 2013, if Washington has been selected to participate in phase two of the federal demonstration project for persons dually-eligible for both medicare and medicaid, the department and the authority may initiate the MICP. Participation in the project shall be limited to persons who are eligible for both medicare and medicaid and to counties in which the county legislative authority has agreed to the terms and conditions under which it will operate. The purpose of the project shall be to demonstrate and evaluate ways to improve care while reducing state expenditures for persons enrolled both in medicare and medicaid. To that end, prior to initiating the project, the department and the authority shall assure that state expenditures shall be no greater on either a per person or total basis than the state would otherwise incur. Individuals who are solely eligible for medicaid may also participate if their participation is

Voluntary consolidation of regional support networks is expected to result in administrative efficiencies and maximize dollars available for direct services to individuals with mental illnesses without corresponding increases in state appropriations.

The assessor shall extend the amounts upon the tax rolls covering the property, and upon authorization from the department shall levy the forest protection assessment against the amounts of unimproved land as shown in each ownership on the county assessor's records. The assessor may then segregate on the records to provide that the improved land and improvements thereon carry the millage levy designed to support the rural fire protection districts as provided for in RCW 52.16.170.
- (5) The amounts assessed shall be collected at the time, in the same manner, by the same procedure, and with the same penalties attached that general state and county taxes on the same property are collected, except that errors in assessments may be corrected at any time by the department certifying them to the treasurer of the county in which the land involved is situated. Assessments shall be known and designated as assessments of the year in which the amounts became reimbursable. Upon the collection of assessments the county treasurer shall place fifty cents of the total assessments paid on a parcel for fire protection into the county current expense fund to defray the costs of listing, billing, and collecting these assessments. treasurer shall then transmit the balance to the department. Collections shall be applied against expenses incurred in carrying out the provisions of this section, including necessary and reasonable administrative costs incurred by the department in the enforcement of these provisions. The department may also expend sums collected from owners of forest lands or received from any other source for necessary

 - (6) When land against which forest protection assessments are outstanding is acquired for delinquent taxes and sold at public auction, the state shall have a prior lien on the proceeds of sale over and above the amount necessary to satisfy the county's delinquent tax judgment.  - (8) A public body, having failed to previously pay the forest protection assessments required of it by this section, which fails to suppress a fire on or originating from forest lands owned or administered by it, is liable for the costs of suppression incurred by the department or its agent and is not entitled to reimbursement of costs incurred by the public body in the suppression activities.
- 34 (9) The department may adopt rules to implement this section, 35 including, but not limited to, rules on levying and collecting forest 36 protection assessments.
