4 NEW SECTION. **Sec. 1.** (1) The transportation budget of the state
5 is hereby adopted and, subject to the provisions set forth, the several
6 amounts specified, or as much thereof as may be necessary to accomplish
7 the purposes designated, are hereby appropriated from the several
8 accounts and funds named to the designated state agencies and offices
9 for employee compensation and other expenses, for capital projects, and
10 for other specified purposes, including the payment of any final
11 judgments arising out of such activities, for the period ending June
12 30, 2015.

13 (2) Unless the context clearly requires otherwise, the definitions
14 in this subsection apply throughout this act.

15 (a) "Fiscal year 2014" or "FY 2014" means the fiscal year ending
16 June 30, 2014.

17 (b) "Fiscal year 2015" or "FY 2015" means the fiscal year ending
18 June 30, 2015.

19 (c) "FTE" means full-time equivalent.

20 (d) "Lapse" or "revert" means the amount shall return to an
21 unappropriated status.

22 (e) "Provided solely" means the specified amount may be spent only
23 for the specified purpose. Unless otherwise specifically authorized in
24 this act, any portion of an amount provided solely for a specified
25 purpose that is not expended subject to the specified conditions and
26 limitations to fulfill the specified purpose shall lapse.

27 (f) "Reappropriation" means appropriation and, unless the context
28 clearly provides otherwise, is subject to the relevant conditions and
29 limitations applicable to appropriations.

26 RCW 46.68.120(3), to contract with the Washington state association of
27 counties to identify, analyze, evaluate, and implement county
28 transportation performance measures associated with transportation
29 system policy goals outlined in RCW 47.04.280. The Washington state
30 association of counties, in cooperation with state agencies, must:
31 Identify, analyze, and report on county transportation system
32 preservation; identify, evaluate, and report on opportunities to
33 streamline reporting requirements for counties; and evaluate project
34 management tools to help improve project delivery at the county level.

1 (2) \$70,000 of the Puget Sound ferry operations account--state
2 appropriation is provided solely for the state's share of the marine
3 salary survey.

20 provided solely to test the quality of biofuel. The department must
21 test fuel quality at the biofuel manufacturer, distributor, and
22 retailer.

29 The appropriation in this section is subject to the following
30 conditions and limitations:

31 (1) \$243,000 of the motor vehicle account--state appropriation is
32 for the joint legislative audit and review committee to conduct a

1 review of the methods and systems used by the department of
2 transportation to develop asset condition and maintenance service level
3 needs and subsequent funding requests for highway preservation and
4 maintenance programs, to include tolled facilities. The review will
5 examine whether the methods and systems used by the department of
6 transportation for estimating preservation and maintenance needs and
7 costs are consistent with industry practices and other appropriate
8 standards. The review will include analysis of a selection of
9 preservation and maintenance requests and address issues such as:

10 (a) Was a systematic, documented process used to develop the
11 estimate of need?

12 (b) Are practices in place to minimize life-cycle preservation and
13 maintenance costs?

14 (c) Was each stage in the cost estimating process fully documented?

15 (d) If appropriate, how were risks to the cost estimate quantified?

16 (e) What steps are in place to ensure that requests are not unduly
17 impacted by outside pressures?

18 Expert engineering or cost estimating consultants may be used to
19 review methods, systems, and individual estimates for accuracy. A
20 briefing report, focusing on an overview of the methods and processes,
21 must be completed by December 2013. A report containing any findings
22 and recommendations must be completed by December 2014.

23 (2) The joint legislative audit and review committee must conduct
24 a forensic audit of the Interstate 5/Columbia River Crossing project
25 (400506A) to investigate possible misuse of public funds. The joint
26 legislative audit and review committee may contract with the state
27 auditor's office for fraud-related investigation services, if
28 necessary.

29 NEW SECTION. **Sec. 109. FOR THE DEPARTMENT OF FISH AND WILDLIFE**
30 Motor Vehicle Account--State Appropriation \$295,000

31 The appropriation in this section is subject to the following
32 conditions and limitations:

33 (1) \$200,000 of the motor vehicle account--state appropriation is
34 from the cities statewide fuel tax distributions under RCW 46.68.110(2)
35 and is provided solely for the department to inventory, prioritize, and
36 study fish passage barriers associated with city roads and streets in

1 the Puget Sound region. The department shall submit the results to the
2 department of transportation and to organizations representing cities
3 by June 30, 2015.

4 (2) \$95,000 of the motor vehicle account--state appropriation is
5 from the counties statewide fuel tax distribution under RCW
6 46.68.120(3) and is provided solely for the department of
7 transportation to contract with the department to inventory, assess,
8 and prioritize fish passage barriers associated with county roads. The
9 department shall submit the results to the department of
10 transportation, the office of financial management, and the
11 transportation committees of the legislature by June 30, 2015.

22 (1) The commission shall develop and implement, in collaboration
23 with the Washington state patrol, a target zero team pilot program in
24 Yakima and Spokane counties. The pilot program must demonstrate the
25 effectiveness of intense, high visibility driving under the influence
26 enforcement in Washington state. The commission shall apply to the
27 national highway traffic safety administration for federal highway
28 safety grants to cover the cost of the pilot program.

29 (2) \$20,000,000 of the highway safety account--federal
30 appropriation is provided solely for federal funds that may be
31 obligated to the commission pursuant to 23 U.S.C. Sec. 164 during the
32 2013-2015 fiscal biennium.

33 (3) Of the amounts provided in this section, any amounts that are
34 granted by the commission for the traffic safety resource prosecutor

1 program must be directed to the Washington association of prosecuting
2 attorneys.

3 (4) The commission may continue to oversee pilot projects
4 implementing the use of automated traffic safety cameras to detect
5 speed violations within cities west of the Cascade mountains that have
6 a population over one hundred ninety-five thousand. For the purposes
7 of pilot projects in this subsection, no more than one automated
8 traffic safety camera may be used to detect speed violations within any
9 one jurisdiction.

10 (a) The commission shall comply with RCW 46.63.170 in administering
11 the pilot projects.

12 (b) By January 1, 2015, any local authority that is operating an
13 automated traffic safety camera to detect speed violations must provide
14 a summary to the transportation committees of the legislature
15 concerning the use of the cameras and data regarding infractions,
16 revenues, and costs.

28 The appropriation in this section is subject to the following
29 conditions and limitations:

30 (1)(a) \$325,000 of the motor vehicle account--state appropriation
31 is for a study of transportation cost drivers and potential
32 efficiencies to contain project costs and gain more value from
33 investments in Washington state's transportation system. The goal is
34 to enable the department of transportation to construct bridge and
35 highway projects more quickly and to build and operate them at a lower

1 cost, while ensuring that appropriate environmental and regulatory
2 protections are maintained and a quality project is delivered. The
3 joint transportation committee must convene an advisory panel to
4 provide study guidance and discuss potential efficiencies and
5 recommendations. The scope of the study must be limited to state-level
6 policies and practices relating to the planning, design, permitting,
7 construction, financing, and operation of department of transportation
8 roadway and bridge projects. The study must:

9 (i) Identify best practices;

10 (ii) Identify inefficiencies in state policy or agency practice
11 where changes may save money;

12 (iii) Recommend changes to improve efficiency and save money; and

13 (iv) Identify potential savings to be achieved by adopting changes
14 in practice or policy.

15 (b) The joint transportation committee shall issue a report of its
16 findings to the house of representatives and senate transportation
17 committees by December 31, 2013.

18 (2) The joint transportation committee shall coordinate a work
19 group comprised of the department of licensing, the department of
20 revenue, county auditors or other agents, and subagents to identify
21 possible issues relating to the administration of, compliance with, and
22 enforcement of the existing statutory requirement for a person to
23 provide an unexpired driver's license when registering a vehicle. The
24 work group shall provide recommendations on how administration and
25 enforcement may be modified, as needed, to address any identified
26 issues, including whether statutory changes may be needed. A report
27 presenting the recommendations must be presented to the house of
28 representatives and senate transportation committees by December 31,
29 2013.

30 (3) The joint transportation committee shall continue to convene a
31 subcommittee for legislative oversight of the I-5/Columbia river
32 crossing bridge replacement project. The Columbia river crossing
33 legislative oversight subcommittee must be made up of six members: Two
34 appointed by the cochairs of the senate transportation committee, two
35 appointed by the chair and ranking member of the house of
36 representatives transportation committee, one designee of the governor,
37 and one citizen jointly appointed by the four members of the joint
38 transportation executive committee. The citizen appointee must be a

1 Washington state resident of the area served by the bridge. At least
2 two of the legislative members must be from the legislative districts
3 served by the bridge. In addition to reviewing project and financing
4 information, the subcommittee must also coordinate with the Oregon
5 legislative oversight committee for the Columbia river crossing bridge.

6 (4) The joint transportation committee shall convene a work group
7 to identify and evaluate internal refinance opportunities for the
8 Tacoma Narrows bridge. The study must include a staff work group,
9 including staff from the office of financial management, the
10 transportation commission, the department of transportation, the office
11 of the state treasurer, and the legislative transportation committees.
12 The joint transportation committee shall issue a report of its findings
13 to the house of representatives and the senate transportation
14 committees by December 31, 2013.

15 (5) The joint transportation committee shall study and review the
16 use of surplus property proceeds to fund facility replacement projects,
17 and the possibility of using the north central region as a pilot. The
18 joint transportation committee shall consult with the department of
19 transportation and the office of financial management regarding the
20 department's current process for prioritizing and funding facility
21 improvement and replacement projects.

27 The appropriations in this section are subject to the following
28 conditions and limitations:

29 (1) Consistent with RCW 43.135.055, 47.60.290, and 47.60.315,
30 during the 2013-2015 fiscal biennium, the legislature authorizes the
31 transportation commission to periodically review and, if necessary,
32 adjust the schedule of fares for the Washington state ferry system only
33 in amounts not greater than those sufficient to generate the amount of
34 revenue required by the biennial transportation budget. When adjusting
35 ferry fares, the commission must consider input from affected ferry
36 users by public hearing and by review with the affected ferry advisory

1 committees, in addition to the data gathered from the current ferry
2 user survey.

3 (2) Consistent with RCW 43.135.055 and 47.46.100, during the 2013-
4 2015 fiscal biennium, the legislature authorizes the transportation
5 commission to periodically review and, if necessary, adjust the
6 schedule of toll charges applicable to the Tacoma Narrows bridge only
7 in amounts not greater than those sufficient to support (a) any
8 required costs for operating and maintaining the toll bridge, including
9 the cost of insurance, (b) any amount required by law to meet the
10 redemption of bonds and applicable interest payments, and (c) repayment
11 of the motor vehicle fund.

12 (3)(a) \$400,000 of the motor vehicle account--state appropriation
13 is provided solely for the development of the business case for the
14 transition to a road usage charge system as the basis for funding the
15 state transportation system, from the current motor fuel tax system.
16 The funds are provided for fiscal year 2014 only.

17 (b) The legislature finds that the efforts started in the 2011-2013
18 fiscal biennium regarding the transition to a road usage charge system
19 represent an important first step in the policy and conceptual
20 development of potential alternative systems to fund transportation
21 projects, but that the governance for the development needs
22 clarification. The legislature also finds that significant amounts of
23 research and public education are occurring in similar efforts in
24 several states and that these efforts can and should be leveraged to
25 advance the evaluation in Washington. The legislature intends,
26 therefore, that the commission and its staff lead the policy
27 development of the business case for a road usage charge system, with
28 the goal of providing the business case to the governor and the
29 legislative committees of the legislature in time for inclusion in the
30 2014 supplemental omnibus transportation appropriations act. The
31 legislature intends for additional oversight in the business case
32 development, with guidance from a steering committee as provided in
33 chapter 86, Laws of 2012, augmented with participation by the joint
34 transportation committee. The legislature further intends that the
35 department of transportation continue to address administrative,
36 technical, and conceptual operational issues related to road usage
37 charge systems, and that the department serve as a resource for

1 information gleaned from other states on this topic for the
2 commission's efforts.

3 (c) For the purposes of this subsection (3), the commission shall:

4 (i) Develop preliminary road usage charge policies that are
5 necessary to develop the business case, as well as supporting research
6 and data that will guide the potential application in Washington;

7 (ii) Develop the preferred operational concept or concepts that
8 reflect the preliminary policies;

9 (iii) Evaluate the business case for the road usage charge system
10 that would result from implementing the preliminary policies and
11 preferred operational concept or concepts. The evaluation must assess
12 likely financial outcomes if the system were to be implemented; and

13 (iv) Identify and document policy and other issues that are deemed
14 important to further refine the preferred operational concept or
15 concepts and to gain public acceptance. These identified issues should
16 form the basis for continued work beyond this funding cycle.

17 (d) The commission shall convene a steering committee to guide the
18 development of the business case. The membership must be the same as
19 provided in chapter 86, Laws of 2012, except that the membership must
20 also include the joint transportation committee executive members.

21 (e) The commission shall submit a report of the business case to
22 the governor and the transportation committees of the legislature by
23 December 15, 2013. The report must also include a proposed budget and
24 work plan for fiscal year 2015. A progress report must be submitted to
25 the governor and the joint transportation committee by November 1,
26 2013, including a presentation to the joint transportation committee.

27 (4) \$174,000 of the motor vehicle account--state appropriation is
28 provided solely for the voice of Washington survey program. The
29 funding must be utilized for continued program maintenance and two
30 transportation surveys for the 2013-2015 fiscal biennium.

14 developing this plan, the department must work with the department of
15 health, disabled citizen advocacy groups, and representatives from
16 local government.

17 (b) The work group must be composed of no more than two
18 representatives from each of the entities listed in (a) of this
19 subsection. The work group may, when appropriate, consult with any
20 other public or private entity in order to complete the strategic plan.

21 (c) The strategic plan must include:

22 (i) Oversight measures to ensure that parking placards and special
23 license plates for persons with disabilities are being properly issued,
24 including: (A) The entity responsible for coordinating a randomized
25 review of applications for special parking privileges; (B) a volunteer
26 panel of medical professionals to conduct such reviews; (C) a means to
27 protect the anonymity of both the medical professional conducting a
28 review and the medical professional under review; (D) a means to
29 protect the privacy of applicants by removing any personally
30 identifiable information; and (E) possible sanctions against a medical
31 professional for repeated improper issuances of parking placards or
32 special license plates for persons with disabilities, including those
33 sanctions listed in chapter 18.130 RCW; and

34 (ii) The creation of a publicly accessible system in which the
35 validity of parking placards and special license plates for persons
36 with disabilities may be verified. This system must not allow the
37 public to access any personally identifiable information or protected

4 December 1, 2013.

5 (e) By December 1, 2013, the work group must deliver to the
6 legislature and the appropriate legislative committees the strategic
7 plan required under this subsection, together with its findings,

9 implement the strategic plan.

26 The appropriations in this section are subject to the following

28 (i.e. posts with decay pockets that cause post strength to fall below
29 AASHTO standards) that can be present in a guardrail run without
30 compromising performance; and

31 (viii) Conduct thorough data search or identify case studies, or
32 both, on service life of wood guardrail posts. Durability test results
33 should also be factored in when evaluating service life.

34 (b) The study must be submitted to the office of financial

16 subsection must be put into allotted status by the director of the
17 office of financial management and may be used only for the development
18 of a new supplemental environmental impact statement to redesign the
19 Interstate 5 bridge between Washington and Oregon in accordance with
20 the requirements of the United States coast guard. The department
21 shall not submit the supplemental environmental impact statement to the
22 appropriate federal agencies for approval until July 1, 2014.

23 (b) It is the intent of the legislature that Washington and Oregon
24 have equal funding commitments and equal total expenditures to date on
25 the shared components of the I-5/Columbia River Crossing project. The
26 department shall provide a quarterly report on this project beginning
27 September 30, 2013. The report must include:

28 (i) An update on preliminary engineering and right-of-way
29 acquisition for the previous quarter;

30 (ii) Planned objectives for right-of-way and preliminary
31 engineering for the ensuing quarter;

32 (iii) An updated comparison of the total appropriation authority
33 for the project by state;

34 (iv) An updated comparison of the total expenditures to date on the
35 project by state; and

36 (v) The committed funding provided by the state of Oregon to right-
37 of-way acquisition.

1 (8)(a) \$5,000,000 of the motor vehicle account--federal
2 appropriation and \$200,000 of the motor vehicle account--state
3 appropriation are provided solely for the I-90 Comprehensive Tolling
4 Study and Environmental Review project (100067T). The department shall
5 prepare a detailed environmental impact statement that complies with
6 the national environmental policy act regarding tolling Interstate 90
7 between Interstate 5 and Interstate 405 for the purposes of both
8 managing traffic and providing funding for the construction of the
9 unfunded state route number 520 from Interstate 5 to Medina project.
10 As part of the preparation of the statement, the department must review
11 any impacts to the network of highways and roads surrounding Lake
12 Washington. In developing this statement, the department must provide

21 network of highways and roads surrounding Lake Washington including,
22 but not limited to:

23 (A) Allowing all Washington residents to traverse a portion of the
24 tolled section of Interstate 90 without paying a toll. Residents may
25 choose either (I) the portion of Interstate 90 between the easternmost
26 landing west of Mercer Island and the westernmost landing on Mercer
27 Island, or (II) the portion of Interstate 90 between the westernmost
28 landing east of Mercer Island and the easternmost landing on Mercer
29 Island;

30 (B) Assessing a toll only when a driver traverses, in either
31 direction, the entire portion of Interstate 90 between the easternmost
32 landing west of Mercer Island and the westernmost landing east of
33 Mercer Island; and

34 (C) Allowing affected residents to choose one portion of the tolled
35 section of Interstate 90 upon which they may travel without paying a
36 toll. Residents may choose either (I) the portion of Interstate 90

4 (ii) The department may also consider any alternative mitigation
5 options that conform to the purpose of this subsection (8).

6 (iii) For the purposes of this subsection (8), "affected resident"
7 means anyone who must use a portion of Interstate 90 west of Interstate
8 405 upon which tolling is considered in order to access necessary
9 medical services, such as a hospital.

10 (9) \$541,901,000 of the transportation partnership account--state
11 appropriation, \$144,954,000 of the motor vehicle account--federal
12 appropriation, \$129,779,000 of the motor vehicle account--private/local
13 appropriation, and \$78,004,000 of the transportation 2003 account
14 (nickel account)--state appropriation are provided solely for the SR
15 99/Alaskan Way Viaduct - Replacement project (809936Z).

16 (10) The department shall reconvene an expert review panel of no
17 more than three members as described under RCW 47.01.400 for the
18 purpose of updating the work that was previously completed by the panel
19 on the Alaskan Way viaduct replacement project and to ensure that an
20 appropriate and viable financial plan is created and regularly
21 reviewed. The expert review panel must be selected cooperatively by
22 the chairs of the senate and house of representatives transportation
23 committees, the secretary of transportation, and the governor. The
24 expert review panel must report findings and recommendations to the
25 transportation committees of the legislature, the governor's Alaskan
26 Way viaduct project oversight committee, and the transportation
27 commission annually until the project is operationally complete. This
28 subsection takes effect if chapter ... (Substitute House Bill No.
29 1957), Laws of 2013 is not enacted by June 30, 2013.

30 (11) \$7,408,000 of the transportation partnership account--state
31 appropriation, \$14,594,000 of the transportation 2003 account (nickel
32 account)--state appropriation, \$3,730,000 of the motor vehicle
33 account--state appropriation, \$1,000,000 of the multimodal
34 transportation account--state appropriation, and \$41,395,000 of the
35 motor vehicle account--federal appropriation are provided solely for
36 the US 395/North Spokane Corridor projects (600010A & 600003A). Any
37 future savings on the projects must stay on the US 395/Interstate 90

1 corridor and be made available to the current phase of the North
2 Spokane corridor projects or any future phase of the projects.

3 (12) \$114,369,000 of the transportation partnership account--state
4 appropriation and \$53,755,000 of the transportation 2003 account
5 (nickel account)--state appropriation are provided solely for the I-
6 405/Kirkland Vicinity Stage 2 - Widening project (8BI1002). This
7 project must be completed as soon as practicable as a design-build
8 project. Any future savings on this project or other Interstate 405
9 corridor projects must stay on the Interstate 405 corridor and be made
10 available to either the I-405/SR 167 Interchange - Direct Connector
11 project (140504C) or the I-405 Renton to Bellevue project.

12 (13)(a) The SR 520 Bridge Replacement and HOV project (0BI1003) is
13 supported over time from multiple sources, including a \$300,000,000
14 TIFIA loan, \$819,524,625 in Garvee bonds, toll revenues, state bonds,
15 interest earnings, and other miscellaneous sources.

16 (b) The state route number 520 corridor account--state
17 appropriation includes up to \$668,142,000 in proceeds from the sale of
18 bonds authorized in RCW 47.10.879 and 47.10.886.

19 (c) The state route number 520 corridor account--federal
20 appropriation includes up to \$300,000,000 in proceeds from the sale of
21 bonds authorized in RCW 47.10.879 and 47.10.886.

22 (d) \$153,124,000 of the transportation partnership account--state
23 appropriation, \$300,000,000 of the state route number 520 corridor
24 account--federal appropriation, and \$737,205,000 of the state route
25 number 520 corridor account--state appropriation are provided solely
26 for the SR 520 Bridge Replacement and HOV project (0BI1003). Of the
27 amounts appropriated in this subsection (13)(d), \$105,085,000 of the
28 state route number 520 corridor account--federal appropriation and
29 \$227,415,000 of the state route number 520 corridor account--state
30 appropriation must be put into unallotted status and are subject to
31 review by the office of financial management. The director of the
32 office of financial management shall consult with the joint

23 is provided solely for improvement program support activities
24 (095901X). \$18,000,000 of this amount must be held in unallotted
25 status until the office of financial management certifies that the
26 department's 2014 supplemental budget request conforms to the terms of
27 subsection (20) of this section.

28 (22) The department shall report to the chairs of the senate
29 transportation committee and the house of representatives
30 transportation committee whenever the department is in negotiations to
31 provide a public or private entity mitigation for ten million dollars
32 or more.

33 (23) Any new advisory group that the department convenes during the
34 2013-2015 fiscal biennium must be representative of the interests of
35 the entire state of Washington.

36 (24) \$3,953,000 of the state toxics control account--state
37 appropriation is provided solely for storm water and mitigation site
38 improvements (0B14003).

1 (4) \$27,278,000 of the motor vehicle account--federal appropriation
 2 and \$1,141,000 of the motor vehicle account--state appropriation are
 3 provided solely for the SR 167/Puyallup River Bridge Replacement
 4 project (316725A). This project must be completed as a design-build
 5 project. The department must work with local jurisdictions and the
 6 community during the environmental review process to develop
 7 appropriate esthetic design elements, at no additional cost to the
 8 department, and traffic management plans pertaining to this project.
 9 The department must report to the transportation committees of the
 10 legislature on estimated cost and/or time savings realized as a result
 11 of using the design-build process.

12 (5) The department shall examine the use of electric arc furnace
 13 slag for use as an aggregate for new roads and paving projects in high
 14 traffic areas and report back to the legislature on its current use in
 15 other areas of the country and any characteristics that can provide
 16 greater wear resistance and skid resistance in new pavement
 17 construction.

34 (5) The department may enter into contracts and make expenditures
35 for projects on behalf of and selected by the freight mobility
36 strategic investment board from the amounts provided in section 301 of
37 this act.

1 (6) The department shall submit a report to the transportation
2 committees of the legislature by December 1, 2013, and December 1,
3 2014, on the status of projects funded as part of the pedestrian
4 safety/safe routes to school grant program (OLP600P). The report must
5 include, but is not limited to, a list of projects selected and a brief
6 description of each project's status.

7 (7) \$50,000 of the motor vehicle account--state appropriation is
8 provided solely for the installation of a guard rail on Deer Harbor
9 Road in San Juan county (L2220054).

10 NEW SECTION. **Sec. 312. ANNUAL REPORTING REQUIREMENTS FOR CAPITAL**
11 **PROGRAM**

12 (1) As part of its budget submittal for the 2014 supplemental
13 budget, the department of transportation shall provide an update to the
14 report provided to the legislature in 2013 that: (a) Compares the
15 original project cost estimates approved in the 2003 and 2005 project
16 lists to the completed cost of the project, or the most recent
17 legislatively approved budget and total project costs for projects not
18 yet completed; (b) identifies highway projects that may be reduced in
19 scope and still achieve a functional benefit; (c) identifies highway
20 projects that have experienced scope increases and that can be reduced
21 in scope; (d) identifies highway projects that have lost significant
22 local or regional contributions that were essential to completing the
23 project; and (e) identifies contingency amounts allocated to projects.

24 (2) As part of its budget submittal for the 2014 supplemental
25 budget, the department of transportation shall provide an annual report
26 on the number of toll credits the department has accumulated and how
27 the department has used the toll credits.

28 NEW SECTION. **Sec. 313. QUARTERLY REPORTING REQUIREMENTS FOR**
29 **CAPITAL PROGRAM**

30 On a quarterly basis, the department of transportation shall
31 provide to the office of financial management and the legislative
32 transportation committees the following reports for all capital
33 programs:

34 (1) For active projects, the report must include:

35 (a) A TEIS version containing actual capital expenditures for all

1 projects consistent with the structure of the most recently enacted

3 (b) Anticipated cost savings, cost increases, reappropriations, and

11 guard rail, fish passage barrier removal, roadside safety projects, and
12 seismic bridges. Projects within this programmatic level funding must
13 be completed on a priority basis and scoped to be completed within the
14 current programmatic budget;

15 (e) Highway projects that may be reduced in scope and still achieve
16 a functional benefit;

17 (f) Highway projects that have experienced scope increases and that
18 can be reduced in scope;

19 (g) Highway projects that have lost significant local or regional
20 contributions that were essential to completing the project; and

21 (h) Contingency amounts for all projects consistent with the
22 structure of the most recently enacted budget.

23 (2) For completed projects, the report must:

24 (a) Compare the costs and operationally complete date for projects
25 with budgets of twenty million dollars or more that are funded with
26 preexisting funds to the original project cost estimates and schedule;
27 and

28 (b) Provide a list of nickel and TPA projects charging to the
29 nickel/TPA environmental mitigation reserve (OBI4ENV) and the amount
30 each project is charging.

31 (3) For prospective projects, the report must:

32 (a) Identify the estimated advertisement date for all projects
33 consistent with the structure of the most recently enacted
34 transportation budget that are going to advertisement during the
35 current fiscal biennium;

36 (b) Identify the anticipated operationally complete date for all
37 projects consistent with the structure of the most recently enacted

1 transportation budget that are going to advertisement during the
2 current fiscal biennium; and

3 (c) Identify the estimated cost of completion for all projects
4 consistent with the structure of the most recently enacted
5 transportation budget that are going to advertisement during the
6 current fiscal biennium.

7 (4) The department shall provide a list of change orders executed
8 for each fiscal quarter beginning September 30, 2013. The report must
9 include the name of the contractor, the dollar value of the change
10 order, and a brief explanation for why there needs to be a change
11 order.

12 (5) The department shall provide a quarterly report, beginning
13 September 30, 2013, on project mitigation costs. The report must show:

14 (a) All mitigation payments made during the current fiscal
15 biennium;

16 (b) The party with whom the mitigation was negotiated; and

17 (c) The parties with whom the department are in on-going
18 negotiations.

19 NEW SECTION. **Sec. 314. FEDERAL FUNDS RECEIVED FOR CAPITAL**
20 **PROJECT EXPENDITURES**

21 To the greatest extent practicable, the department of
22 transportation shall expend federal funds received for capital project
23 expenditures before state funds.

10 employees in the bargaining unit and shall represent all such employees
11 fairly.

12 (2) A ferry employee organization or organizations and the governor
13 may each designate any individual as its representative to engage in
14 collective bargaining negotiations.

15 (3) Negotiating sessions, including strategy meetings of the
16 employer or employee organizations, mediation, and the deliberative
17 process of arbitrators are exempt from the provisions of chapter 42.30
18 RCW. Hearings conducted by arbitrators may be open to the public by
19 mutual consent of the parties.

20 (4) Terms of any collective bargaining agreement may be enforced by
21 civil action in Thurston county superior court upon the initiative of
22 either party.

23 (5) Ferry system employees or any employee organization shall not
24 negotiate or attempt to negotiate directly with anyone other than the
25 person who has been appointed or authorized a bargaining representative
26 for the purpose of bargaining with the ferry employees or their
27 representative.

28 (6)(a) Within ten working days after the first Monday in September
29 of every odd-numbered year, the parties shall attempt to agree on an
30 interest arbitrator to be used if the parties are not successful in
31 negotiating a comprehensive collective bargaining agreement. If the
32 parties cannot agree on an arbitrator within the ten-day period, either
33 party may request a list of seven arbitrators from the federal
34 mediation and conciliation service. The parties shall select an
35 interest arbitrator using the coin toss/alternate strike method within
36 thirty calendar days of receipt of the list. Immediately upon
37 selecting an interest arbitrator, the parties shall cooperate to

1 reserve dates with the arbitrator for potential arbitration between
2 August 1st and September 15th of the following even-numbered year. The
3 parties shall also prepare a schedule of at least five negotiation
4 dates for the following year, absent an agreement to the contrary. The
5 parties shall execute a written agreement before November 1st of each
6 odd-numbered year setting forth the name of the arbitrator and the
7 dates reserved for bargaining and arbitration. This subsection (6)(a)
8 imposes minimum obligations only and is not intended to define or limit
9 a party's full, good faith bargaining obligation under other sections
10 of this chapter.

11 (b) The negotiation of a proposed collective bargaining agreement
12 by representatives of the employer and a ferry employee organization
13 shall commence on or about February 1st of every even-numbered year.

14 (c) For negotiations covering the 2009-2011 biennium and subsequent
15 biennia, the time periods specified in this section, and in RCW
16 47.64.210 and 47.64.300 through 47.64.320, must ensure conclusion of
17 all agreements on or before October 1st of the even-numbered year next
18 preceding the biennial budget period during which the agreement should
19 take effect. These time periods may only be altered by mutual
20 agreement of the parties in writing. Any such agreement and any
21 impasse procedures agreed to by the parties under RCW 47.64.200 must
22 include an agreement regarding the new time periods that will allow
23 final resolution by negotiations or arbitration by October 1st of each
24 even-numbered year.

25 (7) It is the intent of this section that the collective bargaining
26 agreement or arbitrator's award shall commence on July 1st of each odd-
27 numbered year and shall terminate on June 30th of the next odd-numbered
28 year to coincide with the ensuing biennial budget year, as defined by
29 RCW 43.88.020(7), to the extent practical. It is further the intent of
30 this section that all collective bargaining agreements be concluded by
31 October 1st of the even-numbered year before the commencement of the
32 biennial budget year during which the agreements are to be in effect.
33 After the expiration date of a collective bargaining agreement
34 negotiated under this chapter, except to the extent provided in
35 subsection (11) of this section and RCW 47.64.270(4), all of the terms
36 and conditions specified in the collective bargaining agreement remain
37 in effect until the effective date of a subsequently negotiated

1 agreement, not to exceed one year from the expiration date stated in
2 the agreement. Thereafter, the employer may unilaterally implement
3 according to law.

4 (8) The office of financial management shall conduct a salary
5 survey, for use in collective bargaining and arbitration, which must be
6 conducted through a contract with a firm nationally recognized in the
7 field of human resources management consulting.

8 (9) Except as provided in subsection (11) of this section:

9 (a) The governor shall submit a request either for funds necessary
10 to implement the collective bargaining agreements including, but not
11 limited to, the compensation and fringe benefit provisions or for
12 legislation necessary to implement the agreement, or both. Requests
13 for funds necessary to implement the collective bargaining agreements
14 shall not be submitted to the legislature by the governor unless such
15 requests:

16 (i) Have been submitted to the director of the office of financial
17 management by October 1st before the legislative session at which the
18 requests are to be considered; and

19 (ii) Have been certified by the director of the office of financial
20 management as being feasible financially for the state.

21 (b) The governor shall submit a request either for funds necessary
22 to implement the arbitration awards or for legislation necessary to
23 implement the arbitration awards, or both. Requests for funds
24 necessary to implement the arbitration awards shall not be submitted to
25 the legislature by the governor unless such requests:

26 (i) Have been submitted to the director of the office of financial
27 management by October 1st before the legislative session at which the
28 requests are to be considered; and

29 (ii) Have been certified by the director of the office of financial
30 management as being feasible financially for the state.

31 (c) The legislature shall approve or reject the submission of the
32 request for funds necessary to implement the collective bargaining
33 agreements or arbitration awards as a whole for each agreement or
34 award. The legislature shall not consider a request for funds to
35 implement a collective bargaining agreement or arbitration award unless
36 the request is transmitted to the legislature as part of the governor's
37 budget document submitted under RCW 43.88.030 and 43.88.060. If the
38 legislature rejects or fails to act on the submission, either party may

1 reopen all or part of the agreement and award or the exclusive
2 bargaining representative may seek to implement the procedures provided
3 for in RCW 47.64.210 and 47.64.300.

4 (10) If, after the compensation and fringe benefit provisions of an
5 agreement are approved by the legislature, a significant revenue
6 shortfall occurs resulting in reduced appropriations, as declared by
7 proclamation of the governor or by resolution of the legislature, both
8 parties shall immediately enter into collective bargaining for a
9 mutually agreed upon modification of the agreement.

10 (11)(a) For the collective bargaining agreements negotiated for the
11 2011-2013 fiscal biennium, the legislature may consider a request for
12 funds to implement a collective bargaining agreement even if the
13 request for funds was not received by the office of financial
14 management by October 1st and was not transmitted to the legislature as
15 part of the governor's budget document submitted under RCW 43.88.030
16 and 43.88.060.

17 (b) For the ~~((2011-2013))~~ 2013-2015 fiscal biennium, a collective
18 bargaining agreement related to employee health care benefits
19 negotiated between the employer and coalition pursuant to RCW
20 41.80.020(3) regarding the dollar amount expended on behalf of each
21 employee must be a separate agreement for which the governor may
22 request funds necessary to implement the agreement. ~~((If such an
23 agreement is negotiated and funded by the legislature, this agreement
24 will supersede any terms and conditions of an expired 2009-2011
25 biennial master collective bargaining agreement under this chapter
26 regarding health care benefits.))~~ The legislature may act upon a 2013-
27 2015 collective bargaining agreement related to employee health care
28 benefits if an agreement is reached and submitted to the office of
29 financial management and legislative budget committees before final
30 legislative action on the biennial or supplemental operating budget by
31 the sitting legislature.

32 (c) For the collective bargaining agreements negotiated for the
33 2013-2015 fiscal biennium, the legislature may consider a request for
34 funds to implement a collective bargaining agreement reached after
35 October 1st after a determination of financial infeasibility by the
36 director of the office of financial management if the request for funds
37 is transmitted to the legislature as part of the governor's budget
38 document submitted under RCW 43.88.030 and 43.88.060.

1 (2) To this end, the department of transportation is directed to
2 reduce the size of its engineering and technical workforce to a level
3 sustained by current law revenue levels currently estimated at two
4 thousand FTEs by the end of the 2013-2015 fiscal biennium. The
5 department shall submit a report on the progress made in 2011-2013 by
6 July 1, 2013.

7 (3) In order to successfully deliver the highway construction
8 program as funded, the department of transportation may continue to
9 contract out engineering and technical services. In addition, the
10 department may continue the incentive program for retirements and
11 employee separations.

12 NEW SECTION. **Sec. 602. FOR THE DEPARTMENT OF TRANSPORTATION**

13 The department shall begin to transition from owning a fleet of
14 passenger vehicles in Thurston county to using the state motor pool.
15 The funding appropriated in this act may not be used by programs
16 headquartered in Thurston county to purchase passenger cars as defined
17 in RCW 46.04.382.

18 NEW SECTION. **Sec. 603. FUND TRANSFERS**

19 (1) The transportation 2003 projects or improvements and the 2005
20 transportation partnership projects or improvements are listed in the
21 LEAP list titled 2013-1 as developed April 23, 2013, which consists of
22 a list of specific projects by fund source and amount over a ten-year
23 period. Current fiscal biennium funding for each project is a line-
24 item appropriation, while the outer year funding allocations represent
25 a ten-year plan. The department is expected to use the flexibility
26 provided in this section to assist in the delivery and completion of
27 all transportation partnership account and transportation 2003 account
28 (nickel account) projects on the LEAP transportation documents
29 referenced in this act. However, this section does not apply to the I-
30 5/Columbia River Crossing project (400506A). For the 2011-2013 and
31 2013-2015 project appropriations, unless otherwise provided in this
32 act, the director of financial management may authorize a transfer of
33 appropriation authority between projects funded with transportation
34 2003 account (nickel account) appropriations, or transportation
35 partnership account appropriations, in order to manage project spending

1 and efficiently deliver all projects in the respective program under
2 the following conditions and limitations:

3 (a) Transfers may only be made within each specific fund source
4 referenced on the respective project list;

5 (b) Transfers from a project may not be made as a result of the
6 reduction of the scope of a project or be made to support increases in
7 the scope of a project;

8 (c) Each transfer between projects may only occur if the director
9 of financial management finds that any resulting change will not hinder
10 the completion of the projects as approved by the legislature. Until
11 the legislature reconvenes to consider the 2014 supplemental omnibus
12 transportation appropriations act, any unexpended 2011-2013
13 appropriation balance as approved by the office of financial
14 management, in consultation with the legislative staff of the house of
15 representatives and senate transportation committees, may be considered
16 when transferring funds between projects;

17 (d) Transfers from a project may be made if the funds appropriated
18 to the project are in excess of the amount needed to complete the
19 project;

20 (e) Transfers may not occur for projects not identified on the
21 applicable project list;

22 (f) Transfers may not be made while the legislature is in session;
23 and

24 (g) Transfers between projects may be made, without the approval of
25 the director of the office of financial management, by the department
26 of transportation until the transfer amount by project exceeds two
27 hundred fifty thousand dollars, or ten percent of the total project,
28 whichever is less. These transfers must be reported quarterly to the
29 director of financial management and the chairs of the house of
30 representatives and senate transportation committees.

31 (2) At the time the department submits a request to transfer funds
32 under this section, a copy of the request must be submitted to the
33 transportation committees of the legislature.

34 (3) The office of financial management shall work with legislative
35 staff of the house of representatives and senate transportation
36 committees to review the requested transfers in a timely manner.

37 (4) The office of financial management shall document approved
38 transfers and schedule changes in the transportation executive

1 information system, compare changes to the legislative baseline funding
2 and schedules identified by project identification number identified in
3 the LEAP transportation documents referenced in this act, and transmit
4 revised project lists to chairs of the transportation committees of the
5 legislature on a quarterly basis.

6 NEW SECTION. **Sec. 604. ACQUISITION OF PROPERTIES AND FACILITIES**
7 **THROUGH FINANCIAL CONTRACTS**

8 (1) The agency in subsection (2) of this section may enter into
9 financial contracts, paid from any funds of an agency, appropriated or
10 nonappropriated, for the purposes indicated and in not more than the
11 principal amounts indicated, plus financing expenses and required
12 reserves pursuant to chapter 39.94 RCW. When securing properties under
13 this section, agencies shall use the most economical financial contract
14 option available, including long-term leases, lease-purchase
15 agreements, lease-development with option to purchase agreements, or
16 financial contracts using certificates of participation. Expenditures
17 made by an agency for one of the indicated purposes before the issue
18 date of the authorized financial contract and any certificates of
19 participation therein are intended to be reimbursed from proceeds of
20 the financial contract and any certificates of participation therein to
21 the extent provided in the agency's financing plan approved by the
22 state finance committee.

23 (2) The Washington state patrol may enter into agreements with the
24 department of enterprise services and the state treasurer's office to
25 develop requests to the legislature for the acquisition of properties
26 and facilities through financial contracts. The agreements may include
27 charges for services rendered. The Washington state patrol may enter
28 into a financing contract for up to \$4,680,000 plus financing expenses
29 and required reserves pursuant to chapter 39.94 RCW to purchase and
30 install mobile office platforms in state patrol and pursuit vehicles.

31 NEW SECTION. **Sec. 605. FOR THE DEPARTMENT OF TRANSPORTATION**

32 (1) The department of transportation shall prepare an updated
33 facilities and property plan to improve the oversight of real estate
34 procurement and property management across all department programs and
35 regions, including the Washington state ferries. The plan must be

1 submitted to the office of financial management and the transportation
2 committees of the legislature by December 31, 2013. The plan must
3 include:

4 (a) An inventory of all currently owned and leased buildings,
5 including tunnel and bridge operation or maintenance facilities, and
6 traffic management centers as provided by the state's facilities
7 inventory process prescribed by the office of financial management
8 annually by September 1st;

9 (b) A land inventory, as of July 2013, including an indication of
10 whether the land is being held for right-of-way, disposition, or future
11 operational facilities;

12 (c) A prioritized list of all facilities that are planned to be
13 constructed, renovated, or remodeled in the next ten years, including
14 each facilities' purpose and use, and the funding source indicating
15 whether the funding that is assumed for the facility improvements is
16 project or operational funding;

17 (d) A list of options for consolidating staff, equipment, and
18 operational activities to reduce costs with an emphasis on
19 consolidating facilities from leased facilities into state-owned
20 facilities. New locations for a permanent state program or activity,
21 unless a life-cycle cost analysis supports leasing in lieu of ownership
22 or funds are not available for construction, should be state-owned
23 facilities;

24 (e) A department-wide coordinated process and plan for regularly
25 evaluating facility needs, which includes all facilities in the
26 inventory under (a) of this subsection; and

27 (f) A list of department-owned property that can be declared
28 surplus property.

29 (2) Except as provided otherwise in this act, the department of
30 transportation may not enter into new leases, equal value exchanges, or
31 property transactions, including land acquisitions, except for right-
32 of-way purchases for projects on the legislative project lists, without
33 first consulting with the office of financial management.

34 **NEW SECTION. Sec. 606. FOR THE DEPARTMENT OF TRANSPORTATION**

35 As part of its 2014 supplemental budget submittal, the department
36 shall provide a report to the legislature and the office of financial
37 management that:

1 (1) Identifies, by capital project, the amount of state funding
2 that has been reappropriated from the 2011-2013 fiscal biennium into
3 the 2013-2015 fiscal biennium; and

4 (2) Identifies, for each project, the amount of cost savings or
5 increases in funding that have been identified as compared to the 2013
6 enacted omnibus transportation appropriations act.

7 NEW SECTION. **Sec. 607. FOR THE DEPARTMENT OF TRANSPORTATION**

8 The department of transportation, in conjunction with the office of
9 minority and women's business enterprises, shall review the city of
10 Seattle's minority and women's business enterprise inclusion plans that
11 the city has implemented. The review should include a comparison
12 between the existing state process and the city of Seattle inclusion
13 process for bidding construction projects. As part of the review, any
14 identified advantages or disadvantages along with any realized benefits
15 that the city of Seattle has experienced should be included in a report
16 that is due to the transportation committees of the legislature by
17 December 1, 2013.

18 NEW SECTION. **Sec. 608. VOLUNTARY RETIREMENT AND SEPARATION**
19 **INCENTIVES**

20 As a management tool to reduce costs and make more effective use of
21 resources, while improving employee productivity and morale, agencies
22 may implement a voluntary retirement and/or separation program that is
23 cost neutral or results in cost savings, including costs to the state
24 pension systems, over a two-year period following the commencement of
25 the program, provided that the program is approved by the director of
26 financial management. Agencies participating in this authorization may
27 offer voluntary retirement and/or separation incentives and options
28 according to procedures and guidelines established by the office of
29 financial management, in consultation with the office of the state
30 human resources director and the department of retirement systems. The
31 options may include, but are not limited to, financial incentives for
32 voluntary separation or retirement. An employee does not have any
33 contractual right to a financial incentive offered pursuant to this
34 section. Offers must be reviewed and monitored jointly by the office
35 of the state human resources director and the department of retirement
36 systems. Agencies must submit a report by June 30, 2015, to the

1 legislature and the office of financial management on the outcome of
2 their approved incentive program. The report should include
3 information on the details of the program, including the incentive
4 payment amount for each participant, the total cost to the state, and
5 the projected or actual net dollar savings over the two-year period.

6 The department of retirement systems may collect from employers the
7 actuarial cost of any incentive provided under this program, or any
8 other incentive to retire provided by employers to members of the
9 state's pension systems, for deposit in the appropriate pension
10 account.

11 NEW SECTION. **Sec. 609. COMPENSATION--REVISE PENSION CONTRIBUTION**
12 **RATES**

13 The appropriations for school districts and state agencies,
14 including institutions of higher education, are subject to the
15 following conditions and limitations: Appropriations are adjusted to
16 reflect changes to agency appropriations to reflect pension
17 contribution rates adopted by the pension funding council and the law
18 enforcement officers' and firefighters' retirement system plan 2 board.

19 NEW SECTION. **Sec. 610. FOR THE DEPARTMENT OF TRANSPORTATION**

20 The department of transportation may provide up to \$3,000,000 in
21 toll credits to Kitsap Transit for its role in passenger-only ferry
22 service and ferry corridor-related projects. The number of toll
23 credits provided must be equal to, but no more than, the number
24 sufficient to meet federal match requirements for grant funding for
25 passenger-only ferry service, but must not exceed the amount authorized
26 in this section.

27 NEW SECTION. **Sec. 611.** To the extent that any appropriation
28 authorizes expenditures of state funds from the motor vehicle account,
29 special category C account, Tacoma Narrows toll bridge account,
30 transportation 2003 account (nickel account), transportation
31 partnership account, transportation improvement account, Puget Sound
32 capital construction account, multimodal transportation account, state
33 route number 520 corridor account, or other transportation capital
34 project account in the state treasury for a state transportation
35 program that is specified to be funded with proceeds from the sale of

1 bonds authorized in chapter 47.10 RCW, the legislature declares that
2 any such expenditures made prior to the issue date of the applicable
3 transportation bonds for that state transportation program are intended
4 to be reimbursed from proceeds of those transportation bonds in a
5 maximum amount equal to the amount of such appropriation.

6 NEW SECTION. **Sec. 612. WEB SITE REPORTING REQUIREMENTS FOR THE**
7 **DEPARTMENT OF TRANSPORTATION**

8 (1) The department of transportation shall post on its web site
9 every report that is due from the department to the legislature during
10 the 2013-2015 fiscal biennium on one web page. The department must
11 post both completed reports and planned reports on a single web page.

12 (2) The department shall provide a web link for each change order
13 that is more than five hundred thousand dollars on the affected project
14 web page.

15 **MISCELLANEOUS 2013-2015 FISCAL BIENNIUM**

16 **Sec. 701.** RCW 43.19.642 and 2012 c 86 s 802 are each amended to
17 read as follows:

18 (1) Effective June 1, 2006, for agencies complying with the ultra-
19 low sulfur diesel mandate of the United States environmental protection
20 agency for on-highway diesel fuel, agencies shall use biodiesel as an
21 additive to ultra-low sulfur diesel for lubricity, provided that the
22 use of a lubricity additive is warranted and that the use of biodiesel
23 is comparable in performance and cost with other available lubricity
24 additives. The amount of biodiesel added to the ultra-low sulfur
25 diesel fuel shall be not less than two percent.

26 (2) Except as provided in subsection (5) of this section, effective
27 June 1, 2009, state agencies are required to use a minimum of twenty
28 percent biodiesel as compared to total volume of all diesel purchases
29 made by the agencies for the operation of the agencies' diesel-powered
30 vessels, vehicles, and construction equipment.

31 (3) All state agencies using biodiesel fuel shall, beginning on
32 July 1, 2006, file biannual reports with the department of enterprise
33 services documenting the use of the fuel and a description of how any
34 problems encountered were resolved.

1 (4) By December 1, 2009, the department of enterprise services
2 shall:

3 (a) Report to the legislature on the average true price
4 differential for biodiesel by blend and location; and

5 (b) Examine alternative fuel procurement methods that work to
6 address potential market barriers for in-state biodiesel producers and
7 report these findings to the legislature.

8 (5) During the 2011-2013 and 2013-2015 fiscal (~~(biennium)~~) biennia,
9 the Washington state ferries is required to use a minimum of five
10 percent biodiesel as compared to total volume of all diesel
11 (~~(purchased)~~) purchases made by the Washington state ferries for the
12 operation of the Washington state ferries diesel-powered vessels, as
13 long as the price of a B5 biodiesel blend does not exceed the price of
14 conventional diesel fuel by five percent or more.

15 **Sec. 702.** RCW 46.12.630 and 2012 c 86 s 803 are each amended to
16 read as follows:

17 In addition to any other authority which it may have, the
18 department of licensing may furnish lists of registered and legal
19 owners of motor vehicles only for the purposes specified in this
20 section to:

21 (1)(a) The manufacturers of motor vehicles, or their authorized
22 agents, to be used:

23 (~~((+a))~~) (i) To enable those manufacturers to carry out the
24 provisions of the national traffic and motor vehicle safety act of 1966
25 (15 U.S.C. Sec. 1382-1418), including amendments or additions thereto,
26 respecting safety-related defects in motor vehicles; or

27 (~~((+b))~~) (ii) During the 2011-2013 fiscal biennium, in research
28 activities, and in producing statistical reports, as long as the
29 personal information is not published, redisclosed, or used to contact
30 individuals; or

31 (b) During fiscal year 2014, an entity that is an authorized agent
32 of a motor vehicle manufacturer, for purposes of using lists of
33 registered and legal owner information to conduct research activities
34 and produce statistical reports, as long as the entity does not allow
35 personal information received under this section to be published,
36 redisclosed, or used to contact individuals. The department must
37 charge an amount sufficient to cover the full cost of providing the

1 data requested under this subsection (1)(b). Full cost of providing
2 the data includes the information technology, administrative, and
3 contract oversight costs;

4 (2) Any governmental agency of the United States or Canada, or
5 political subdivisions thereof, to be used by it or by its authorized
6 commercial agents or contractors only in connection with the
7 enforcement of motor vehicle or traffic laws by, or programs related to
8 traffic safety of, that government agency. Only such parts of the list
9 as are required for completion of the work required of the agent or
10 contractor shall be provided to such agent or contractor;

11 (3) A commercial parking company requiring the names and addresses
12 of registered owners to notify them of outstanding parking violations.
13 Subject to the disclosure agreement provisions of RCW 46.12.635 and the
14 requirements of Executive Order 97-01, the department may provide only
15 the parts of the list that are required for completion of the work
16 required of the company;

17 (4) An authorized agent or contractor of the department, to be used
18 only in connection with providing motor vehicle excise tax, licensing,
19 title, and registration information to motor vehicle dealers;

20 (5) Any business regularly making loans to other persons to finance
21 the purchase of motor vehicles, to be used to assist the person
22 requesting the list to determine ownership of specific vehicles for the
23 purpose of determining whether or not to provide such financing; or

24 (6) A company or its agents operating a toll facility under chapter
25 47.46 RCW or other applicable authority requiring the names, addresses,
26 and vehicle information of motor vehicle registered owners to identify
27 toll violators.

28 Where both a mailing address and residence address are recorded on
29 the vehicle record and are different, only the mailing address will be
30 disclosed. Both addresses will be disclosed in response to requests
31 for disclosure from courts, law enforcement agencies, or government
32 entities with enforcement, investigative, or taxing authority and only
33 for use in the normal course of conducting their business.

34 If a list of registered and legal owners of motor vehicles is used
35 for any purpose other than that authorized in this section, the
36 manufacturer, governmental agency, commercial parking company,
37 authorized agent, contractor, financial institution, toll facility

1 operator, or their authorized agents or contractors responsible for the
2 unauthorized disclosure or use will be denied further access to such
3 information by the department of licensing.

4 **Sec. 703.** RCW 46.18.060 and 2012 c 65 s 6 are each amended to read
5 as follows:

6 (1) The department must review and either approve or reject special
7 license plate applications submitted by sponsoring organizations.

8 (2) Duties of the department include, but are not limited to, the
9 following:

10 (a) Review and approve the annual financial reports submitted by
11 sponsoring organizations with active special license plate series and
12 present those annual financial reports to the joint transportation
13 committee;

14 (b) Report annually to the joint transportation committee on the
15 special license plate applications that were considered by the
16 department;

17 (c) Issue approval and rejection notification letters to sponsoring

4 and takes effect July 1, 2013.

5 NEW SECTION. **Sec. 1404.** Section 709 of this act is necessary for
6 the immediate preservation of the public peace, health, or safety, or
7 support of the state government and its existing public institutions,
8 and takes effect June 30, 2013, unless chapter . . . (Substitute House
9 Bill No. 1745), Laws of 2013 is enacted on or before June 30, 2013, in
10 which case section 709 of this act does not take effect.
