Where feasible, grant application content prepared by the commission must reflect the direction provided by the road usage charge steering committee on the preferred road usage charge pilot project approach. One or more grant applications may be developed as part of the road usage charge pilot project implementation plan development work, but the pilot project implementation plan must nevertheless include any details necessary for a full launch of the pilot project not required to be included in any grant application.
- (b) The commission shall reconvene the road usage charge steering committee, with the same membership authorized in chapter 222, Laws of 2014, as well as the addition of a representative from the Puget Sound regional council, and, upon finalization of the federal grant award for stage 1 of the road usage charge pilot project, shall report at least once every three months to the steering committee with updates on project progress, key project milestones, and developments related to securing additional federal funding for future road usage charge pilot work. Each report must include a phone or in-person meeting with the steering committee, with a maximum of two in-person meetings to be held in 2017. If the year-end report is not the final report for stage 1 of the pilot project, a final report that includes an evaluation of stage 1 of the pilot project must be provided to the governor's office and the transportation committees of the house of representatives and the senate following completion of stage 1 of the pilot project. - (d) Transfers may not occur for projects not identified on the 19 20 applicable project list;
- 21 (e) Transfers may not be made while the legislature is session; 22
- (f) Transfers to a project may not be made with funds designated 23 24 as attributable to practical design savings as described in RCW 25 47.01.480;
  - (g) Each transfer between projects may only occur if the director of the office of financial management finds that any resulting change will not hinder the completion of the projects as approved by the legislature. Until the legislature reconvenes to consider the 2018 supplemental omnibus transportation appropriations act, unexpended 2015-2017 appropriation balance as approved by the office of financial management, in consultation with the legislative staff of the house of representatives and senate transportation committees, may be considered when transferring funds between projects; and
  - (h) Transfers between projects may be made by the department of transportation without the formal written approval provided under this subsection (1), provided that the transfer amount does not exceed two hundred fifty thousand dollars or ten percent of the total project, whichever is less. These transfers must be quarterly to the director of the office of financial management and 95

- the chairs of the house of representatives and senate transportation committees.
  - (2) The department of transportation must submit quarterly all transfers authorized under this section in the transportation executive information system. The office of financial management must maintain a legislative baseline project list identified in the LEAP transportation documents referenced in this act, and update that project list with all authorized transfers under this section.
- 9 (3) At the time the department submits a request to transfer 10 funds under this section, a copy of the request must be submitted to 11 the transportation committees of the legislature.
- 12 (4) Before approval, the office of financial management shall 13 work with legislative staff of the house of representatives and 14 senate transportation committees to review the requested transfers in 15 a timely manner.
  - (5) No fewer than ten days after the receipt of a project transfer request, the director of the office of financial management must provide written notification to the department of any decision regarding project transfers, with copies submitted to the transportation committees of the legislature.

The report must address each modal category 31 separately and identify if eighteenth amendment protected funds have 32 been used and, if not, the source of funding. 33
- 34 (2) To facilitate the report in subsection (1) of this section, 35 the department of transportation must require that all bids on 36 connecting Washington projects include an estimate on the cost to 37 implement any transit, bicycle, or pedestrian project elements.

NEW SECTION. Sec. 701. A new section is added to 2017 c 313 (uncodified) to read as follows:

# ACQUISITION OF PROPERTIES AND FACILITIES THROUGH FINANCIAL CONTRACTS

- (1) The department of transportation is authorized, subject to the conditions in section 305(3) of this act, to enter into a financing contract pursuant to chapter 39.94 RCW through the state treasurer's lease-purchase program for the purposes indicated. The department may use any funds, appropriated or nonappropriated, in not more than the principal amounts indicated, plus financing expenses and required reserves, if any. Expenditures made by the department of transportation for the indicated purposes before the issue date of the authorized financing contract and any certificates of participation therein may be reimbursed from proceeds of the financing contract and any certificates of participation therein to the extent provided in the agency's financing plan approved by the state finance committee.
- 17 (2) Department of transportation: Enter into a financing contract 18 for up to \$32,500,000 plus financing expenses and required reserves 19 pursuant to chapter 39.94 RCW to renovate the existing office 20 building at 15700 Dayton Ave N, Shoreline.
- NEW SECTION. Sec. 702. 2017 c 288 s 5 (uncodified) is repealed.
- 22 MISCELLANEOUS
- NEW SECTION. Sec. 801. If any provision of this act or its application to any person or circumstance is held invalid, the remainder of the act or the application of the provision to other persons or circumstances is not affected.
- NEW SECTION. Sec. 802. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and takes effect immediately.
