6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. **Sec. 1.** The legislature finds that the purpose of
8 the transportation system is to support the mobility needs of
9 Washington residents, as well as to sustain and foster the economic
10 activity and growth of the state. The legislature recognizes that the
11 transportation system has pressing near, mid, and long-term needs
12 that necessitate reliance on reliable funding resources, as well as
13 the efficient use of those resources. The legislature further
14 recognizes that the production, maintenance, and utilization of
15 transportation resources across the state is inherently a complex,
16 multifaceted issue. The legislature therefore intends to address
17 these resources needs in a comprehensive manner. As such, the
18 legislature's purpose in enacting this legislation is to address the
19 complex production, maintenance, and utilization of transportation
20 resources in Washington to achieve both short-term investment needs
21 and provide a long-range vision for transportation system
22 development.

23 **PART I: MOTOR VEHICLE FUEL TAX**

24 **Sec. 101.** RCW 82.38.030 and 2015 3rd sp.s. c 44 s 103 are each
25 amended to read as follows:

26 (1) There is levied and imposed upon fuel licensees a tax at the
27 rate of (~~twenty-three~~) 23 cents per gallon of fuel.

28 (2) Beginning July 1, 2003, an additional and cumulative tax rate
29 of five cents per gallon of fuel is imposed on fuel licensees. This
30 subsection (2) expires when the bonds issued for transportation 2003
31 projects are retired.

32 (3) Beginning July 1, 2005, an additional and cumulative tax rate
33 of three cents per gallon of fuel is imposed on fuel licensees.

34 (4) Beginning July 1, 2006, an additional and cumulative tax rate
35 of three cents per gallon of fuel is imposed on fuel licensees.

1 (5) Beginning July 1, 2007, an additional and cumulative tax rate
2 of two cents per gallon of fuel is imposed on fuel licensees.

3 (6) Beginning July 1, 2008, an additional and cumulative tax rate
4 of one and one-half cents per gallon of fuel is imposed on fuel
5 licensees.

6 (7) Beginning August 1, 2015, an additional and cumulative tax
7 rate of seven cents per gallon of fuel is imposed on fuel licensees.

8 (8) Beginning July 1, 2016, an additional and cumulative tax rate
9 of four and nine-tenths cents per gallon of fuel is imposed on fuel
10 licensees.

11 (9) Beginning July 1, 2025, an additional and cumulative tax rate
12 of six cents per gallon of fuel is imposed on fuel licensees.

13 (10) Beginning July 1, 2025, an additional and cumulative tax
14 rate of three cents per gallon of special fuel is imposed on fuel
15 licensees.

16 (11) Beginning July 1, 2027, an additional and cumulative tax
17 rate of three cents per gallon of special fuel is imposed on fuel
18 licensees.

19 (12)(a) Beginning July 1, 2026, the fuel tax rates imposed under
20 subsections (1) through (9) of this section must be increased
21 annually by two percent and the resulting fuel tax rate must be
22 rounded to the nearest one-thousandth of \$1.

23 (b) Beginning July 1, 2028, the fuel tax rate imposed under
24 subsections (10) and (11) of this section must be increased annually
25 by two percent and the resulting fuel tax rate must be rounded to the
26 nearest one-thousandth of \$1.

27 (13) Taxes are imposed when:

28 (a) Fuel is removed in this state from a terminal if the fuel is
29 removed at the rack unless the removal is by a licensed supplier or
30 distributor for direct delivery to a destination outside of the
31 state, or the removal is by a fuel supplier for direct delivery to an
32 international fuel tax agreement licensee under RCW 82.38.320;

33 (b) Fuel is removed in this state from a refinery if either of
34 the following applies:

35 (i) The removal is by bulk transfer and the refiner or the owner
36 of the fuel immediately before the removal is not a licensed
37 supplier; or

38 (ii) The removal is at the refinery rack unless the removal is to
39 a licensed supplier or distributor for direct delivery to a
40 destination outside of the state, or the removal is to a licensed

1 supplier for direct delivery to an international fuel tax agreement
2 licensee under RCW 82.38.320;

3 (c) Fuel enters into this state for sale, consumption, use, or
4 storage, unless the fuel enters this state for direct delivery to an
5 international fuel tax agreement licensee under RCW 82.38.320, if
6 either of the following applies:

7 (i) The entry is by bulk transfer and the importer is not a
8 licensed supplier; or

9 (ii) The entry is not by bulk transfer;

10 (d) Fuel enters this state by means outside the bulk transfer-
11 terminal system and is delivered directly to a licensed terminal
12 unless the owner is a licensed distributor or supplier;

13 (e) Fuel is sold or removed in this state to an unlicensed entity
14 unless there was a prior taxable removal, entry, or sale of the fuel;

15 (f) Blended fuel is removed or sold in this state by the blender
16 of the fuel. The number of gallons of blended fuel subject to tax is
17 the difference between the total number of gallons of blended fuel
18 removed or sold and the number of gallons of previously taxed fuel
19 used to produce the blended fuel;

20 (g) Dyed special fuel is used on a highway, as authorized by the
21 internal revenue code, unless the use is exempt from the fuel tax;

22 (h) Dyed special fuel is held for sale, sold, used, or is
23 intended to be used in violation of this chapter;

24 (i) Special fuel purchased by an international fuel tax agreement
25 licensee under RCW 82.38.320 is used on a highway; and

26 (j) Fuel is sold by a licensed fuel supplier to a fuel
27 distributor or fuel blender and the fuel is not removed from the bulk
28 transfer-terminal system.

29 **Sec. 102.** RCW 82.38.075 and 2014 c 216 s 202 are each amended to
30 read as follows:

31 (1) To encourage the use of nonpolluting fuels, an annual license
32 fee in lieu of the tax imposed by RCW 82.38.030 is imposed upon the
33 use of liquefied natural gas, compressed natural gas, or propane used
34 in any motor vehicle. The annual license fee must be based upon the
35 following schedule and formula:

36	VEHICLE TONNAGE (GVW)	FEE
37	0 - 6,000	\$ 45
38	6,001 - 10,000	\$ 45

1	10,001 - 18,000	\$ 80
2	18,001 - 28,000	\$110
3	28,001 - 36,000	\$150

5 (2) To determine the annual license fee for a registration year,
6 the appropriate dollar amount in the schedule is multiplied by the
7 cumulative fuel tax rate per gallon of special fuel effective on July
8 1st of the preceding calendar year and the product is divided by 12
9 cents. The annual license fee must be rounded to the nearest five
10 cents.

11 (3) The department, in addition to the resulting fee, must charge
12 an additional fee of (~~five dollars~~) \$5 as a handling charge for
13 each license issued.

14 (4) The vehicle tonnage fee must be prorated so the annual
15 license will correspond with the staggered vehicle licensing system.

16 (5) A decal or other identifying device issued upon payment of
17 the annual fee must be displayed as prescribed by the department as
18 authority to purchase this fuel.

19 (6) Persons selling or dispensing natural gas or propane may not
20 sell or dispense this fuel for their own use or the use of others
21 into tanks of vehicles powered by this fuel which do not display a
22 valid decal or other identifying device.

23 (7) Commercial motor vehicles registered in a foreign
24 jurisdiction under the provisions of the international registration
25 plan are subject to the annual fee.

26 (8) Motor vehicles registered in a foreign jurisdiction, except
27 those registered under the international registration plan under
28 chapter 46.87 RCW, are exempt from this section.

29 (9) Vehicles registered in jurisdictions outside the state of
30 Washington are exempt from this section.

31 (10) Any person selling or dispensing liquefied natural gas,
32 compressed natural gas, or propane into the tank of a motor vehicle
33 powered by this fuel, except as prescribed in this chapter, is
34 subject to the penalty provisions of this chapter.

35 **Sec. 103.** RCW 46.68.090 and 2015 3rd sp.s. c 44 s 105 are each
36 amended to read as follows:

1 (1) All moneys that have accrued or may accrue to the motor
2 vehicle fund from the fuel tax must be first expended for purposes
3 enumerated in (a) and (b) of this subsection. The remaining net tax
4 amount must be distributed monthly by the state treasurer in
5 accordance with subsections (2) through (~~(8)~~) (9) of this section.

6 (a) For payment of refunds of fuel tax that has been paid and is
7 refundable as provided by law;

8 (b) For payment of amounts to be expended pursuant to
9 appropriations for the administrative expenses of the offices of
10 state treasurer, state auditor, and the department of licensing of
11 the state of Washington in the administration of the fuel tax, which
12 sums must be distributed monthly.

13 (2) All of the remaining net tax amount collected under RCW
14 82.38.030(1) must be distributed as set forth in (a) through (j) of
15 this subsection.

16 (a) For distribution to the motor vehicle fund an amount equal to
17 44.387 percent to be expended for highway purposes of the state as
18 defined in RCW 46.68.130;

19 (b)(i) For distribution to the special category C account, hereby
20 created in the motor vehicle fund, an amount equal to 3.2609 percent
21 to be expended for special category C projects. Special category C
22 projects are category C projects that, due to high cost only, will
23 require bond financing to complete construction.

24 (ii) The following criteria, listed in order of priority, must be
25 used in determining which special category C projects have the
26 highest priority:

27 (A) Accident experience;

28 (B) Fatal accident experience;

29 (C) Capacity to move people and goods safely and at reasonable
30 speeds without undue congestion; and

31 (D) Continuity of development of the highway transportation
32 network.

33 (iii) Moneys deposited in the special category C account in the
34 motor vehicle fund may be used for payment of debt service on bonds
35 the proceeds of which are used to finance special category C projects
36 under this subsection (2)(b);

37 (c) For distribution to the Puget Sound ferry operations account
38 in the motor vehicle fund an amount equal to 2.3283 percent;

39 (d) For distribution to the Puget Sound capital construction
40 account in the motor vehicle fund an amount equal to 2.3726 percent;

1 (e) For distribution to the transportation improvement account in
2 the motor vehicle fund an amount equal to 7.5597 percent;

3 (f) For distribution to the transportation improvement account in
4 the motor vehicle fund an amount equal to 5.6739 percent and expended
5 in accordance with RCW 47.26.086;

6 (g) For distribution to the cities and towns from the motor
7 vehicle fund an amount equal to 10.6961 percent in accordance with
8 RCW 46.68.110;

9 (h) For distribution to the counties from the motor vehicle fund
10 an amount equal to 19.2287 percent: (i) Out of which there must be
11 distributed from time to time, as directed by the department of
12 transportation, those sums as may be necessary to carry out the
13 provisions of RCW 47.56.725; and (ii) less any amounts appropriated
14 to the county road administration board to implement the provisions
15 of RCW 47.56.725(4), with the balance of such county share to be
16 distributed monthly as the same accrues for distribution in
17 accordance with RCW 46.68.120;

18 (i) For distribution to the county arterial preservation account,
19 hereby created in the motor vehicle fund an amount equal to 1.9565
20 percent. These funds must be distributed by the county road
21 administration board to counties in proportions corresponding to the
22 number of paved arterial lane miles in the unincorporated area of
23 each county and must be used for improvements to sustain the
24 structural, safety, and operational integrity of county arterials.
25 The county road administration board must adopt reasonable rules and
26 develop policies to implement this program and to assure that a
27 pavement management system is used;

28 (j) For distribution to the rural arterial trust account in the
29 motor vehicle fund an amount equal to 2.5363 percent and expended in
30 accordance with RCW 36.79.020.

31 (3) The remaining net tax amount collected under RCW 82.38.030(2)
32 must be distributed to the transportation 2003 account (nickel
33 account).

34 (4) The remaining net tax amount collected under RCW 82.38.030(3)
35 must be distributed as follows:

36 (a) 8.3333 percent must be distributed to the incorporated cities
37 and towns of the state in accordance with RCW 46.68.110;

38 (b) 8.3333 percent must be distributed to counties of the state
39 in accordance with RCW 46.68.120; and

1 (c) The remainder must be distributed to the transportation
2 partnership account created in RCW 46.68.290.

3 (5) The remaining net tax amount collected under RCW 82.38.030(4)
4 must be distributed as follows:

5 (a) 8.3333 percent must be distributed to the incorporated cities
6 and towns of the state in accordance with RCW 46.68.110;

7 (b) 8.3333 percent must be distributed to counties of the state
8 in accordance with RCW 46.68.120; and

9 (c) The remainder must be distributed to the transportation
10 partnership account created in RCW 46.68.290.

11 (6) The remaining net tax amount collected under RCW 82.38.030
12 (5) and (6) must be distributed to the transportation partnership
13 account created in RCW 46.68.290.

14 (7) The remaining net tax amount collected under RCW 82.38.030
15 (7) and (8) must be distributed to the connecting Washington account
16 created in RCW 46.68.395.

17 (8) The remaining net tax amount collected under RCW 82.38.030
18 (9) through (12) must be distributed as follows:

19 (a) Two and one-half percent must be distributed to the
20 incorporated cities and towns of the state in accordance with RCW
21 46.68.110;

22 (b) Two and one-half percent must be distributed to counties of
23 the state in accordance with RCW 46.68.120; and

24 (c) The remainder must be distributed to the motor vehicle fund
25 created in RCW 46.68.070.

26 (9) Nothing in this section or in RCW 46.68.130 may be construed
27 so as to violate any terms or conditions contained in any highway
28 construction bond issues now or hereafter authorized by statute and
29 whose payment is by such statute pledged to be paid from any excise
30 taxes on fuel.

21 (a) A commercial motor vehicle, as defined in RCW 46.25.010; or
22 (b) A motor vehicle that has a gross vehicle weight rating of
23 greater than 10,000 pounds other than motor homes, as defined in RCW
24 46.04.305.

25 (4) The revenue collected under this section must be deposited in
26 the multimodal transportation account created in RCW 47.66.070.

27 (5) For the purposes of this section and section 204 of this act,

34 82.32.210 for the collection of unpaid trust fund taxes from a
35 limited liability business entity and that business entity has been

19 responsible individual who is the current or a former chief executive
20 or chief financial officer is liable under this section only for
21 trust fund tax liability accrued during the period that he or she was
22 the chief executive or chief financial officer. However, if the
23 responsible individual had the responsibility or duty to remit
24 payment of the limited liability business entity's trust fund taxes
25 to the department during any period of time that the person was not
26 the chief executive or chief financial officer, that individual is
27 also liable for trust fund tax liability that became due during the
28 period that he or she had the duty to remit payment of the limited
29 liability business entity's taxes to the department but was not the
30 chief executive or chief financial officer.

31 (b) All other responsible individuals are liable under this
32 section only for trust fund tax liability that became due during the

7 (8) Collection authority and procedures prescribed in this
8 chapter apply to collections under this section.

9 (9) The definitions in this subsection apply throughout this
10 section unless the context clearly requires otherwise.

11 (a) "Chief executive" means: The president of a corporation; or
12 for other entities or organizations other than corporations or if the
13 corporation does not have a president as one of its officers, the
14 highest ranking executive manager or administrator in charge of the
15 management of the company or organization.

16 (b) "Chief financial officer" means: The treasurer of a
17 corporation; or for entities or organizations other than corporations
18 or if a corporation does not have a treasurer as one of its officers,
19 the highest senior manager who is responsible for overseeing the
20 financial activities of the entire company or organization.

21 (c) "Limited liability business entity" means a type of business
22 entity that generally shields its owners from personal liability for
23 the debts, obligations, and liabilities of the entity, or a business
24 entity that is managed or owned in whole or in part by an entity that
25 generally shields its owners from personal liability for the debts,
26 obligations, and liabilities of the entity. Limited liability
27 business entities include corporations, limited liability companies,
28 limited liability partnerships, trusts, general partnerships and
29 joint ventures in which one or more of the partners or parties are
30 also limited liability business entities, and limited partnerships in
31 which one or more of the general partners are also limited liability
32 business entities.

33 (d) "Manager" has the same meaning as in RCW 25.15.006.

34 (e) "Member" has the same meaning as in RCW 25.15.006, except
35 that the term only includes members of member-managed limited
36 liability companies.

37 (f) "Officer" means any officer or assistant officer of a
38 corporation, including the president, vice president, secretary, and
39 treasurer.

1 (g)(i) "Responsible individual" includes any current or former
2 officer, manager, member, partner, or trustee of a limited liability
3 business entity with an unpaid tax warrant issued by the department.

4 (ii) "Responsible individual" also includes any current or former
5 employee or other individual, but only if the individual had the
6 responsibility or duty to remit payment of the limited liability
7 business entity's unpaid trust fund tax liability reflected in a tax
8 warrant issued by the department.

9 (iii) Whenever any taxpayer has one or more limited liability
10 business entities as a member, manager, or partner, "responsible
11 individual" also includes any current and former officers, members,
12 or managers of the limited liability business entity or entities or
13 of any other limited liability business entity involved directly in

15 (9)(g)(iii), "taxpayer" means a limited liability business entity
16 with an unpaid tax warrant issued against it by the department.

26 act.

27 NEW SECTION. **Sec. 207.** (1)(a) In addition to taxes required

- 5 (a) Aircraft exempt from taxes under RCW 82.48.100; and
- 6 (b) "Commercial airplane" as defined in RCW 82.32.550.

7 NEW SECTION. **Sec. 208.** (1)(a) In addition to taxes required
8 under chapters 82.08, 82.12, and 82.48 RCW, there is levied and
9 collected from every person in this state a tax for the privilege of
10 using within this state as a consumer any noncommercial aircraft if
11 the value of the aircraft exceeds \$500,000.

12 (b) The tax is levied and must be collected in an amount equal to
13 the value of the aircraft that exceeds \$500,000, multiplied by 10
14 percent.

15 (2) The tax imposed in this section does not apply if the sale
16 to, or the use by, the present user or his or her bailor or donor has
17 already been subjected to the tax under section 207 of this act and
18 the tax has been paid by the present user or by his or her bailor or
19 donor.

20 (3) The tax imposed in this section does not apply in respect to
21 the use by a nonresident of Washington of a noncommercial aircraft,
22 which is registered or licensed under the laws of the state of his or
23 her residence.

24 (4) For the purposes of this section, "value" means the fair
25 market value of the noncommercial aircraft. In the case of a leased
26 noncommercial aircraft in which the consumer is required to make
27 periodic lease payments, "value" of the aircraft means the fair
28 market value of the aircraft at the inception of the lease.

29 NEW SECTION. **Sec. 209.** If chapter . . ., Laws of 2025
30 (Engrossed Substitute House Bill No. 2061) is enacted by June 30,
31 2025, the revenue collected under this chapter must be deposited in
32 the sustainable aviation fuel account. If chapter . . ., Laws of 2025
33 (Engrossed Substitute House Bill No. 2061) is not enacted by June 30,
34 2025, the revenue collected under this chapter must be deposited in
35 the aeronautics account created in RCW 82.42.090.

36 NEW SECTION. **Sec. 210.** Chapter 82.32 RCW applies to the
37 administration of the luxury tax authorized in this chapter.

6 **Sec. 301.** RCW 70A.205.405 and 2020 c 20 s 1190 are each amended

9 retail sale of new replacement vehicle tires. The fee imposed in this
10 section must be paid by the buyer to the seller, and each seller
11 shall collect from the buyer the full amount of the fee. The fee
12 collected from the buyer by the seller less the ten percent amount
13 retained by the seller as provided in RCW 70A.205.430(1) must be paid
14 to the department of revenue in accordance with RCW 82.32.045.

15 (2) The department of revenue shall incorporate into the agency's
16 regular audit cycle a reconciliation of the number of tires sold and
17 the amount of revenue collected by the businesses selling new
18 replacement vehicle tires at retail. The department of revenue shall
19 collect on the business excise tax return from the businesses selling
20 new replacement vehicle tires at retail:

- 21 (a) The number of tires sold; and
- 22 (b) The fee levied in this section.

23 (3) All other applicable provisions of chapter 82.32 RCW have
24 full force and application with respect to the fee imposed under this
25 section. The department of revenue shall administer this section.

26 (4) For the purposes of this section, "new replacement vehicle
27 tires" means tires that are newly manufactured for vehicle purposes
28 and does not include retreaded vehicle tires.

29 **Sec. 302.** RCW 70A.205.425 and 2020 c 20 s 1192 are each amended
30 to read as follows:

31 (1) (~~All receipts from~~) The first \$600,000 of the net receipts

27 distributed to retail tire sales and tire service outlets;

28 (d) Product marketing studies for recycled tires and alternatives
29 to land disposal.

30 **Sec. 304.** RCW 46.63.200 and 2024 c 308 s 4 are each amended to

32 (1) This section applies to the use of speed safety camera
33 systems in state highway work zones.

34 (2) Nothing in this section prohibits a law enforcement officer
35 from issuing a notice of infraction to a person in control of a
36 vehicle at the time a violation occurs under RCW 46.63.030(1) (a),
37 (b), or (c).

1 (3) (a) The department of transportation is responsible for all
2 actions related to the operation and administration of speed safety
3 camera systems in state highway work zones including, but not limited
4 to, the procurement and administration of contracts necessary for the
5 implementation of speed safety camera systems, the mailing of notices
6 of infraction, and the development and maintenance of a public-facing
7 website for the purpose of educating the traveling public about the
8 use of speed safety camera systems in state highway work zones. Prior
9 to the use of a speed safety camera system to capture a violation
10 established in this section for enforcement purposes, the department
11 of transportation, in consultation with the Washington state patrol,
12 department of licensing, office of administrative hearings,
13 Washington traffic safety commission, and other organizations
14 committed to protecting civil rights, must adopt rules addressing
15 such actions and take all necessary steps to implement this section.

16 (b) The Washington state patrol is responsible for all actions
17 related to the enforcement and adjudication of speed violations under
18 this section including, but not limited to, notice of infraction
19 verification and issuance authorization, and determining which types
20 of emergency vehicles are exempt from being issued notices of
21 infraction under this section. Prior to the use of a speed safety
22 camera system to capture a violation established in this section for
23 enforcement purposes, the Washington state patrol, in consultation
24 with the department of transportation, department of licensing,
25 office of administrative hearings, Washington traffic safety
26 commission, and other organizations committed to protecting civil
27 rights, must adopt rules addressing such actions and take all
28 necessary steps to implement this section.

29 (c) When establishing rules under this subsection (3), the
30 department of transportation and the Washington state patrol may also
31 consult with other public and private agencies that have an interest
32 in the use of speed safety camera systems in state highway work
33 zones.

34 (4) (a) No person may drive a vehicle in a state highway work zone
35 at a speed greater than that allowed by traffic control devices.

36 (b) A notice of infraction may only be issued under this section
37 if a speed safety camera system captures a speed violation in a state
38 highway work zone when workers are present.

1 (5) The penalty for a speed safety camera system violation is:
2 (a) (~~(\$0)~~) \$125 for the first violation; and (b) \$248 for the second
3 violation, and for each violation thereafter.

4 (6) During the 30-day period after the first speed safety camera
5 system is put in place, the department is required to conduct a
6 public awareness campaign to inform the public of the use of speed
7 safety camera systems in state highway work zones.

8 (7) (a) A notice of infraction issued under this section may be
9 mailed to the registered owner of the vehicle within 30 days of the
10 violation, or to the renter of a vehicle within 30 days of
11 establishing the renter's name and address. The law enforcement
12 officer issuing the notice of infraction shall include with it a
13 certificate or facsimile thereof, based upon inspection of
14 photographs, microphotographs, or electronic images produced by a
15 speed safety camera stating the facts supporting the notice of
16 infraction. This certificate or facsimile is prima facie evidence of
17 the facts contained in it and is admissible in a proceeding charging
18 a violation under this section. The photographs, microphotographs, or
19 electronic images evidencing the violation must be available for
20 inspection and admission into evidence in a proceeding to adjudicate
21 the liability for the violation.

22 (b) A notice of infraction represents a determination that an
23 infraction has been committed, and the determination will be final
24 unless contested as provided under this section.

25 (c) A person receiving a notice of infraction based on evidence
26 detected by a speed safety camera system must, within 30 days of
27 receiving the notice of infraction: (i) (~~(Except for a first~~
28 ~~violation under subsection (5)(a) of this section, remit)~~) Remit
29 payment in the amount of the penalty assessed for the violation; (ii)
30 contest the determination that the infraction occurred by following
31 the instructions on the notice of infraction; or (iii) admit to the
32 infraction but request a hearing to explain mitigating circumstances
33 surrounding the infraction.

34 (d) If a person fails to respond to a notice of infraction, a
35 final order shall be entered finding that the person committed the
36 infraction and assessing monetary penalties required under subsection
37 (5) (~~(b)~~) of this section.

38 (e) If a person contests the determination that the infraction
39 occurred or requests a mitigation hearing, the notice of infraction

1 shall be referred to the office of administrative hearings for
2 adjudication consistent with chapter 34.05 RCW.

3 (f) At a hearing to contest an infraction, the agency issuing the
4 infraction has the burden of proving, by a preponderance of the
5 evidence, that the infraction was committed.

6 (g) A person may request a payment plan at any time for the
7 payment of any penalty or other monetary obligation associated with
8 an infraction under this section. The agency issuing the infraction
9 shall provide information about how to submit evidence of inability
10 to pay, how to obtain a payment plan, and that failure to pay or
11 enter into a payment plan may result in collection action or
12 nonrenewal of the vehicle registration. The office of administrative
13 hearings may authorize a payment plan if it determines that a person
14 is not able to pay the monetary obligation, and it may modify a
15 payment plan at any time.

16 (8)(a) Speed safety camera systems may only take photographs,
17 microphotographs, or electronic images of the vehicle and vehicle
18 license plate and only while a speed violation is occurring. The
19 photograph, microphotograph, or electronic image must not reveal the
20 face of the driver or any passengers in the vehicle. The department
21 of transportation shall consider installing speed safety camera
22 systems in a manner that minimizes the impact of camera flash on
23 drivers.

24 (b) The registered owner of a vehicle is responsible for a
25 traffic infraction under RCW 46.63.030 unless the registered owner
26 overcomes the presumption in RCW 46.63.075 or, in the case of a
27 rental car business, satisfies the conditions under (f) of this
28 subsection. If appropriate under the circumstances, a renter
29 identified under (f)(i) of this subsection is responsible for the
30 traffic infraction.

31 (c) Notwithstanding any other provision of law, all photographs,
32 microphotographs, or electronic images, or any other personally
33 identifying data prepared under this section are for the exclusive
34 use of the Washington state patrol and department of transportation
35 in the discharge of duties under this section and are not open to the
36 public and may not be used in court in a pending action or proceeding
37 unless the action or proceeding relates to a speed violation under
38 this section. This data may be used in administrative appeal
39 proceedings relative to a violation under this section.

1 (d) All locations where speed safety camera systems are used must
2 be clearly marked before activation of the camera system by placing
3 signs in locations that clearly indicate to a driver that they are
4 entering a state highway work zone where posted speed limits are
5 monitored by a speed safety camera system. Additionally, where
6 feasible and constructive, radar speed feedback signs will be placed
7 in advance of the speed safety camera system to assist drivers in
8 complying with posted speed limits. Signs placed in these locations
9 must follow the specifications and guidelines under the manual of
10 uniform traffic control devices for streets and highways as adopted
11 by the department of transportation under chapter 47.36 RCW.

12 (e) Imposition of a penalty for a speed violation detected
13 through the use of speed safety camera systems shall not be deemed a
14 conviction as defined in RCW 46.25.010, and shall not be part of the
15 registered owner's driving record under RCW 46.52.101 and 46.52.120.
16 Additionally, infractions generated by the use of speed safety camera
17 systems under this section shall be processed in the same manner as
18 parking infractions, including for the purposes of RCW 46.16A.120 and
19 46.20.270(2).

20 (f) If the registered owner of the vehicle is a rental car
21 business, the department of transportation shall, before a notice of
22 infraction may be issued under this section, provide a written notice
23 to the rental car business that a notice of infraction may be issued
24 to the rental car business if the rental car business does not,
25 within 30 days of receiving the written notice, provide to the
26 issuing agency by return mail:

27 (i)(A) A statement under oath stating the name and known mailing
28 address of the individual driving or renting the vehicle when the
29 speed violation occurred;

30 (B) A statement under oath that the business is unable to
31 determine who was driving or renting the vehicle at the time the
32 speed violation occurred because the vehicle was stolen at the time
33 of the violation. A statement provided under this subsection
34 (8)(f)(i)(B) must be accompanied by a copy of a filed police report
35 regarding the vehicle theft; or

36 (C) In lieu of identifying the vehicle operator, payment of the
37 applicable penalty.

38 (ii) Timely mailing of a statement to the department of
39 transportation relieves a rental car business of any liability under
40 this chapter for the notice of infraction.

1 (9) Revenue generated from the deployment of speed safety camera
2 systems must be deposited into the highway safety fund and first used
3 exclusively for the operating and administrative costs under this

26 (3) For contracts eligible for the use of federal funds,
27 contractors must comply with federal disadvantaged business
28 enterprise targets as outlined by the federal agency awarding funds.

29 (4) Contractors located in the state of Washington must meet the
30 requirements of RCW 47.60.835, the small business enterprise
31 enforceable goals program.

32 (5) The department shall employ third-party experts that report
33 to the Washington state ferries to serve as a supplementary resource.
34 The third-party experts contracted by the Washington state ferries
35 shall:

36 (a) Perform project quality oversight and report to the
37 transportation committees of the legislature and the office of

39 risks, and project budget;

24 **Sec. 501.** RCW 47.46.100 and 2002 c 114 s 7 are each amended to

28 primarily by bonds issued by the state. Subject to RCW 47.46.090, the

9 on bonds issued for any particular toll bridge or toll bridges; and

10 (c) Repay the motor vehicle fund under RCW 47.46.110, 47.56.165,

12 (4) The bond principal and interest payments, including repayment
13 of the motor vehicle fund for amounts transferred from that fund to
14 provide for such principal and interest payments, constitute a first
15 direct and exclusive charge and lien on all tolls and other revenues
16 from the toll bridge concerned, subject to operating and maintenance
17 expenses.

18 **Sec. 502.** RCW 47.56.850 and 2009 c 498 s 15 are each amended to

21 legislature, the transportation commission is the tolling authority
22 for the state. The tolling authority shall:

3 administration, and toll enforcement by public law enforcement;

4 (b) Meet obligations for the timely payment of debt service on
5 bonds issued for eligible toll facilities, and any other associated
6 financing costs including, but not limited to, required reserves,
7 minimum debt coverage or other appropriate contingency funding,
8 insurance, and compliance with all other financial and other
9 covenants made by the state in the bond proceedings;

10 (c) Meet obligations to reimburse the motor vehicle fund for
11 excise taxes on motor vehicle and special fuels applied to the

13 (d) Meet any other obligations of the tolling authority to
14 provide its proportionate share of funding contributions for any

18 this subsection.

19 (b) The tolling authority shall initially set the variable
20 schedule of toll rates, which the tolling authority may adjust at
21 least annually to reflect inflation as measured by the consumer price
22 index or as necessary to meet the redemption of bonds and interest
23 payments on the bonds, to generate revenue sufficient to provide for:

24 (i) The issuance of general obligation bonds, authorized in RCW
25 47.10.879, first payable from toll revenue and then excise taxes on

3 connections benefit or improve the operation of state route number

16 department shall report to the transportation committees of the
17 legislature when average transit speeds in the two lanes that are for

21 city of Seattle to include sound transit, King county metro, the

27 group must consider such techniques as grade separation, additional

14 cause substantial adverse effects to shoreline resources or the
15 shoreline environment. Replacement of a structure or development may
16 be considered a repair if: Replacement is the common method of repair
17 for the type of structure or development; the replacement structure
18 or development is comparable to the original structure or development
19 including, but not limited to, the size, shape, configuration,
20 location, and external appearance of the original structure or
21 development; and the replacement does not cause substantial adverse
22 effects to shoreline resources or the shoreline environment.

23 (c) "Replacement" of any existing transportation facility, or
24 transit facility, including surface, shoulders, roadsides, structures

1 lease or ownership area of a state ferry terminal, or the lease or
2 ownership area of a transit facility, including ancillary

6 equipment, including pavement marking, freeway surveillance and
7 control systems, railroad protective devices not including grade

11 (d) Construction undertaken in response to unforeseen,

35 or rehabilitation following the conviction of a criminal offense.
36 Facilities included under this subsection (1)(b) shall not include
37 facilities detaining persons under RCW 71.09.020 (7) or (16) or
38 chapter 10.77 or 71.05 RCW.

1 (c) The department of children, youth, and families may not
2 attempt to site new community facilities as defined in RCW 72.05.020
3 east of the crest of the Cascade mountain range unless there is an
4 equal or greater number of sited community facilities as defined in
5 RCW 72.05.020 on the western side of the crest of the Cascade
6 mountain range.

7 (d) For the purpose of this (~~section, "harm")~~ subsection:

8 (i) "Bus rapid transit" means a fixed route bus system that
9 features assets indicating permanent, high capacity service
10 including, but not limited to, elevated platforms or enhanced
11 stations, off-board fare collection, dedicated lanes, busways, or
12 transit signal priority; and

13 (ii) Harm reduction programs" means programs that emphasize
14 working directly with people who use drugs to prevent overdose and
15 infectious disease transmission, improve the physical, mental, and
16 social well-being of those served, and offer low threshold options
17 for accessing substance use disorder treatment and other services.

18 (2) Each county and city planning under RCW 36.70A.040 shall, not
19 later than September 1, 2002, establish a process, or amend its
20 existing process, for identifying and siting essential public
21 facilities and adopt or amend its development regulations as
22 necessary to provide for the siting of secure community transition
23 facilities consistent with statutory requirements applicable to these
24 facilities.

25 (3) Any city or county not planning under RCW 36.70A.040 shall,
26 not later than September 1, 2002, establish a process for siting
27 secure community transition facilities and adopt or amend its
28 development regulations as necessary to provide for the siting of
29 such facilities consistent with statutory requirements applicable to
30 these facilities.

31 (4) The office of financial management shall maintain a list of
32 those essential state public facilities that are required or likely
33 to be built within the next six years. The office of financial
34 management may at any time add facilities to the list.

35 (5) (a) No local comprehensive plan or development regulation may
36 preclude the siting of essential public facilities.

37 (b) A city or county precludes an essential public facility when
38 the city or county imposes conditions or costs that the city or
39 county cannot demonstrate are reasonably necessary to mitigate
40 adverse impacts directly caused by construction or operation of the

1 essential public facility. A city or county with permitting authority
2 shall commit to reasonable timelines to ensure timely issuance of
3 permits without unnecessary delay. The essential public facility
4 shall provide the city or county with the information needed to make
5 timely permitting decisions. This subsection (5)(b) is limited
6 exclusively to those essential public facilities that are
7 improvements to high capacity transportation systems as defined in
8 RCW 81.104.015.

9 (6) No person may bring a cause of action for civil damages based
10 on the good faith actions of any county or city to provide for the
11 siting of secure community transition facilities in accordance with
12 this section and with the requirements of chapter 12, Laws of 2001
13 2nd sp. sess. For purposes of this subsection, "person" includes, but
14 is not limited to, any individual, agency as defined in RCW
15 29B.10.030, corporation, partnership, association, and limited
16 liability entity.

17 (7) Counties or cities siting facilities pursuant to subsection
18 (2) or (3) of this section shall comply with RCW 71.09.341.

19 (8) The failure of a county or city to act by the deadlines
20 established in subsections (2) and (3) of this section is not:

21 (a) A condition that would disqualify the county or city for
22 grants, loans, or pledges under RCW 43.155.070 or 70A.135.070;

23 (b) A consideration for grants or loans provided under RCW
24 43.17.250(3); or

25 (c) A basis for any petition under RCW 36.70A.280 or for any
26 private cause of action.

27 NEW SECTION. Sec. 605. A new section is added to chapter 43.21C
28 RCW to read as follows:

29 In the event of a disagreement over the scope of a transit
30 project, state agencies, cities, and counties shall accept the
31 detailed statement prepared by the transit agency under RCW
32 43.21C.030(2)(c) as the sole environmental review document, rather
33 than conducting separate environmental reviews or preparing
34 additional detailed statements. Consistent with RCW 43.21C.150, when
35 a transit agency has previously prepared an adequate detailed
36 statement pursuant to the national environmental policy act of 1969
37 as part of a federally funded transit project, that national
38 environmental policy act document shall satisfy the requirements
39 under RCW 43.21C.030(2)(c). State agencies, cities, and counties

1 shall adopt and rely on the national environmental policy act
2 document for their environmental review and permitting processes,
3 aligning applicable local documents accordingly. For purposes of this
4 section, "transit agency" does not include a regional transit
5 authority under chapter 81.112 RCW.

6 **PART VII: TRANSPORTATION GRANT PROGRAMS**

7 NEW SECTION. **Sec. 701.** A new county local road program is
8 established to fund the preservation and improvement of county local
9 roads. The board must:

10 (1) Adopt rules necessary to implement the provisions of this
11 chapter relating to the allocation of funds; and

12 (2) Include a program status report in the board's annual report
13 to the legislature as provided in RCW 36.78.070.

14 NEW SECTION. **Sec. 702.** The definitions in this section apply
15 throughout this chapter unless the context clearly requires
16 otherwise.

17 (1) "Board" means the county road administration board created in
18 RCW 36.78.030.

19 (2) "Community facility" means a publicly owned facility or
20 building that is primarily intended to serve the recreational,
21 educational, cultural, public health and safety, administrative, or
22 entertainment needs of the community as a whole.

23 (3) "County local road program project" means improvement
24 projects on those county roads not federally classified as an
25 arterial or collector.

26 (4) "LAG manual" means the Washington state department of
27 transportation's local agency guidelines manual or its successor
28 document.

29 (5) "Overburdened community" has the same meaning as defined in
30 RCW 70A.02.010.

31 (6) "Pedestrian facility" means a facility designed to meet the
32 needs of pedestrians in accordance with county and Americans with
33 disabilities act requirements.

34 NEW SECTION. **Sec. 703.** (1) The board shall adopt rules to
35 select preservation and improvement projects under this chapter

1 taking into consideration, at a minimum, the following priority
2 rating factors:

3 (a) Investment in overburdened communities;

4 (b) Environmental health disparities as identified in the
5 environmental health disparities map specified in RCW 43.70.815;

6 (c) Location on or providing direct access to a federally
7 recognized Indian reservation or lands;

8 (d) Sustaining the structural, safety, and operational integrity
9 of the road;

10 (e) Vehicle and pedestrian collision experience;

11 (f) Access improvements to a community facility; and

12 (g) Identified need in a state, regional, county, or community
13 plan.

14 (2) Proposed projects must be included in the respective county's
15 six-year plan as provided in RCW 36.81.121 before board approval of
16 the project.

17 NEW SECTION. **Sec. 704.** The following project types are allowed
18 under the county local road program created in this chapter:

19 (1) 2-R as defined in the LAG manual;

20 (2) 3-R as defined in the LAG manual;

21 (3) Reconstruction as defined in the LAG manual;

22 (4) Replacement of any bridge on the national bridge inventory;

23 (5) Removal of human-made or caused impediments to anadromous
24 fish passage; and

25 (6) Pedestrian facilities.

26 NEW SECTION. **Sec. 705.** Whenever a proposed county local road
27 program project is adjacent to a city or town, the appropriate city
28 or town and county officials shall jointly plan and include the
29 improvement in their respective long-range plans. Whenever a county
30 local road program project connects with and will be substantially
31 affected by a programmed construction project on a state highway, the
32 proper county officials shall jointly plan the development of such
33 project with the department of transportation district administrator.

34 NEW SECTION. **Sec. 706.** Counties receiving funds from the county
35 local road program shall provide such matching funds as established
36 by rules adopted by the board. Matching requirements must be

1 established after appropriate studies by the board and considering
2 the financial resources available to counties.

3 NEW SECTION. **Sec. 707.** (1) Only those counties that, during the
4 preceding 12 months, have spent all revenues collected for road
5 purposes only for such purposes, including removal of barriers to
6 fish passage and accompanying streambed and stream bank repair as
7 specified in RCW 36.82.070, and including traffic law enforcement as
8 allowed under Article II, section 40 of the state Constitution or RCW
9 36.82.070(2), are eligible to receive funds from the county local
10 road program, except that:

11 (a) Counties with a population of less than 8,000 are exempt from
12 this eligibility restriction;

13 (b) Counties expending revenues collected for road purposes only
14 on other governmental services after authorization from the voters of
15 that county under RCW 84.55.050 are exempt from this eligibility
16 restriction; and

17 (c) This restriction does not apply to any moneys diverted from
18 the road district levy under chapter 39.89 RCW.

19 (2) The board shall authorize county local road grant program
20 funds for the construction project portion of a project previously
21 authorized for a preliminary proposal in the sequence in which the
22 preliminary proposal has been completed and the construction project
23 is to be placed under contract. At such time the board may reserve
24 funds for expenditure in future years as may be necessary for
25 completion of preliminary proposals and construction projects to be
26 commenced in the ensuing biennium.

27 (3) Subject to the availability of amounts appropriated for this
28 specific purpose, the board may consider additional projects for
29 authorization under this chapter upon a clear and conclusive showing
30 by the submitting county that the proposed project is of an emergent
31 nature and that its need was unable to be anticipated at the time the
32 six-year plan of the county was developed. The proposed projects must
33 be evaluated on the basis of the priority rating factors specified in
34 section 703 of this act.

35 NEW SECTION. **Sec. 708.** Whenever the board approves a county
36 local road program project under this chapter it shall determine the
37 amount of county local road program funds to be allocated for such
38 project. The allocation must be based upon information submitted by

1 the county seeking approval of the project and upon such further
2 investigation as the board deems necessary. The board shall adopt
3 reasonable rules pursuant to which county local road program funds
4 allocated to a project may be increased upon a subsequent application
5 of the county constructing the project. The rules adopted by the
6 board must take into account, but are not limited to, the following
7 factors:

8 (1) The financial effect of increasing the original allocation
9 for the project upon other county local road program projects either
10 approved or requested;

11 (2) Whether the project for which an additional allocation is
12 requested can be reduced in scope while retaining a usable segment;

13 (3) Whether the original cost of the project shown in the
14 applicant's original submittal was based upon reasonable engineering
15 estimates; and

16 (4) Whether the requested additional allocation is to pay for an
17 expansion in the scope of work originally approved.

18 NEW SECTION. **Sec. 709.** Sections 701 through 708 of this act
19 constitute a new chapter in Title 36 RCW.

20 **Sec. 710.** RCW 47.04.380 and 2024 c 106 s 1 are each amended to
21 read as follows:

22 (1) The legislature finds that many communities across Washington
23 state have not equitably benefited from investments in the active
24 transportation network. The legislature also finds that legacy state
25 transportation facilities designed primarily for vehicle use caused
26 disconnections in safe routes for people who walk, bike, and roll to
27 work and to carry out other daily activities.

28 (2) To address these investment gaps, and to honor the legacy of
29 community advocacy of Sandy Williams, the Sandy Williams connecting
30 communities program is established within the department. The purpose
31 of the program is to improve active transportation connectivity in
32 communities by:

33 (a) Providing safe, continuous routes for pedestrians,
34 bicyclists, and other nonvehicle users carrying out their daily
35 activities;

36 (b) Mitigating for the health, safety, and access impacts of
37 transportation infrastructure that bisects communities and creates
38 obstacles in the local active transportation network;

1 (c) Investing in greenways providing protected routes for a wide
2 variety of nonvehicular users; and

3 (d) Facilitating the planning, development, and implementation of
4 projects and activities that will improve the connectivity and safety
5 of the active transportation network.

6 (3) The department must select projects to propose to the
7 legislature for funding. In selecting projects, the department must
8 consider, at a minimum, the following criteria:

9 (a) Access to a transit facility, community facility, commercial
10 center, or community-identified assets;

11 (b) The use of minority and women-owned businesses and community-
12 based organizations in planning, community engagement, design, and
13 construction of the project;

14 (c) Whether the project will serve:

15 (i) Overburdened communities as defined in RCW 70A.02.010 to mean
16 a geographic area where vulnerable populations face combined,
17 multiple environmental harms and health impacts, and includes, but is
18 not limited to, highly impacted communities as defined in RCW
19 19.405.020;

20 (ii) Vulnerable populations as defined in RCW 70A.02.010 to mean
21 population groups that are more likely to be at higher risk for poor
22 health outcomes in response to environmental harms, due to adverse
23 socioeconomic factors, such as unemployment, high housing, and
24 transportation costs relative to income, limited access to nutritious
25 food and adequate health care, linguistic isolation, and other
26 factors that negatively affect health outcomes and increase
27 vulnerability to the effects of environmental harms; and sensitivity
28 factors, such as low birth weight and higher rates of
29 hospitalization. Vulnerable populations include, but are not limited
30 to: Racial or ethnic minorities, low-income populations, populations
31 disproportionately impacted by environmental harms, and populations
32 of workers experiencing environmental harms;

33 (iii) Household incomes at or below 200 percent of the federal
34 poverty level; and

35 (iv) People with disabilities;

36 (d) Environmental health disparities, such as those indicated by
37 the diesel pollution burden portion of the Washington environmental
38 health disparities map developed by the department of health, or
39 other similar indicators;

1 (e) Location on or adjacent to tribal lands or locations
2 providing essential services to tribal members;

3 (f) Crash experience involving pedestrians and bicyclists; and

4 (g) Identified need by the community, for example in the state
5 active transportation plan or a regional, county, or community plan.

6 (4) It is the intent of the legislature that the Sandy Williams
7 connecting communities program comply with the requirements of
8 chapter 314, Laws of 2021.

9 (5) The department shall submit a report to the transportation
10 committees of the legislature by December 1, 2022, and each December
11 1st thereafter identifying the selected connecting communities
12 projects for funding by the legislature. The report must also include
13 the status of previously funded projects.

14 (6) The Sandy Williams connecting communities program account is
15 created in the state treasury. Moneys in the account may be spent
16 only after appropriation. Expenditures from the account may be used
17 only for the program activities described in this section.

18 (7) Beginning September 2027, by the last day of September,
19 December, March, and June of each year, the state treasurer shall
20 transfer \$3,125,000 from the multimodal transportation account
21 created in RCW 47.66.070 to the Sandy Williams connecting communities
22 program account created in this section.

23 **Sec. 711.** RCW 47.04.390 and 2023 c 431 s 7 are each amended to
24 read as follows:

25 (1)(a) The department shall establish a statewide school-based
26 bicycle education grant program. The grant will support two programs:
27 One for (~~elementary and middle school~~) grades three through eight;
28 and one for (~~junior high and high school~~) grades six through 12
29 aged youth to develop the skills and street safety knowledge to be
30 more confident bicyclists for transportation and/or recreation. In
31 development of the grant program, the department is encouraged to

2 and demonstrable experience deploying bicycling and road safety

4 selected nonprofit shall identify partner schools and partner
5 organizations that serve target populations, based on the criteria in
6 subsection ~~((3))~~ (4) of this section. Partner schools shall receive
7 from the nonprofit: In-school bike and pedestrian safety education
8 curriculum, materials, equipment guidance and consultation, and
9 physical education teacher ~~((trainings. Youth grades three through~~
10 ~~eight are eligible for the program.~~

11 ~~(b) Selected school districts shall receive and maintain a fleet~~
12 ~~of bicycles for the youth in the program. Youth and families~~
13 ~~participating in the school-base bicycle education grant program~~
14 ~~shall have an opportunity to receive a bike, lock, helmet, and lights~~
15 ~~free of cost)) training. Selected school districts shall receive and~~
16 ~~maintain a fleet of bicycles for the youth in the program.~~

17 (3) For the ~~((junior high and high school))~~ grades six through 12
18 program, the department shall contract with a nonprofit organization
19 with relevant reach and experience, including a statewide footprint;
20 demonstrable experience developing and managing youth-based
21 programming serving youth of color in an after-school and/or
22 community setting; and deploying bicycling and road safety education
23 curriculum via a train the trainer model. The selected nonprofit
24 shall use the equity-based criteria in subsection (4) of this section
25 to identify target populations and partner organizations including,
26 but not limited to, schools, community-based organizations, housing
27 authorities, and parks and recreation departments, that work with the
28 eligible populations of youth ~~((ages 14 to 18))~~. Partner
29 organizations shall receive from the nonprofit: Education curriculum,
30 materials, equipment including, but not limited to, bicycles,
31 helmets, locks, and lights, guidance and consultation, and initial
32 instructor/volunteer training, as well as ongoing support.

33 (4) In selecting schools and partner organizations for the
34 school-based bicycle education grant program, the department and
35 nonprofit must consider, at a minimum, the following criteria:

36 (a) Population impacted by poverty, as measured by free and
37 reduced lunch population or 200 percent federal poverty level;

38 (b) People of color;

39 (c) People of Hispanic heritage;

40 (d) People with disabilities;

1 (e) Environmental health disparities, such as those indicated by
2 the diesel pollution burden portion of the Washington environmental
3 health disparities map developed by the department of health, or
4 other similar indicators;

5 (f) Location on or adjacent to an Indian reservation;

6 (g) Geographic location throughout the state;

7 (h) Crash experience involving pedestrians and bicyclists;

8 (i) Access to a community facility or commercial center; and

9 (j) Identified need in the state active transportation plan or a
10 regional, county, or community plan.

11 (5) The department shall submit a report for both programs to the
12 transportation committees of the legislature by December 1, 2022, and
13 each December 1st thereafter identifying the selected programs and
14 school districts for funding by the legislature. The report must also
15 include the status of previously funded programs.

16 **PART VIII: GREEN TRANSPORTATION POLICY**

17 **Climate Commitment Act Transportation Accounts**

18 NEW SECTION. **Sec. 801.** The following acts or parts of acts are
19 each repealed:

20 (1) RCW 46.68.490 (Climate active transportation account) and
21 2023 c 472 s 711 & 2022 c 182 s 102; and

22 (2) RCW 46.68.500 (Climate transit programs account) and 2023 c
23 472 s 712 & 2022 c 182 s 103.

24 **Sec. 802.** RCW 43.84.092 and 2024 c 210 s 4 and 2024 c 168 s 12
25 are each reenacted and amended to read as follows:

26 (1) All earnings of investments of surplus balances in the state
27 treasury shall be deposited to the treasury income account, which
28 account is hereby established in the state treasury.

29 (2) The treasury income account shall be utilized to pay or
30 receive funds associated with federal programs as required by the
31 federal cash management improvement act of 1990. The treasury income
32 account is subject in all respects to chapter 43.88 RCW, but no
33 appropriation is required for refunds or allocations of interest
34 earnings required by the cash management improvement act. Refunds of

15 required for payments to financial institutions. Payments shall occur

31 a speed measuring device, and a camera synchronized to automatically
32 record one or more sequenced photographs, microphotographs, or
33 electronic images of the front or rear of a motor vehicle at the time
34 the vehicle fails to stop when facing a steady red traffic control
35 signal or an activated railroad grade crossing control signal, or
36 exceeds a speed limit as detected by a speed measuring device.
37 "Automated traffic safety camera" also includes a device used to
38 detect stopping at intersection or crosswalk violations; stopping

1 when traffic obstructed violations; public transportation only lane
2 violations; stopping or traveling in restricted lane violations; and
3 public transportation bus stop zone violations and public
4 transportation only lane violations detected by a public
5 transportation vehicle-mounted system.

6 (2) "Hospital speed zone" means the marked area within hospital
7 property and extending 300 feet from the border of the hospital
8 property (a) consistent with hospital use; and (b) where signs are
9 posted to indicate the location is within a hospital speed zone,
10 where "hospital" has the same meaning as in RCW 70.41.020.

11 (3) "Public park speed zone" means the marked area within public
12 park property and extending 300 feet from the border of the public
13 park property (a) consistent with active park use; and (b) where
14 signs are posted to indicate the location is within a public park
15 speed zone.

16 (4) "Public transportation vehicle" means any motor vehicle,
17 streetcar, train, trolley vehicle, ferry boat, or any other device,
18 vessel, or vehicle that is owned or operated by a transit authority
19 or an entity providing service on behalf of a transit authority that
20 is used for the purpose of carrying passengers and that operates on
21 established routes. "Transit authority" has the same meaning as
22 provided in RCW 9.91.025.

23 (5) "Roadway work zone" means an area of any city roadway,
24 including state highways that are also classified as city streets
25 under chapter 47.24 RCW, or county road as defined in RCW 46.04.150,
26 with construction, maintenance, or utility work with a duration of 30
27 calendar days or more. A roadway work zone is identified by the
28 placement of temporary traffic control devices that may include
29 signs, channelizing devices, barriers, pavement markings, and/or work
30 vehicles with warning lights. A roadway work zone extends from the
31 first warning sign or high intensity rotating, flashing, oscillating,
32 or strobe lights on a vehicle to the end road work sign or the last
33 temporary traffic control device or vehicle.

8 safety cameras and must adopt an ordinance authorizing such use
9 through its local legislative authority.

10 (3) The local legislative authority must prepare an analysis of
11 the locations within the jurisdiction where automated traffic safety
12 cameras are proposed to be located before adding traffic safety
13 cameras to a new location or relocating any existing camera to a new
14 location within the jurisdiction. The analysis must include equity
15 considerations including the impact of the camera placement on
16 livability, accessibility, economics, education, and environmental
17 health when identifying where to locate an automated traffic safety
18 camera. The analysis must also show a demonstrated need for traffic
19 cameras based on one or more of the following in the vicinity of the
20 proposed camera location: Travel by vulnerable road users, evidence
21 of vehicles speeding, rates of collision, reports showing near
22 collisions, and anticipated or actual ineffectiveness or
23 infeasibility of other mitigation measures.

24 (4) Automated traffic safety cameras may not be used on an on-
25 ramp to a limited access facility as defined in RCW 47.52.010.

26 (5) A city may use automated traffic safety cameras to enforce
27 traffic ordinances in this section on state highways that are also
28 classified as city streets under chapter 47.24 RCW. A city government
29 must notify the department of transportation when it installs an
30 automated traffic safety camera to enforce traffic ordinances as
31 authorized in this subsection.

32 (6) (a) At a minimum, a local ordinance adopted pursuant to this
33 section must contain the restrictions described in this section and
34 provisions for public notice and signage. Cities and counties must
35 also post such restrictions and other automated traffic safety camera
36 policies on the city's or county's website. Cities and counties using
37 automated traffic safety cameras before July 24, 2005, are subject to
38 the restrictions described in this section, but are not required to
39 adopt an authorizing ordinance.

1 (b) (i) Cities and counties using automated traffic safety cameras
2 must post an annual report on the city's or county's website of the
3 number of traffic crashes that occurred at each location where an
4 automated traffic safety camera is located, as well as the number of
5 notices of infraction issued for each camera. Beginning January 1,
6 2026, the annual report must include the percentage of revenues
7 received from fines issued from automated traffic safety camera
8 infractions that were used to pay for the costs of the automated
9 traffic safety camera program and must describe the uses of revenues
10 that exceeded the costs of operation and administration of the
11 automated traffic safety camera program by the city or county.

12 (ii) The Washington traffic safety commission must provide an
13 annual report to the transportation committees of the legislature,
14 and post the report to its website for public access, beginning July
15 1, 2026, that includes aggregated information on the use of automated
16 traffic safety cameras in the state that includes an assessment of
17 the impact of their use, information required in city and county
18 annual reports under (b) (i) of this subsection, and information on
19 the number of automated traffic safety cameras in use by type and
20 location, with an analysis of camera placement in the context of area
21 demographics and household incomes. To the extent practicable, the
22 commission must also provide in its annual report the number of
23 traffic accidents, speeding violations, single vehicle accidents,
24 pedestrian accidents, and driving under the influence violations that
25 occurred at each location where an automated traffic safety camera is
26 located in the five years before each camera's authorization and
27 after each camera's authorization. Cities and counties using
28 automated traffic safety cameras must provide the commission with the
29 data it requests for the report required under this subsection in a
30 form and manner specified by the commission.

31 (7) All locations where an automated traffic safety camera is
32 used on roadways or intersections must be clearly marked by placing
33 signs at least 30 days prior to activation of the camera in locations
34 that clearly indicate to a driver either that: (a) The driver is
35 within an area where automated traffic safety cameras are authorized;
36 or (b) the driver is entering an area where violations are enforced
37 by an automated traffic safety camera. The signs must be readily
38 visible to a driver approaching an automated traffic safety camera.
39 Signs placed in automated traffic safety camera locations after June
40 7, 2012, must follow the specifications and guidelines under the

1 manual of uniform traffic control devices for streets and highways as
2 adopted by the department of transportation under chapter 47.36 RCW.
3 All public transportation vehicles utilizing a vehicle-mounted system
4 must post a sign on the rear of the vehicle indicating to drivers
5 that the vehicle is equipped with an automated traffic safety camera
6 to enforce bus stop zone violations and public transportation only
7 lane violations.

8 (8) Automated traffic safety cameras may only record images of
9 the vehicle and vehicle license plate and only while an infraction is
10 occurring. The image must not reveal the face of the driver or of
11 passengers in the vehicle. The primary purpose of camera placement is
12 to record images of the vehicle and vehicle license plate when an
13 infraction is occurring. Cities and counties must consider installing
14 automated traffic safety cameras in a manner that minimizes the
15 impact of camera flash on drivers.

16 (9) A notice of infraction must be mailed to the registered owner
17 of the vehicle within 14 days of the violation, or to the renter of a
18 vehicle within 14 days of establishing the renter's name and address
19 under subsection (17) of this section. The notice of infraction must
20 include with it a certificate or facsimile thereof, based upon
21 inspection of photographs, microphotographs, or electronic images
22 produced by an automated traffic safety camera, stating the facts
23 supporting the notice of infraction. This certificate or facsimile is
24 prima facie evidence of the facts contained in it and is admissible
25 in a proceeding charging a violation under this chapter. The
26 photographs, microphotographs, or electronic images evidencing the
27 violation must be available for inspection and admission into
28 evidence in a proceeding to adjudicate the liability for the
29 infraction. A person receiving a notice of infraction based on
30 evidence detected by an automated traffic safety camera may respond
31 to the notice by mail.

32 (10) The registered owner of a vehicle is responsible for an
33 infraction under RCW 46.63.030(1)(d) unless the registered owner
34 overcomes the presumption in RCW 46.63.075, or, in the case of a
35 rental car business, satisfies the conditions under subsection (17)
36 of this section. If appropriate under the circumstances, a renter
37 identified under subsection (17)(a) of this section is responsible
38 for an infraction.

39 (11) Notwithstanding any other provision of law, all photographs,
40 microphotographs, or electronic images, or any other personally

1 identifying data prepared under this section are for the exclusive
2 use of authorized city or county employees, as specified in RCW
3 46.63.030(1)(d), in the discharge of duties under this section and
4 are not open to the public and may not be used in a court in a
5 pending action or proceeding unless the action or proceeding relates
6 to a violation under this section. No photograph, microphotograph, or
7 electronic image, or any other personally identifying data may be
8 used for any purpose other than enforcement of violations under this
9 section nor retained longer than necessary to enforce this section.
10 Transit authorities must provide to the appropriate local
11 jurisdiction that has authorized traffic safety camera use under RCW
12 46.63.260(~~(+2)~~) (3) any images or evidence collected establishing
13 that a violation of stopping, standing, or parking in a bus stop zone
14 or traveling, stopping, standing, or parking in a public
15 transportation only lane has occurred for infraction processing
16 purposes consistent with this section.

17 (12) If a county or city has established an automated traffic
18 safety camera program as authorized under this section, the
19 compensation paid to the manufacturer or vendor of the equipment used
20 must be based only upon the value of the equipment and services
21 provided or rendered in support of the system and may not be based
22 upon a portion of the fine or civil penalty imposed or the revenue
23 generated by the equipment. If the contract between the city or
24 county and manufacturer or vendor of the equipment does not provide
25 for performance or quality control measures regarding camera images,
26 the city or county must perform a performance audit of the
27 manufacturer or vendor of the equipment every three years to review
28 and ensure that images produced from automated traffic safety cameras
29 are sufficient for evidentiary purposes as described in subsection
30 (9) of this section.

31 (13)(a) Except as provided in (d) of this subsection, a county or
32 a city may only use revenue generated by an automated traffic safety
33 camera program as authorized under this section for:

34 (i) Traffic safety activities related to construction and
35 preservation projects and maintenance and operations purposes
36 including, but not limited to, projects designed to implement the
37 complete streets approach as defined in RCW 47.04.010, changes in
38 physical infrastructure to reduce speeds through road design, and
39 changes to improve safety for active transportation users, including

1 improvements to access and safety for road users with mobility,
2 sight, or other disabilities; and

3 (ii) The cost to administer, install, operate, and maintain the
4 automated traffic safety cameras, including the cost of processing
5 infractions.

6 (b) Except as provided in (d) of this subsection:

7 (i) The automated traffic safety camera program revenue used by a
8 county or city with a population of 10,000 or more for purposes
9 described in (a)(i) of this subsection must include the use of
10 revenue in census tracts of the city or county that have household
11 incomes in the lowest quartile determined by the most currently
12 available census data and areas that experience rates of injury
13 crashes that are above average for the city or county. Funding
14 contributed from traffic safety program revenue must be, at a
15 minimum, proportionate to the share of the population of the county
16 or city who are residents of these low-income communities and
17 communities experiencing high injury crash rates. This share must be
18 directed to investments that provide direct and meaningful traffic
19 safety benefits to these communities. Revenue used to administer,
20 install, operate, and maintain automated traffic safety cameras,
21 including the cost of processing infractions, are excluded from
22 determination of the proportionate share of revenues under this
23 subsection (13)(b); and

24 (ii) The automated traffic safety camera program revenue used by
25 a city or county with a population under 10,000 for traffic safety
26 activities under (a)(i) of this subsection must be informed by the
27 department of health's environmental health disparities map.

28 (c) Except as provided in (d) of this subsection, beginning four
29 years after an automated traffic safety camera authorized under this
30 section is initially placed and in use after June 6, 2024, 25 percent
31 of the noninterest money received for infractions issued by such
32 cameras in excess of the cost to administer, install, operate, and
33 maintain the cameras, including the cost of processing infractions,
34 must be deposited into the Cooper Jones active transportation safety
35 account created in RCW 46.68.480.

36 (d)(i)(A) Jurisdictions with an automated traffic safety camera
37 program in effect before January 1, 2024, may continue to allocate
38 revenue generated from automated traffic safety cameras authorized
39 under RCW 46.63.230 and 46.63.250(2)(c) as determined by the

1 jurisdiction, as well as for the purposes established in (a) through
2 (c) of this subsection, by:

3 (I) Up to a 10 percent increase in the number of traffic safety
4 camera locations authorized to detect violations for automated
5 traffic safety cameras authorized under RCW 46.63.230; and

6 (II) Up to a 10 percent increase in the number of traffic safety
7 camera locations authorized to detect violations for automated
8 traffic safety cameras authorized under RCW 46.63.250(2)(c).

9 (B)(I) Any automated traffic safety camera program in effect
10 before January 1, 2024, with fewer than 10 traffic safety camera
11 locations for automated traffic safety cameras authorized under RCW
12 46.63.230, which adds automated traffic safety cameras to one
13 additional location for the use of cameras authorized under RCW
14 46.63.230, may continue to allocate revenue generated from automated
15 traffic safety cameras authorized under RCW 46.63.230 as determined
16 by the jurisdiction, as well as for the purposes established in (a)
17 through (c) of this subsection.

18 (II) Any automated traffic safety camera program in effect before
19 January 1, 2024, with fewer than 10 traffic safety camera locations
20 for automated traffic safety cameras authorized under RCW
21 46.63.250(2)(c) as of January 1, 2024, which adds automated traffic
22 safety cameras to one additional location for the use of cameras
23 authorized under RCW 46.63.250(2)(c), may continue to allocate
24 revenue generated from automated traffic safety cameras authorized
25 under RCW 46.63.250(2)(c) as determined by the jurisdiction, as well
26 as for the purposes established in (a) through (c) of this
27 subsection.

28 (C) For the purposes of this subsection (13)(d)(i), a location
29 is:

30 (I) An intersection for automated traffic safety cameras
31 authorized under RCW 46.63.230 where cameras authorized under RCW
32 46.63.230 are in use; and

33 (II) A school speed zone for automated traffic safety cameras
34 authorized under RCW 46.63.250(2)(c) where cameras authorized under
35 RCW 46.63.250(2)(c) are in use.

36 (ii) The revenue distribution requirements under (a) through
37 (d)(i) of this subsection do not apply to automated traffic safety
38 camera programs in effect before January 1, 2024, for which an
39 ordinance in effect as of January 1, 2024, directs the manner in

1 which revenue generated from automated traffic safety cameras
2 authorized under RCW 46.63.230 or 46.63.250(2)(c) must be used.

3 (14) A county or city may adopt the use of an online ability-to-
4 pay calculator to process and grant requests for reduced fines or
5 reduced civil penalties for automated traffic safety camera
6 violations.

7 (15) Except as provided in this subsection, registered owners of
8 vehicles who receive notices of infraction for automated traffic
9 safety camera-enforced infractions and are recipients of public
10 assistance under Title 74 RCW or participants in the Washington
11 women, infants, and children program, and who request reduced
12 penalties for infractions detected through the use of automated
13 traffic safety camera violations, must be granted reduced penalty
14 amounts of 50 percent of what would otherwise be assessed for a first
15 automated traffic safety camera violation and for subsequent
16 automated traffic safety camera violations issued within 21 days of
17 issuance of the first automated traffic safety camera violation.
18 Eligibility for medicaid under RCW 74.09.510 is not a qualifying
19 criterion under this subsection. Registered owners of vehicles who
20 receive notices of infraction must be provided with information on
21 their eligibility and the opportunity to apply for a reduction in
22 penalty amounts through the mail or internet.

23 (16) Infractions detected through the use of automated traffic
24 safety cameras are not part of the registered owner's driving record
25 under RCW 46.52.101 and 46.52.120. Additionally, infractions
26 generated by the use of automated traffic safety cameras under this
27 section must be processed in the same manner as parking infractions,
28 including for the purposes of RCW 3.50.100, 35.20.220, 46.16A.120,
29 and 46.20.270(2). The amount of the fine issued for an infraction
30 generated through the use of an automated traffic safety camera may
31 not exceed \$145, as adjusted for inflation by the office of financial
32 management every five years, beginning January 1, 2029, based upon
33 changes in the consumer price index during that time period, but may
34 be doubled for a school speed zone infraction generated through the
35 use of an automated traffic safety camera.

36 (17) If the registered owner of the vehicle is a rental car
37 business, the issuing agency must, before a notice of infraction
38 being issued under this section, provide a written notice to the
39 rental car business that a notice of infraction may be issued to the
40 rental car business if the rental car business does not, within 18

1 days of receiving the written notice, provide to the issuing agency
2 by return mail:

3 (a) A statement under oath stating the name and known mailing
4 address of the individual driving or renting the vehicle when the
5 infraction occurred; or

6 (b) A statement under oath that the business is unable to
7 determine who was driving or renting the vehicle at the time the
8 infraction occurred because the vehicle was stolen at the time of the
9 infraction. A statement provided under this subsection must be
10 accompanied by a copy of a filed police report regarding the vehicle
11 theft; or

12 (c) In lieu of identifying the vehicle operator, the rental car
13 business may pay the applicable penalty. Timely mailing of this
14 statement to the issuing agency relieves a rental car business of any
15 liability under this chapter for the notice of infraction.

16 **Sec. 907.** RCW 46.63.260 and 2024 c 307 s 6 are each amended to
17 read as follows:

18 (1)(a) Subject to RCW 46.63.220 and as limited in this
19 subsection, automated traffic safety cameras may be used in cities
20 with populations of more than 500,000 residents to detect one or more
21 of the following violations:

- 22 (i) Stopping when traffic obstructed violations;
- 23 (ii) Stopping at intersection or crosswalk violations;
- 24 (iii) Public transportation only lane violations; or
- 25 (iv) Stopping or traveling in restricted lane violations.

26 (b) Use of automated traffic safety cameras as authorized in this
27 subsection (1) is restricted to the following locations only:
28 Intersections as described in RCW 46.63.230(2); railroad grade

4 freeways for up to four miles; and

5 (iv) Portions of roadway systems in the city connected to the
6 portions of the noninterstate freeways identified in (b)(iii) of this
7 subsection that are designated by the Washington state department of
8 transportation as arterial roadways for up to one mile from the
9 intersection of the arterial roadway and the noninterstate freeway.

10 (2) Subject to RCW 46.63.220, automated traffic safety cameras
11 may also be used in cities with a bus rapid transit corridor or
12 routes to detect public transportation only lane violations.

15 be used by a transit authority within a county with a population of
16 more than 1,500,000 residents to detect stopping, standing, or

24 (5) A transit authority may not take disciplinary action
25 regarding a warning or infraction issued pursuant to subsections (1)
26 through (3) of this section against an employee who was operating a
27 public transportation vehicle at the time the violation that was the
28 basis of the warning or infraction was detected.

29 **PART X: PUBLIC TRANSPORTATION BENEFIT AREAS**

30 NEW SECTION. **Sec. 1001.** A new section is added to chapter
31 36.57A RCW to read as follows:

32 (1) A public transportation benefit area authority as provided in
33 subsection (2) of this section may, pursuant to an interlocal
34 agreement, annex an adjacent city operating a transit system under
35 chapter 35.95 RCW within the county in which the public
36 transportation benefit area is located. This method of annexation is
37 an alternative method and is additional to all other methods provided
38 for in this chapter.

1 (2) An authority and the governing body of an adjacent city
2 described in subsection (1) of this section may jointly initiate an
3 annexation process for annexing the city into the public
4 transportation benefit area by adopting an interlocal agreement as
5 provided in chapter 39.34 RCW and under this subsection between the
6 authority and the city. The authority and the city shall jointly
7 agree on the annexation and its effective date. The interlocal
8 agreement must set a date for a public hearing on the agreement for
9 annexation.

10 (3) A public hearing must be held by each governing body,
11 separately or jointly, before the agreement is executed. Each
12 governing body holding a public hearing shall:

13 (a) Separately or jointly, publish a notice of availability of
14 the agreement at least once a week for four weeks before the date of
15 the hearing in one or more newspapers of general circulation within
16 the public transportation benefit area and one or more newspapers of
17 general circulation within the city; and

18 (b) If the governing body has the ability to do so, post the
19 notice of availability of the agreement on its website for the same
20 four weeks that the notice is published in the newspapers under (a)
21 of this subsection. The notice must describe where the public may
22 review the agreement.

23 (4) On the date set for hearing, the public must be afforded an
24 opportunity to be heard. Following the hearing, if the governing body
25 determines to undertake the annexation, it must do so by ordinance,
26 if a city's governing body, and by resolution, if a public
27 transportation benefit area's governing body. Upon the effective date
28 of the annexation the city annexed must become part of the public
29 transportation benefit area and must cease operating a transit system

28 their authority under the Ports and Waterways Safety Act of 1972; the
29 expenses of the board; updates on efforts to increase diversity of
30 pilots, trainees, and applicants; and any and all other information
31 which the board deems appropriate to include;

32 (g) Make available information that includes the pilotage act and
33 other statutes of Washington state and the federal government that
34 affect pilotage, including the rules of the board, together with such
35 additional information as may be informative for pilots, agents,
36 owners, operators, and masters;

37 (h) Appoint advisory committees and employ marine experts as
38 necessary to carry out its duties under this chapter;

39 (i) Provide for the maintenance of efficient and competent
40 pilotage service on all waters covered by this chapter; and do such

1 other things as are reasonable, necessary, and expedient to insure
2 proper and safe pilotage upon the waters covered by this chapter and
3 facilitate the efficient administration of this chapter.

4 (2) The board may pay stipends to pilot trainees under subsection
5 (1)(b) of this section.

6 **Marine Pilotage Exemptions**

7 **Sec. 1102.** RCW 88.16.180 and 1991 c 200 s 602 are each amended
8 to read as follows:

9 (~~Notwithstanding the provisions of RCW 88.16.070~~) Except as
10 otherwise provided in RCW 88.16.070(3), any registered oil tanker of
11 five thousand gross tons or greater, shall be required:

12 (1) To take a Washington state licensed pilot while navigating
13 Puget Sound and adjacent waters and shall be liable for and pay
14 pilotage rates pursuant to RCW 88.16.035; and

15 (2) To take a licensed pilot while navigating the Columbia river.

16 **Sec. 1103.** RCW 88.16.070 and 2018 c 107 s 4 are each amended to
17 read as follows:

18 Every vessel not exempt under this section that operates in the
19 waters of the Puget Sound pilotage district or Grays Harbor pilotage
20 district is subject to compulsory pilotage under this chapter.

21 (1) A United States vessel on a voyage in which it is operating
22 exclusively on its coastwise endorsement, its fishery endorsement
23 (including catching and processing its own catch outside United
24 States waters and economic zone for delivery in the United States),
25 and/or its recreational (or pleasure) endorsement, and all United
26 States and Canadian vessels engaged exclusively in the coasting trade
27 on the west coast of the continental United States (including Alaska)
28 and/or British Columbia shall be exempt from the provisions of this
29 chapter unless a pilot licensed under this chapter be actually

16 The board shall annually, or at any other time when in the public
17 interest, review any exemptions granted to this specified class of
18 small vessels to insure that each exempted vessel remains in
19 compliance with the original exemption. The board shall have the
20 authority to revoke such exemption where there is not continued
21 compliance with the requirements for exemption. The board shall
22 maintain a file which shall include all petitions for exemption, a
23 roster of vessels granted exemption, and the board's written
24 decisions which shall set forth the findings for grants of exemption.
25 Each applicant for exemption or annual renewal shall pay a fee,
26 payable to the pilotage account. Fees for initial applications and
27 for renewals shall be established by rule, and shall not exceed (~~one~~
28 ~~thousand five hundred dollars~~) \$1,500. The board shall report
29 annually to the legislature on such exemptions.

30 (3) Every vessel not exempt under subsection (1) or (2) of this
31 section shall, while navigating the Puget Sound and Grays Harbor
32 pilotage districts, employ a pilot licensed under the provisions of
33 this chapter and shall be liable for and pay pilotage rates in
34 accordance with the pilotage rates herein established or which may
35 hereafter be established under the provisions of this chapter or
36 under RCW 81.116.010 through 81.116.060: PROVIDED, That any vessel
37 inbound to or outbound from Canadian ports is exempt from the
38 provisions of this section, if said vessel actually employs a pilot
39 licensed by the Pacific pilotage authority (the pilot licensing
40 authority for the western district of Canada), and if it is

1 communicating with the vessel traffic system and has appropriate
2 navigational charts, and if said vessel uses only those Washington
3 waters east of the international boundary line which are west of a
4 line which begins at the southwestern edge of Point Roberts then to
5 Alden Point (Patos Island), then to Skipjack Island light, then to
6 Turn Point (Stuart Island), then to Kellet Bluff (Henry Island), then
7 to Lime Kiln (San Juan Island) then to the intersection of (~~one~~
8 ~~hundred twenty-three~~) 123 degrees seven minutes west longitude and
9 (~~forty-eight~~) 48 degrees (~~twenty-five~~) 25 minutes north latitude
10 then to the international boundary. The board shall correspond with
11 the Pacific pilotage authority from time to time to ensure the
12 provisions of this section are enforced. If any exempted vessel does
13 not comply with these provisions it shall be deemed to be in
14 violation of this section and subject to the penalties provided in
15 RCW 88.16.150 as now or hereafter amended and liable to pilotage fees
16 as determined by the board. The board shall investigate any accident
17 on the waters covered by this chapter involving a Canadian pilot and
18 shall include the results in its annual report.

19 **PART XII: PUBLIC-PRIVATE PARTNERSHIP PROJECTS**

20 NEW SECTION. **Sec. 1201.** (1) The legislature finds that a full
21 set of project procurement, contracting, financing, and funding tools
22 are needed to enable the delivery of transportation projects in a
23 manner most advantageous to the public. Current public-private
24 partnership laws have failed to spur innovative proposals from the
25 private sector or new project delivery approaches from the department
26 of transportation.

27 (2) The legislature confirms the findings from previous studies
28 that current laws and administrative processes are the primary
29 obstacle impairing the state's ability to utilize public-private
30 partnerships. The legislature finds that a new public-private
31 partnership law is needed to:

32 (a) Transparently demonstrate and deliver better value for the
33 public including, but not limited to, expedited project delivery and
34 more effective management of project life-cycle costs;

35 (b) Provide an additional option for delivering complex
36 transportation projects, including addressing a shortage of truck
37 parking;

1 (c) Incorporate private sector expertise and innovation into
2 transportation project delivery;

3 (d) Allocate project risks to the parties best able to manage
4 those risks;

5 (e) Allow new sources of private capital;

6 (f) Increase access to federal funding and financing mechanisms;

7 (g) Better align private sector incentives with public
8 priorities; and

9 (h) Provide consistency in the review and approval processes for
10 the full range of project delivery tools and contracting methods.

11 NEW SECTION. **Sec. 1202.** DEFINITIONS. The definitions in this
12 section apply throughout this chapter unless the context clearly
13 requires otherwise.

14 (1) "Commission" means the transportation commission.

15 (2) "Department" means the department of transportation.

16 (3) "Eligible transportation project" means any project that is
17 not a rail project and meets the criteria to be evaluated for
18 delivery in section 1206 of this act, whether capital or operating,
19 where the state's purpose for the project is to preserve or
20 facilitate the safe transport of people or goods via any mode of
21 travel.

22 (4) "Private sector partner" and "private partner" means a
23 person, entity, or organization that is not the federal government, a
24 state, or a political subdivision of a state.

25 (5) "Public funds" means all moneys derived from taxes, fees,
26 charges, tolls, or other levies of money from the public.

27 (6) "Public sector partner" and "public partner" means any
28 federal or state unit of government, bistate transportation
29 organization, or any other political subdivision of any state.

30 (7) "State finance committee" means the entity created in chapter
31 43.33 RCW.

32 (8) "Unit of government" means any department or agency of the
33 federal government, any state or agency, office, or department of a
34 state, any city, county, district, commission, authority, entity,
35 port, or other public corporation organized and existing under
36 statutory law or under a voter-approved charter or initiative, and
37 any intergovernmental entity created under chapter 39.34 RCW or this
38 chapter.

1 (2) During its rule-making activities, the department must
2 consult with the department's office of equity and civil rights.

3 (3) By September 1, 2026, the department must provide a report to
4 the house of representatives and senate transportation committees on
5 proposed policies and guidelines it intends to develop into
6 administrative rules. Rules adopted by the department pursuant to
7 this chapter may not take effect before January 1, 2027.

8 NEW SECTION. **Sec. 1204.** APPLICABILITY OF OTHER TRANSPORTATION
9 PROJECT GOVERNING PROVISIONS. (1) For any eligible transportation
10 project that requires the imposition of tolls on a state facility,
11 the legislature must approve the imposition of such tolls consistent
12 with RCW 47.56.820.

13 (2) For any eligible transportation project that requires setting
14 or adjusting toll rates on a state facility, the commission has sole
15 responsibility consistent with RCW 47.56.850.

16 (3) (a) If federal funds are provided for an eligible
17 transportation project developed under this chapter, disadvantaged
18 business enterprise inclusion requirements, as established,
19 monitored, and administered by the department's office of equity and
20 civil rights, apply.

21 (b) If no federal funds are provided for an eligible
22 transportation project developed under this chapter, state laws,
23 rates, and rules must govern, including the public works small
24 business certification program pursuant to RCW 39.19.030(7) as
25 monitored and administered by the department's office of equity and
26 civil rights.

27 NEW SECTION. **Sec. 1205.** APPLICATION OF PUBLIC WORKS PROVISIONS.
28 All other transportation and public works project procurement and
29 contracting governing provisions and procedures that do not conflict
30 with this chapter, including responsible bidder and apprenticeship
31 requirements under chapter 39.04 RCW and prevailing wage requirements
32 under chapter 39.12 RCW, apply to the entire eligible transportation
33 project.

34 NEW SECTION. **Sec. 1206.** PROJECT COST THRESHOLD FOR P3
35 EVALUATION. Any eligible transportation project with an estimated
36 cost to the state of less than \$500,000,000, or any project on a
37 United States route that is not an interstate route and includes

1 replacement of a seismically vulnerable elevated structure at least
2 one and one-half miles long that crosses a river, may be evaluated
3 for delivery under a public-private partnership model as prescribed
4 under this chapter.

5 NEW SECTION. **Sec. 1207.** ELIGIBLE FINANCING. (1) Subject to the
6 limitations in this section, the department may, in connection with
7 the evaluation of eligible transportation projects, consider any
8 financing mechanisms from any lawful source, either integrated as
9 part of a project proposal or as a separate, stand-alone proposal to
10 finance a project. Financing may be considered for all or part of a
11 proposed project. A project may be financed in whole or in part with:

12 (a) The proceeds of grant anticipation revenue bonds authorized
13 under 23 U.S.C. Sec. 122 and applicable state law. Legislative
14 authorization and appropriation are required to use this source of
15 financing;

16 (b) Grants, loans, loan guarantees, lines of credit, revolving
17 lines of credit, or other financing arrangements available under the
18 transportation infrastructure finance and innovation act under 23
19 U.S.C. Sec. 181 et seq., or any other applicable federal law, subject
20 to legislative authorization and appropriation as required;

21 (c) Infrastructure loans or assistance from the state
22 infrastructure bank established under RCW 82.44.195, subject to
23 legislative authorization and appropriation as required;

24 (d) Federal, state, or local revenues, subject to appropriation
25 by the applicable legislative authority;

26 (e) User fees, tolls, fares, lease proceeds, rents, gross or net
27 receipts from sales, proceeds from the sale of development rights,
28 franchise fees, or any other lawful form of consideration. However,
29 projects financed by tolls must first be authorized by the
30 legislature under RCW 47.56.820;

31 (f) Loans, pledges, or contributions of funds, including equity
32 investments, from private entities;

33 (g) Revenue bonds, subject to legislative authorization and
34 appropriation as required.

35 (2) Subject to subsection (4) of this section, the department may
36 develop a plan of finance that would require either the state or a
37 private partner, or both, to: Issue debt, equity, or other securities
38 or obligations; enter into contracts, leases, concessions, and grant
39 and loan agreements; or secure any financing with a pledge of funds

1 to be appropriated by the legislature or with a lien or exchange of
2 real property.

3 (3) As security for the payment of any financing, the revenues
4 from the project may be pledged, but no such pledge of revenues
5 constitutes in any manner or to any extent a general obligation of
6 the state, unless specifically authorized by the legislature. Any
7 financing described in this section may be structured on a senior,
8 parity, or subordinate basis to any other financing.

9 (4) The department shall not execute any agreement with respect
10 to an eligible transportation project, including any agreement that
11 could materially impact the state's debt capacity or credit rating as
12 determined by the state finance committee, without prior review and
13 approval of the plan of finance and proposed financing terms by the
14 state finance committee.

15 NEW SECTION. **Sec. 1208.** USE OF FEDERAL FUNDS OR OTHER SOURCES.

16 (1) The department may accept from the United States or any of its
17 agencies such funds as are available to this state or to any other
18 unit of government for carrying out the purposes of this chapter,
19 whether the funds are made available by grant, loan, or other
20 financing arrangement. The department may enter into such agreements
21 and other arrangements with the United States or any of its agencies
22 as may be necessary, proper, and convenient for carrying out the
23 purposes of this chapter, subject to subsection (2) of this section.

24 (2)(a) The department may accept from any source any grant,
25 donation, gift, or other form of conveyance of land, money, other
26 real or personal property, or other valuable thing made to the state
27 of Washington, the department, or a local government for carrying out
28 the purposes of this chapter.

29 (b) Any eligible transportation project may be financed in whole
30 or in part by contribution of any funds or property made by any
31 private entity or public sector partner that is a party to any
32 agreement entered into under this chapter.

33 NEW SECTION. **Sec. 1209.** PUBLIC INTEREST FINDING. (1) The
34 department may evaluate eligible transportation projects that are
35 already programmed for other delivery methods to determine their
36 appropriateness for delivery under a public-private partnership
37 model.

1 (2) Before entering into a formal solicitation or procurement to
2 develop a project as a public-private partnership, the department
3 must make formal findings that utilizing a public-private partnership
4 delivery method is in the public's interest. The department must
5 adopt rules detailing the process and criteria for making such
6 findings. At a minimum, the criteria must consider whether:

7 (a) Public ownership of the asset can be retained;

8 (b) Transparency during the consideration of a public-private
9 partnership agreement can be provided;

10 (c) Public oversight of the private entity's management of the
11 asset can be provided; and

12 (d) Additional criteria that reflects the legislative findings in
13 section 1201 of this act.

14 (3) Before commencing any solicitation to deliver the project as
15 a public-private partnership, the department must provide an
16 opportunity for public comment on the proposed project and delivery
17 method.

18 (4) Upon a finding of public interest pursuant to subsection (2)
19 of this section, the department must provide written notification of
20 their finding of public interest and intent to deliver the project as
21 a public-private partnership to the general public, to the chairs and
22 ranking members of the transportation committees of the legislature,
23 and to the governor.

24 (5) Upon a finding of public interest pursuant to subsection (2)
25 of this section, the department may:

26 (a) Solicit concepts or proposals for the identified public-
27 private partnership project from private entities and units of
28 government;

29 (b) Evaluate the concepts or proposals received under this
30 section. The evaluation under this subsection must include
31 consultation with any appropriate unit of government; and

32 (c) Select potential projects based on the concepts or proposals.

33 NEW SECTION. **Sec. 1210.** USE OF FUNDS FOR PROPOSAL PURPOSES. (1)
34 Subject to the availability of amounts appropriated for this specific
35 purpose, the department may spend such moneys as may be necessary for
36 stipends for respondents to a solicitation, the evaluation of
37 concepts or proposals for eligible transportation projects, and for
38 negotiating agreements for eligible transportation projects
39 authorized under this chapter. Expenses incurred by the department

1 under this section before the issuance of transportation project
2 bonds or other financing must be paid by the department and charged
3 to the appropriate project. The department must keep records and
4 accounts showing each charged amount.

5 (2) Unless otherwise provided in the omnibus transportation
6 appropriations act, the funds spent by the department under this
7 section in connection with the project must be repaid from the
8 proceeds of the bonds or other financing upon the sale of
9 transportation project bonds or upon obtaining other financing for an
10 eligible transportation project, as allowed by law or contract.

11 NEW SECTION. **Sec. 1211.** EXPERT CONSULTATION. The department may
12 consult with legal, financial, technical, and other experts in the
13 public and private sector in the evaluation, negotiation, and
14 development of projects under this chapter.

15 NEW SECTION. **Sec. 1212.** CONTRACTED STUDIES. In the absence of
16 any direct federal funding or direction, the department may contract
17 with a private developer of a selected project proposal to conduct
18 environmental impact studies and engineering and technical studies.

19 NEW SECTION. **Sec. 1213.** PARTNERSHIP AGREEMENTS. (1) The
20 following provisions must be included in any transportation project
21 agreement entered into under the authority of this chapter and to
22 which the state is a party:

23 (a) For any project that proposes terms for stand alone
24 maintenance or asset management services for a public facility, those
25 services must be provided in a manner consistent with any collective
26 bargaining agreements, chapter 41.80 RCW, and civil service laws that
27 are in effect for the public facility;

28 (b) A finding of public interest, as issued by the department
29 pursuant to section 1209 of this act;

30 (c) If there is a tolling component to the project, it must be
31 specified that the tolling technology used in the project must be
32 consistent with tolling technology standards adopted by the
33 department for transportation-related projects;

34 (d) Provisions for bonding, financial guarantees, deposits, or
35 the posting of other security to secure the payment of laborers,
36 subcontractors, and suppliers who perform work or provide materials
37 as part of the project;

1 (e) All projects must be financed in a manner consistent with
2 section 1207 of this act.

3 (2) At a minimum, agreements between the state and private sector
4 partners entered into under this section must specifically include
5 the following contractual elements:

6 (a) The point in the project at which public and private sector
7 partners will enter the project and which partners will assume
8 responsibility for specific project elements;

9 (b) How the partners will share management of the risks of the
10 project;

11 (c) The compensation method and amount for the private partner,
12 establishing a maximum rate of return, and identifying how project
13 revenue, if any, in excess of the maximum rate of return will be
14 distributed;

15 (d) How the partners will share the costs of development of the
16 project;

17 (e) How the partners will allocate financial responsibility for
18 cost overruns;

19 (f) The penalties for nonperformance;

20 (g) The incentives for performance;

21 (h) The accounting and auditing standards to be used to evaluate
22 work on the project;

23 (i) For any project that reverts to public ownership, the
24 responsibility for reconstruction or renovations that are required
25 for a facility to meet all service standards and state of good repair
26 upon reversion of the facility to the state;

27 (j) Provisions and remedies for default by either party, and
28 provisions for termination of the agreement for or without cause;

29 (k) Provisions for public communication and participation with
30 respect to the development of the project.

31 NEW SECTION. **Sec. 1214.** BEST VALUE FINDING AND AGREEMENT
32 EXECUTION. Before executing an agreement under section 1213 of this
33 act, the department must make a formal finding that the negotiated
34 partnership agreement is expected to result in best value for the
35 public, and the agreement must be approved through duly enacted
36 legislation. The department must develop and adopt a process and
37 criteria for measuring, determining, and transparently reporting best
38 value relevant to the proposed project. At minimum, the criteria must
39 include:

1 (1) A comparison of the total cost to deliver the project,
2 including any operations and maintenance costs, as a public-private
3 partnership compared to traditional or other alternative delivery
4 methods available to the department;

5 (2) A comparison with the department's current plan, resources,
6 delivery capacity, and schedule to complete the project that
7 documents the advantages of completing the project as a public-
8 private partnership versus solely as a public venture; and

9 (3) Factors such as, but not limited to: Priority, cost, risk
10 sharing, scheduling, asset and service quality, innovation, and
11 management conditions.

12 NEW SECTION. **Sec. 1215.** CONFIDENTIALITY. A proposer must
13 identify those portions of a proposal that the proposer considers to
14 be confidential, proprietary information, or trade secrets and
15 provide any justification as to why these materials, upon request,
16 should not be disclosed by the department. Patent information will be
17 covered until the patent expires. Other information, such as
18 originality of design or records of negotiation, is protected under
19 this section only until an agreement under section 1214 of this act
20 is reached. Eligible transportation projects under federal
21 jurisdiction or using federal funds must conform to federal
22 regulations under the freedom of information act.

23 NEW SECTION. **Sec. 1216.** GOVERNMENT AGREEMENTS. The state may,
24 either separately or in combination with any other public sector
25 partner, enter into working agreements, coordination agreements, or
26 similar implementation agreements, including the formation of bistate
27 transportation organizations, to carry out the joint implementation
28 and operation of an eligible transportation project selected under
29 this chapter. The state may enter into agreements with other units of
30 government or Canadian provinces for transborder transportation
31 projects.

32 NEW SECTION. **Sec. 1217.** EMINENT DOMAIN. The state may exercise
33 the power of eminent domain to acquire property, easements, or other
34 rights or interests in property for projects that are necessary to
35 implement an eligible transportation project developed under this
36 chapter. Any property acquired pursuant to this section must be owned
37 in fee simple by the state.

1 NEW SECTION. **Sec. 1218.** FEDERAL LAWS. Applicable federal laws,
2 rules, and regulations govern in any situation that involves federal
3 funds if the federal laws, rules, or regulations:

4 (1) Conflict with any provision of this chapter;

5 (2) Require procedures that are additional to or inconsistent
6 with those provided in this chapter; or

7 (3) Require contract provisions not authorized in this chapter.

8 NEW SECTION. **Sec. 1219.** PUBLIC-PRIVATE PARTNERSHIPS ACCOUNT.

9 (1) The public-private partnerships account is created in the custody
10 of the state treasurer.

11 (2) The following moneys must be deposited into the account:

12 (a) Proceeds from bonds or other financing instruments;

13 (b) Revenues received from any transportation project developed
14 under this chapter or developed under the general powers granted to
15 the department; and

16 (c) Any other moneys that are by donation, grant, contract, law,
17 or other means transferred, allocated, or appropriated to the
18 account.

19 (3) Expenditures from the account may be used only for the
20 planning, acquisition, financing, development, design, construction,
21 reconstruction, replacement, improvement, maintenance, preservation,
22 management, repair, or operation of any eligible transportation
23 project under this chapter.

24 (4) The state treasurer may establish separate subaccounts within
25 the public-private partnerships account for each transportation
26 project that is initiated under this chapter or under the general
27 powers granted to the department. The state may pledge moneys in the
28 public-private partnerships account to secure revenue bonds or any
29 other debt obligations relating to the project for which the account
30 is established.

31 (5) Only the secretary or the secretary's designee may authorize
32 distributions from the account. The account is subject to the
33 allotment procedures under chapter 43.88 RCW, but an appropriation is
34 not required for expenditures.

35 **Sec. 1220.** RCW 47.56.030 and 2023 c 429 s 6 are each amended to
36 read as follows:

37 (1) Except as permitted under chapter (~~47.29~~) 47.--- RCW (the
38 new chapter created in section 1224 of this act) or 47.46 RCW:

1 (a) Unless otherwise delegated, and subject to RCW 47.56.820, the
2 department of transportation shall have full charge of the planning,
3 analysis, and construction of all toll bridges and other toll
4 facilities including the Washington state ferries, and the operation
5 and maintenance thereof.

6 (b) The transportation commission shall determine and establish
7 the tolls and charges thereon.

8 (c) Unless otherwise delegated, and subject to RCW 47.56.820, the
9 department shall have full charge of planning, analysis, and design
10 of all toll facilities. The department may conduct the planning,
11 analysis, and design of toll facilities as necessary to support the
12 legislature's consideration of toll authorization.

13 (d) The department shall utilize and administer toll collection
14 systems that are simple, unified, and interoperable. To the extent
15 practicable, the department shall avoid the use of toll booths. The
16 department shall set the statewide standards and protocols for all
17 toll facilities within the state, including those authorized by local
18 authorities.

19 (e) Except as provided in this section, the department shall
20 proceed with the construction of such toll bridges and other
21 facilities and the approaches thereto by contract in the manner of
22 state highway construction immediately upon there being made
23 available funds for such work and shall prosecute such work to
24 completion as rapidly as practicable. The department is authorized to
25 negotiate contracts for any amount without bid under (e) (i) and (ii)
26 of this subsection:

27 (i) Emergency contracts, in order to make repairs to ferries or
28 ferry terminal facilities or removal of such facilities whenever
29 continued use of ferries or ferry terminal facilities constitutes a
30 real or immediate danger to the traveling public or precludes prudent
31 use of such ferries or facilities; and

32 (ii) Single source contracts for vessel dry dockings, when there
33 is clearly and legitimately only one available bidder to conduct dry
34 dock-related work for a specific class or classes of vessels. The
35 contracts may be entered into for a single vessel dry docking or for
36 multiple vessel dry dockings for a period not to exceed two years.

37 (f) Any new vessel planning, construction, purchase, analysis, or
38 design work must be consistent with RCW 47.60.810, except as
39 otherwise provided in RCW 47.60.826.

1 (2) The department shall proceed with the procurement of
2 materials, supplies, services, and equipment needed for the support,
3 maintenance, and use of a ferry, ferry terminal, or other facility
4 operated by Washington state ferries, in accordance with chapter
5 43.19 RCW except as follows:

6 (a) When the secretary of the department of transportation
7 determines in writing that the use of invitation for bid is either
8 not practicable or not advantageous to the state and it may be
9 necessary to make competitive evaluations, including technical or
10 performance evaluations among acceptable proposals to complete the
11 contract award, a contract may be entered into by use of a
12 competitive sealed proposals method, and a formal request for
13 proposals solicitation. Such formal request for proposals
14 solicitation shall include a functional description of the needs and
15 requirements of the state and the significant factors.

16 (b) When purchases are made through a formal request for
17 proposals solicitation the contract shall be awarded to the
18 responsible proposer whose competitive sealed proposal is determined
19 in writing to be the most advantageous to the state taking into
20 consideration price and other evaluation factors set forth in the
21 request for proposals. No significant factors may be used in
22 evaluating a proposal that are not specified in the request for
23 proposals. Factors that may be considered in evaluating proposals
24 include but are not limited to: Price; maintainability; reliability;
25 commonality; performance levels; life-cycle cost if applicable under
26 this section; cost of transportation or delivery; delivery schedule
27 offered; installation cost; cost of spare parts; availability of
28 parts and service offered; and the following:

29 (i) The ability, capacity, and skill of the proposer to perform
30 the contract or provide the service required;

31 (ii) The character, integrity, reputation, judgment, experience,
32 and efficiency of the proposer;

33 (iii) Whether the proposer can perform the contract within the
34 time specified;

35 (iv) The quality of performance of previous contracts or
36 services;

37 (v) The previous and existing compliance by the proposer with
38 laws relating to the contract or services;

39 (vi) Objective, measurable criteria defined in the request for
40 proposal. These criteria may include but are not limited to items

1 such as discounts, delivery costs, maintenance services costs,
2 installation costs, and transportation costs; and

3 (vii) Such other information as may be secured having a bearing
4 on the decision to award the contract.

5 (c) When purchases are made through a request for proposal
6 process, proposals received shall be evaluated based on the
7 evaluation factors set forth in the request for proposal. When
8 issuing a request for proposal for the procurement of propulsion
9 equipment or systems that include an engine, the request for proposal
10 must specify the use of a life-cycle cost analysis that includes an
11 evaluation of fuel efficiency. When a life-cycle cost analysis is
12 used, the life-cycle cost of a proposal shall be given at least the
13 same relative importance as the initial price element specified in
14 the request of proposal documents. The department may reject any and
15 all proposals received. If the proposals are not rejected, the award
16 shall be made to the proposer whose proposal is most advantageous to

15 center is denied certification, the local jurisdiction may appeal the

24 management of any railroad shall, outside of any corporate city or
25 town, and outside the limits of any sidetrack or switch, cause to be
26 constructed and maintained in good repair on each side of said
27 railroad, along the line of said right-of-way of such person,
28 company, or corporation operating the same, a substantial fence, and
29 at every point where any roadway or other public highway shall cross
30 said railroad, a safe and sufficient crossing must be built and
31 maintained, and on each side of such crossing and at each end of such
32 sidetrack or switch, outside of any incorporated city or town, a
33 sufficient cattle guard: PROVIDED, That any person holding land on
34 both sides of said right-of-way shall have the right to put in gates
35 for his or her own use at such places as may be convenient. This

1 section does not apply to rail right-of-way owned by the department
2 of transportation.

3 **Temporary License Plates**

4 **Sec. 1302.** RCW 46.16A.305 and 2022 c 132 s 5 are each amended to
5 read as follows:

6 (1) The department, county auditor or other agent, or subagent
7 appointed by the director may grant a temporary license plate to
8 operate a vehicle for which an application for registration has been
9 made. The application for a temporary license plate must be made by
10 the owner or the owner's representative to the department, county

12 form furnished by the department and must contain:

13 (a) A full description of the vehicle, including its make, model,

19 (a) Be consecutively numbered;

20 (b) Be displayed as described for permanent license plates in RCW

23 unaltered in field conditions for a minimum of four months; and

24 (d) Remain on the vehicle only until the receipt of permanent
25 license plates.

26 (3) The application must be accompanied by the fee required under
27 RCW 46.17.400(1)(b).

28 (4) Pursuant to subsection (2) of this section, the department
29 may adopt rules for the design and display of temporary license
30 plates.

31 (5) By December 1, 2025, the department must adopt rules
32 implementing contingency extensions of the expiration date for
33 department temporary license plates in cases of shortages of
34 permanent license plates. The rules must prioritize reducing customer
35 return trips for department temporary license plates, and include a
36 communication plan with state and local law enforcement agencies
37 regarding the implementation of the contingency extensions.

3 (2) The city or town shall exercise full responsibility for and
4 control over any such street beyond the curbs and if no curb is

23 the surface of any such street, but all damage occasioned thereby
24 shall promptly be repaired either by the city or town itself or at
25 its direction. Pavement trenching and restoration performed under a
26 privilege granted by the city under this subsection must meet or
27 exceed requirements established by the department;

28 (6) Except as otherwise provided in subsection (17) of this
29 section, the city or town at its own expense shall provide street
30 illumination and shall clean all such streets, including storm sewer
31 inlets and catch basins, and remove all snow, except that the state
32 shall when necessary plow the snow on the roadway. In cities and
33 towns having a population of (~~twenty-seven thousand five hundred~~)
34 27,500 or less according to the latest determination of population by
35 the office of financial management, the state, when necessary for
36 public safety, shall assume, at its expense, responsibility for the
37 stability of the slopes of cuts and fills and the embankments within
38 the right-of-way to protect the roadway itself. When the population
39 of a city or town first exceeds (~~twenty-seven thousand five~~
40 ~~hundred~~) 27,500 according to the determination of population by the

1 office of financial management, the city or town shall have three
2 years from the date of the determination to plan for additional
3 staffing, budgetary, and equipment requirements before being required
4 to assume the responsibilities under this subsection. The state shall
5 install, maintain, and operate all illuminating facilities on any
6 limited access facility, together with its interchanges, located
7 within the corporate limits of any city or town, and shall assume and
8 pay the costs of all such installation, maintenance, and operation
9 incurred after November 1, 1954;

10 (7) The department has the right to use all storm sewers on such
11 highways without cost; and if new storm sewer facilities are
12 necessary in construction of new streets by the department, the cost
13 of the facilities shall be borne by the state and/or city as may be
14 mutually agreed upon between the department and the governing body of
15 the city or town;

16 (8) Cities and towns have exclusive right to grant franchises not
17 in conflict with state laws and rules, over, beneath, and upon such
18 streets, but the department is authorized to enforce in an action
19 brought in the name of the state any condition of any franchise which
20 a city or town has granted on such street. No franchise for
21 transportation of passengers in motor vehicles may be granted on such
22 streets without the approval of the department, but the department
23 shall not refuse to approve such franchise unless another street
24 conveniently located and of strength of construction to sustain
25 travel of such vehicles is accessible;

26 (9) Every franchise or permit granted any person by a city or
27 town for use of any portion of such street by a public utility must
28 require the grantee or permittee to restore, repair, and replace any
29 portion of the street damaged or injured by it to conditions that
30 meet or exceed requirements established by the department;

31 (10) The city or town has the right to issue overload or
32 overwidth permits for vehicles to operate on such streets or roads
33 subject to regulations printed and distributed to the cities and
34 towns by the department;

35 (11) Cities and towns shall regulate and enforce all traffic and
36 parking restrictions on such streets, but all regulations adopted by
37 a city or town relating to speed, parking, and traffic control
38 devices on such streets not identical to state law relating thereto
39 are subject to the approval of the department before becoming
40 effective. All regulations pertaining to speed, parking, and traffic

1 control devices relating to such streets heretofore adopted by a city
2 or town not identical with state laws shall become null and void
3 unless approved by the department heretofore or within one year after
4 March 21, 1963;

5 (12) The department shall erect, control, and maintain at state
6 expense all route markers and directional signs, except street signs,
7 on such streets;

8 (13) Except as otherwise provided in subsection (17) of this
9 section, the department shall install, operate, maintain, and control
10 at state expense all traffic control signals, signs, and traffic
11 control devices for the purpose of regulating both pedestrian and
12 motor vehicular traffic on, entering upon, or leaving state highways
13 in cities and towns having a population of (~~twenty-seven thousand~~
14 ~~five hundred~~) 27,500 or less according to the latest determination
15 of population by the office of financial management. Such cities and
16 towns may submit to the department a plan for traffic control
17 signals, signs, and traffic control devices desired by them,
18 indicating the location, nature of installation, or type thereof, or
19 a proposed amendment to such an existing plan or installation, and
20 the department shall consult with the cities or towns concerning the
21 plan before installing such signals, signs, or devices. Cities and
22 towns having a population in excess of (~~twenty-seven thousand five~~
23 ~~hundred~~) 27,500 according to the latest determination of population
24 by the office of financial management shall install, maintain,
25 operate, and control such signals, signs, and devices at their own
26 expense, subject to approval of the department for the installation
27 and type only. When the population of a city or town first exceeds
28 (~~twenty-seven thousand five hundred~~) 27,500 according to the
29 determination of population by the office of financial management,
30 the city or town shall have three years from the date of the
31 determination to plan for additional staffing, budgetary, and
32 equipment requirements before being required to assume the
33 responsibilities under this subsection. For the purpose of this
34 subsection, striping, lane marking, and channelization are considered
35 traffic control devices;

36 (14) All revenue from parking meters placed on such streets
37 belongs to the city or town;

38 (15) Rights-of-way for such streets shall be acquired by either
39 the city or town or by the state as shall be mutually agreed upon.
40 Costs of acquiring rights-of-way may be at the sole expense of the

1 state or at the expense of the city or town or at the expense of the
2 state and the city or town as may be mutually agreed upon. Title to
3 all such rights-of-way so acquired shall vest in the city or town:
4 PROVIDED, That no vacation, sale, rental, or any other
5 nontransportation use of any unused portion of any such street may be
6 made by the city or town without the prior written approval of the
7 department; and all revenue derived from sale, vacation, rental, or
8 any nontransportation use of such rights-of-way shall be shared by
9 the city or town and the state in the same proportion as the purchase
10 costs were shared;

11 (16) If any city or town fails to perform any of its obligations
12 as set forth in this section or in any cooperative agreement entered
13 into with the department for the maintenance of a city or town street
14 forming part of the route of a state highway, the department may
15 notify the mayor of the city or town to perform the necessary
16 maintenance within (~~(thirty)~~) 30 days. If the city or town within the
17 (~~(thirty)~~) 30 days fails to perform the maintenance or fails to
18 authorize the department to perform the maintenance as provided by
19 RCW 47.24.050, the department may perform the maintenance, the cost
20 of which is to be deducted from any sums in the motor vehicle fund
21 credited or to be credited to the city or town;

22 (17) The population thresholds identified in subsections (6) and
23 (13) of this section shall be increased as follows:

24 (a) Thirty thousand on July 1, 2023;

25 (b) Thirty-two thousand five hundred on July 1, (~~(2028)~~) 2025,
26 for cities or towns having a population of 30,000 or less on January
27 1, 2025; and

28 (c) Thirty-five thousand on July 1, (~~(2033)~~) 2030.

29 **Solicited Property Transactions For Transportation Purposes**

30 **Sec. 1306.** RCW 61.--.--- and 2025 c . . . (SHB 1081) s 1 are
31 each amended to read as follows:

32 (1) For real estate transactions executed on or after January 1,
33 2026, in which a potential buyer or someone representing a potential
34 buyer actively solicits the purchase of real property through public
35 advertising or written, electronic, or in-person contact with an
36 owner of real property that is not currently publicly available or
37 listed on the real estate market for purchase, the owner of the
38 solicited real property shall, upon execution of a purchase contract

1 between the potential buyer and the owner of the solicited real
2 property:

3 (a) Have the right to an appraisal of the real property by an
4 appraiser licensed in accordance with chapter 18.140 RCW, which right
5 shall be expressly included in the purchase contract between the
6 potential buyer and the owner of the solicited real property; and

7 (b) Have the right to cancel the purchase contract without
8 penalty or further obligation subject to subsection (2) of this
9 section.

10 (2)(a) For owners of the solicited real property who wish to
11 exercise their right to an appraisal:

12 (i) The owner has the right to select the appraiser, and the
13 potential buyer is responsible for the expense of the appraisal;

14 (ii) The appraisal must be ordered within three business days
15 after the execution of the purchase contract, and the owner of the
16 solicited real property shall notify the potential buyer of the
17 appraisal; and

18 (iii) The owner of the solicited real property has the right to
19 cancel the purchase contract, without penalty or further obligation,
20 within four business days after the appraisal is received.

21 (b) For owners of solicited real property who do not wish to
22 receive an appraisal, the owner has the right to cancel the purchase
23 contract without penalty or further obligation within 10 business
24 days after execution of the contract.

25 (c) In the event of cancellation, the owner of the solicited real
26 property shall send a notice of cancellation to the buyer by mail,
27 telegram, email, or other means of written communication. Notice of
28 cancellation is considered given when mailed, when filed for
29 telegraphic transmission, when emailed, or, if sent by other means,
30 when delivered to the buyer's designated place of business.

31 (3) The purchase contract for a real estate transaction described
32 in this section must state clearly in at least size 10-point boldface
33 type, and the seller must affirmatively acknowledge in writing, that
34 the seller:

35 (a) Has a right to an appraisal as specified in subsection (2) of
36 this section; and

37 (b) Has a right to cancel the purchase contract without penalty
38 or further obligation in accordance with subsection (2) of this
39 section.

1 (4) This section does not apply to a buyer or seller represented
2 by a real estate broker licensed in accordance with chapter 18.85
3 RCW.

4 (5) Nothing in this chapter affects the rights accruing to any
5 party as set forth in RCW 64.04.220.

6 (6) The legislature finds that the practices covered by this
7 section are matters vitally affecting the public interest for the
8 purpose of applying the consumer protection act, chapter 19.86 RCW. A
9 violation of this section is not reasonable in relation to the
10 development and preservation of business and is an unfair or
11 deceptive act in trade or commerce and an unfair method of
12 competition for the purpose of applying the consumer protection act,
13 chapter 19.86 RCW.

14 (7) This section does not apply to any public entity including,
15 but not limited to, the department of transportation, cities, and
16 counties, acquiring real property for transportation purposes.

17 **Tow Truck Impounds**

18 NEW SECTION. **Sec. 1307.** A new section is added to chapter 46.55
19 RCW to read as follows:

20 (1) The department shall create a program to compensate
21 registered tow truck operators for private property impounds or
22 impounds performed at the direction of law enforcement to apply when
23 the owner of the vehicle is indigent, except when the vehicle has
24 been impounded after the vehicle owner has been arrested by a law
25 enforcement officer.

26 (2) An individual seeking the release of a vehicle under this
27 program must:

28 (a) Be the legal or registered owner of the vehicle;

29 (b) Be indigent;

30 (c) Either not have the ability to pay for the towing service or
31 when making such payment would be a severe hardship;

32 (d) Not have applied for the release of a vehicle under this
33 program more than once in the preceding year; and

34 (e) Fill out and certify the first part of the form described in
35 subsection (4)(a) of this section and submit it to the registered tow
36 truck operator.

37 (3) A registered tow truck operator may seek payment for private
38 property impounds or impounds ordered by a law enforcement agency

1 when the impound was not ordered following an arrest, for vehicles
2 owned by individuals meeting the requirements of subsection (2) of
3 this section. The registered tow truck operator applying for payment
4 must fill out the second part of the form described in subsection
5 (4)(b) of this section and must submit the completed form to the
6 department.

7 (4) The department shall provide a form to registered tow truck
8 operators that consists of two parts.

9 (a) The first part of the form is to be completed by individuals
10 seeking the release of a vehicle and must include a requirement that
11 individuals self-certify under penalty of perjury that they meet the
12 requirements of the program and acknowledge that they understand that
13 the department may verify or audit the information and that perjury
14 is a criminal offense.

15 (b)(i) The second part of the form is to be completed by
16 registered tow truck operators and must include a requirement that
17 registered tow truck operators self-certify under penalty of perjury
18 that they have verified that:

19 (A) The impound was a private property impound or ordered by a
20 law enforcement agency;

21 (B) The impound was not ordered following an arrest;

22 (C) The individual seeking the release of a vehicle is the owner
23 of the vehicle registered or titled with the department; and

24 (ii) The registered tow truck operators must acknowledge that
25 they understand that the department may verify or audit the
26 information and that perjury is a criminal offense.

27 (5)(a) Subject to the availability of amounts appropriated for
28 this specific purpose, the department shall disburse excess funds
29 deposited under RCW 46.55.130(2)(h) that are no longer subject to
30 payment for a valid claim under RCW 46.55.130(2)(h) in an amount
31 equal to the cost of the towing, storage, or other services incurred
32 by the registered tow truck operators during the course of the
33 private property impound or law enforcement directed impound to the
34 eligible registered tow truck operators following submission of the
35 form by the registered tow truck operator. Eligibility for payment
36 under this section does not constitute an entitlement for payment. If
37 eligible applications for payment exceed the funds available, the
38 department must create and maintain a waitlist in the order the forms
39 are received pursuant to this section. The department is not civilly

1 or criminally liable and no penalty or cause of action may be brought
2 against it regarding the provision or lack of provision of funds.

3 (b) After consulting with appropriate stakeholders, the
4 department must develop rules establishing maximum rates of
5 reimbursement for towing, storage, and other services, under this
6 subsection. The department shall convene a stakeholder work group
7 every two years, with the first meeting to be held within 12 months
8 of rule adoption, to make recommendations on amendments to these
9 rules.

10 (6) The department shall provide an annual report to the
11 appropriate committees of the legislature by October 1st of each
12 year. The annual report must include the total number of law
13 enforcement directed tows not following an arrest, the number of
14 vehicles released under this program, the number of applicants who
15 received payment under this program, the total funds provided to
16 applicants, the number of applicants on the waitlist who did not
17 receive grants, the total amount of grants unpaid due to lack of
18 funds, and the number of ineligible applicants and the reasons for
19 ineligibility.

20 (7) A registered tow truck operator who releases the vehicle
21 under this section does not have a lien or deficiency claim on the
22 released vehicle.

23 (8) When an impounding tow truck operator sends notification to
24 the legal and registered owners of a vehicle regarding the
25 impoundment of it as required under RCW 46.55.110 and the vehicle may
26 be eligible under this program, the impounding tow truck operator
27 must include information in the notification about the program
28 established in this section for the release of vehicles to indigent
29 persons.

30 (9) The registered tow truck operator shall provide to each
31 person who seeks to redeem an impounded vehicle that may be eligible
32 under this program written notice, in a form and manner specified by
33 the department, of the release of vehicles to indigent individuals.
34 The notice must be accompanied by the form described in subsection
35 (4) of this section.

36 **Sec. 1308.** RCW 46.55.115 and 1993 c 121 s 2 are each amended to
37 read as follows:

38 The Washington state patrol, under its authority to remove
39 vehicles from the highway, may remove the vehicles directly, through

1 towing operators appointed by the state patrol and called on a
2 rotational or other basis, through contracts with towing operators,
3 or by a combination of these methods. When removal is to be
4 accomplished through a towing operator on a noncontractual basis, the
5 state patrol may appoint any towing operator for this purpose upon
6 the application of the operator. Each appointment shall be contingent
7 upon the submission of an application to the state patrol and the
8 making of subsequent reports in such form and frequency and
9 compliance with such standards of equipment, performance, pricing,
10 and practices as may be required by rule of the state patrol.

11 An appointment may be rescinded by the state patrol upon evidence
12 that the appointed towing operator is not complying with the laws or
13 rules relating to the removal and storage of vehicles from the
14 highway. The state patrol may not rescind an appointment merely
15 because a registered tow truck operator negotiates a different rate
16 for voluntary, owner-requested towing than for involuntary towing
17 under this chapter. The costs of removal and storage of vehicles
18 under this section shall be paid by the owner or driver of the
19 vehicle and shall be a lien upon the vehicle until paid, unless the
20 removal is determined to be invalid or the registered tow truck
21 operator releases the vehicle under the program established in
22 section 1307 of this act.

23 Rules promulgated under this section shall be binding only upon
24 those towing operators appointed by the state patrol for the purpose
25 of performing towing services at the request of the Washington state
26 patrol. Any person aggrieved by a decision of the state patrol made
27 under this section may appeal the decision under chapter 34.05 RCW.

28 **Sec. 1309.** RCW 46.55.120 and 2017 c 152 s 1 are each amended to
29 read as follows:

30 (1)(a) Vehicles or other items of personal property registered or
31 titled with the department that are impounded by registered tow truck
32 operators pursuant to RCW 46.55.080, 46.55.085, 46.55.113, or
33 9A.88.140 may be redeemed only by the following persons or entities:

- 34 (i) The legal owner;
35 (ii) The registered owner;
36 (iii) A person authorized in writing by the registered owner;
37 (iv) The vehicle's insurer or a vendor working on behalf of the
38 vehicle's insurer;

1 (v) A third-party insurer that has a duty to repair or replace
2 the vehicle, has obtained consent from the registered owner or the
3 owner's agent to move the vehicle, and has documented that consent in
4 the insurer's claim file, or a vendor working on behalf of a third-
5 party insurer that has received such consent; provided, however, that
6 at all times the registered owner must be granted access to and may
7 reclaim possession of the vehicle. For the purposes of this
8 subsection, "owner's agent" means the legal owner of the vehicle, a
9 driver in possession of the vehicle with the registered owner's
10 permission, or an adult member of the registered owner's family;

11 (vi) A person who is determined and verified by the operator to
12 have the permission of the registered owner of the vehicle or other
13 item of personal property registered or titled with the department;

14 (vii) A person who has purchased a vehicle or item of personal
15 property registered or titled with the department from the registered
16 owner who produces proof of ownership or written authorization and
17 signs a receipt therefor; or

18 (viii) If (a)(i) through (vii) of this subsection do not apply, a
19 person, who is known to the registered or legal owner of a motorcycle
20 or moped, as each are defined in chapter 46.04 RCW, that was towed
21 from the scene of an accident, may redeem the motorcycle or moped as
22 a bailment in accordance with RCW 46.55.125 while the registered or
23 legal owner is admitted as a patient in a hospital due to the
24 accident.

25 (b) In addition, a vehicle impounded because the operator is in
26 violation of RCW 46.20.342(1)(c) shall not be released until a person
27 eligible to redeem it under (a) of this subsection satisfies the
28 requirements of (f) of this subsection, including paying all towing,
29 removal, and storage fees, notwithstanding the fact that the hold was
30 ordered by a government agency. If the department's records show that
31 the operator has been convicted of a violation of RCW 46.20.342 or a
32 similar local ordinance within the past five years, the vehicle may
33 be held for up to (~~thirty~~) 30 days at the written direction of the
34 agency ordering the vehicle impounded. A vehicle impounded because
35 the operator is arrested for a violation of RCW 46.20.342 may be
36 released only pursuant to a written order from the agency that
37 ordered the vehicle impounded or from the court having jurisdiction.
38 An agency shall issue a written order to release pursuant to a
39 provision of an applicable state agency rule or local ordinance
40 authorizing release on the basis of the following:

1 (i) Economic or personal hardship to the spouse of the operator,
2 taking into consideration public safety factors, including the
3 operator's criminal history and driving record; or

4 (ii) The owner of the vehicle was not the driver, the owner did
5 not know that the driver's license was suspended or revoked, and the
6 owner has not received a prior release under this subsection or RCW
7 46.55.113(3).

8 In order to avoid discriminatory application, other than for the
9 reasons for release set forth in (b)(i) and (ii) of this subsection,
10 an agency shall, under a provision of an applicable state agency rule
11 or local ordinance, deny release in all other circumstances without
12 discretion.

13 If a vehicle is impounded because the operator is in violation of
14 RCW 46.20.342(1) (a) or (b), the vehicle may be held for up to
15 (~~thirty~~) 30 days at the written direction of the agency ordering
16 the vehicle impounded. However, if the department's records show that
17 the operator has been convicted of a violation of RCW 46.20.342(1)
18 (a) or (b) or a similar local ordinance within the past five years,
19 the vehicle may be held at the written direction of the agency
20 ordering the vehicle impounded for up to (~~sixty~~) 60 days, and for
21 up to (~~ninety~~) 90 days if the operator has two or more such prior
22 offenses. If a vehicle is impounded because the operator is arrested
23 for a violation of RCW 46.20.342, the vehicle may not be released
24 until a person eligible to redeem it under (a) of this subsection
25 satisfies the requirements of (f) of this subsection, including
26 paying all towing, removal, and storage fees, notwithstanding the
27 fact that the hold was ordered by a government agency.

28 (c) If the vehicle is directed to be held for a suspended license
29 impound, a person who desires to redeem the vehicle at the end of the
30 period of impound shall within five days of the impound at the
31 request of the tow truck operator pay a security deposit to the tow
32 truck operator of not more than one-half of the applicable impound
33 storage rate for each day of the proposed suspended license impound.
34 The tow truck operator shall credit this amount against the final
35 bill for removal, towing, and storage upon redemption. The tow truck
36 operator may accept other sufficient security in lieu of the security
37 deposit. If the person desiring to redeem the vehicle does not pay
38 the security deposit or provide other security acceptable to the tow
39 truck operator, the tow truck operator may process and sell at
40 auction the vehicle as an abandoned vehicle within the normal time

1 limits set out in RCW 46.55.130(1). The security deposit required by
2 this section may be paid and must be accepted at any time up to
3 (~~twenty-four~~) 24 hours before the beginning of the auction to sell
4 the vehicle as abandoned. The registered owner is not eligible to
5 purchase the vehicle at the auction, and the tow truck operator shall
6 sell the vehicle to the highest bidder who is not the registered
7 owner.

8 (d) Notwithstanding (c) of this subsection, a rental car business
9 may immediately redeem a rental vehicle it owns by payment of the
10 costs of removal, towing, and storage, whereupon the vehicle will not
11 be held for a suspended license impound.

12 (e) Notwithstanding (c) of this subsection, a motor vehicle
13 dealer or lender with a perfected security interest in the vehicle
14 may redeem or lawfully repossess a vehicle immediately by payment of
15 the costs of removal, towing, and storage, whereupon the vehicle will
16 not be held for a suspended license impound. A motor vehicle dealer
17 or lender with a perfected security interest in the vehicle may not
18 knowingly and intentionally engage in collusion with a registered
19 owner to repossess and then return or resell a vehicle to the
20 registered owner in an attempt to avoid a suspended license impound.
21 However, this provision does not preclude a vehicle dealer or a
22 lender with a perfected security interest in the vehicle from
23 repossessing the vehicle and then selling, leasing, or otherwise
24 disposing of it in accordance with chapter 62A.9A RCW, including
25 providing redemption rights to the debtor under RCW 62A.9A-623. If
26 the debtor is the registered owner of the vehicle, the debtor's right
27 to redeem the vehicle under chapter 62A.9A RCW is conditioned upon
28 the debtor obtaining and providing proof from the impounding
29 authority or court having jurisdiction that any fines, penalties, and
30 forfeitures owed by the registered owner, as a result of the
31 suspended license impound, have been paid, and proof of the payment
32 must be tendered to the vehicle dealer or lender at the time the
33 debtor tenders all other obligations required to redeem the vehicle.
34 Vehicle dealers or lenders are not liable for damages if they rely in
35 good faith on an order from the impounding agency or a court in
36 releasing a vehicle held under a suspended license impound.

37 (f) The vehicle or other item of personal property registered or
38 titled with the department shall be released upon the presentation to
39 any person having custody of the vehicle of commercially reasonable
40 tender sufficient to cover the costs of towing, storage, or other

1 services rendered during the course of towing, removing, impounding,
2 or storing any such vehicle, with credit being given for the amount
3 of any security deposit paid under (c) of this subsection.
4 Alternatively, a vehicle must be released when the registered tow
5 truck operator completes the form described in section 1307(4) of
6 this act provided that the first part of the form is completed by an
7 individual seeking the release of a vehicle. In addition, if a
8 vehicle is impounded because the operator was arrested for a
9 violation of RCW 46.20.342 or 46.20.345 and was being operated by the
10 registered owner when it was impounded under local ordinance or
11 agency rule, it must not be released to any person until the
12 registered owner establishes with the agency that ordered the vehicle
13 impounded or the court having jurisdiction that any penalties, fines,
14 or forfeitures owed by him or her have been satisfied. Registered tow
15 truck operators are not liable for damages if they rely in good faith
16 on an order from the impounding agency or a court in releasing a
17 vehicle held under a suspended license impound. Commercially
18 reasonable tender shall include, without limitation, cash, major bank
19 credit cards issued by financial institutions, or personal checks
20 drawn on Washington state branches of financial institutions if
21 accompanied by two pieces of valid identification, one of which may
22 be required by the operator to have a photograph. If the towing firm
23 cannot determine through the customer's bank or a check verification
24 service that the presented check would be paid by the bank or
25 guaranteed by the service, the towing firm may refuse to accept the
26 check. Any person who stops payment on a personal check or credit
27 card, or does not make restitution within (~~ten~~) 10 days from the
28 date a check becomes insufficient due to lack of funds, to a towing
29 firm that has provided a service pursuant to this section or in any
30 other manner defrauds the towing firm in connection with services
31 rendered pursuant to this section shall be liable for damages in the
32 amount of twice the towing and storage fees, plus costs and
33 reasonable attorney's fees.

34 (2)(a) The registered tow truck operator shall give to each
35 person who seeks to redeem an impounded vehicle, or item of personal
36 property registered or titled with the department, written notice of
37 the right of redemption and opportunity for a hearing, which notice
38 shall be accompanied by a form to be used for requesting a hearing,
39 the name of the person or agency authorizing the impound, and a copy
40 of the towing and storage invoice. The registered tow truck operator

1 shall maintain a record evidenced by the redeeming person's signature
2 that such notification was provided.

3 (b) Any person seeking to redeem an impounded vehicle under this
4 section has a right to a hearing in the district or municipal court
5 for the jurisdiction in which the vehicle was impounded to contest
6 the validity of the impoundment or the amount of towing and storage
7 charges. The district court has jurisdiction to determine the issues
8 involving all impoundments including those authorized by the state or
9 its agents. The municipal court has jurisdiction to determine the
10 issues involving impoundments authorized by agents of the
11 municipality. Any request for a hearing shall be made in writing on
12 the form provided for that purpose and must be received by the
13 appropriate court within (~~ten~~) 10 days of the date the opportunity
14 was provided for in (a) of this subsection and more than five days
15 before the date of the auction. At the time of the filing of the
16 hearing request, the petitioner shall pay to the court clerk a filing
17 fee in the same amount required for the filing of a suit in district
18 court. If the hearing request is not received by the court within the
19 (~~ten-day~~) 10-day period, the right to a hearing is waived and the
20 registered owner is liable for any towing, storage, or other
21 impoundment charges permitted under this chapter. Upon receipt of a
22 timely hearing request, the court shall proceed to hear and determine
23 the validity of the impoundment.

24 (3) (a) The court, within five days after the request for a
25 hearing, shall notify the registered tow truck operator, the person
26 requesting the hearing if not the owner, the registered and legal
27 owners of the vehicle or other item of personal property registered
28 or titled with the department, and the person or agency authorizing
29 the impound in writing of the hearing date and time.

30 (b) At the hearing, the person or persons requesting the hearing
31 may produce any relevant evidence to show that the impoundment,
32 towing, or storage fees charged were not proper. The court may
33 consider a written report made under oath by the officer who
34 authorized the impoundment in lieu of the officer's personal
35 appearance at the hearing.

36 (c) At the conclusion of the hearing, the court shall determine
37 whether the impoundment was proper, whether the towing or storage
38 fees charged were in compliance with the posted rates, and who is
39 responsible for payment of the fees. The court may not adjust fees or
40 charges that are in compliance with the posted or contracted rates.

1 (d) If the impoundment is found proper, the impoundment, towing,
2 and storage fees as permitted under this chapter together with court
3 costs shall be assessed against the person or persons requesting the
4 hearing, unless the operator did not have a signed and valid
5 impoundment authorization from a private property owner or an
6 authorized agent.

7 (e) If the impoundment is determined to be in violation of this
8 chapter, then the registered and legal owners of the vehicle or other
9 item of personal property registered or titled with the department
10 shall bear no impoundment, towing, or storage fees, and any security
11 shall be returned or discharged as appropriate, and the person or
12 agency who authorized the impoundment shall be liable for any towing,
13 storage, or other impoundment fees permitted under this chapter. The
14 court shall enter judgment in favor of the registered tow truck
15 operator against the person or agency authorizing the impound for the
16 impoundment, towing, and storage fees paid. In addition, the court
17 shall enter judgment in favor of the registered and legal owners of
18 the vehicle, or other item of personal property registered or titled
19 with the department, for the amount of the filing fee required by law
20 for the impound hearing petition as well as reasonable damages for
21 loss of the use of the vehicle during the time the same was impounded
22 against the person or agency authorizing the impound. However, if an
23 impoundment arising from an alleged violation of RCW 46.20.342 or
24 46.20.345 is determined to be in violation of this chapter, then the
25 law enforcement officer directing the impoundment and the government
26 employing the officer are not liable for damages if the officer
27 relied in good faith and without gross negligence on the records of
28 the department in ascertaining that the operator of the vehicle had a
29 suspended or revoked driver's license. If any judgment entered is not
30 paid within (~~fifteen~~) 15 days of notice in writing of its entry,
31 the court shall award reasonable attorneys' fees and costs against
32 the defendant in any action to enforce the judgment. Notice of entry
33 of judgment may be made by registered or certified mail, and proof of
34 mailing may be made by affidavit of the party mailing the notice.
35 Notice of the entry of the judgment shall read essentially as
36 follows:

10 (4) Any impounded abandoned vehicle or item of personal property
11 registered or titled with the department that is not redeemed within
12 (~~fifteen~~) 15 days of mailing of the notice of custody and sale as
13 required by RCW 46.55.110(3) shall be sold at public auction in
14 accordance with all the provisions and subject to all the conditions
15 of RCW 46.55.130. A vehicle or item of personal property registered
16 or titled with the department may be redeemed at any time before the
17 start of the auction either upon (~~payment~~):

- 18 (a) Payment of the applicable towing and storage fees; or
- 19 (b) The completion of the form specified in section 1307 of this
- 20 act.

21 **Tax Increment Financing for Transportation Projects**

22 **Sec. 1310.** RCW 39.114.020 and 2024 c 236 s 2 are each amended to
23 read as follows:

24 (1) A local government may designate an increment area under this
25 chapter and use the tax allocation revenues to pay public improvement
26 costs, subject to the following conditions:

27 (a) The local government must adopt an ordinance designating an
28 increment area within its boundaries and describing the public
29 improvements proposed to be paid for, or financed with, tax
30 allocation revenues;

31 (b) The local government may not designate increment area
32 boundaries such that the entirety of its territory falls within an
33 increment area;

34 (c) (~~The~~) (i) Except as provided in (c)(ii) of this subsection,
35 the increment area may not have an assessed valuation of more than
36 \$200,000,000 or more than 20 percent of the sponsoring jurisdiction's
37 total assessed valuation, whichever is less, when the ordinance is

1 passed. If a sponsoring jurisdiction creates two increment areas, the
2 total combined assessed valuation in both of the two increment areas
3 may not equal more than \$200,000,000 or more than 20 percent of the
4 sponsoring jurisdiction's total assessed valuation, whichever is
5 less, when the ordinances are passed creating the increment areas.

6 (ii) During the 2026 fiscal year, a sponsoring jurisdiction may
7 enact a tax increment area or areas with a combined assessed
8 valuation greater than \$200,000,000 but no more than \$500,000,000 if:

9 (A) The sponsoring jurisdiction is a city with a population over
10 150,000 but less than 170,000 and is located in a county with a
11 population of over 1,500,000;

12 (B) The tax increment area is connected to Interstate 405 and the
13 transportation-related public improvements that will be funded
14 enhance the integration and connection of neighborhoods within and
15 adjacent to the increment area;

16 (C) The sponsoring jurisdiction enacted an ordinance designating
17 the increment area no later than June 30, 2026; and

18 (D) A governing body of any taxing district within the increment
19 area approves by a majority vote, and according to the governing
20 body's ordinance and publication procedures, the taxing district's
21 partial or full participation in the tax increment project. If the
22 governing body does not approve its participation, the taxing
23 district's property taxes are not subject to apportionment under this
24 chapter and the taxing district is excluded from the provisions of
25 this section;

26 (d) ((A)) Except as otherwise provided in (c)(ii) of this
27 subsection, a local government can create no more than two active
28 increment areas at any given time and they may not physically overlap
29 by including the same land in more than one increment area at any
30 time;

31 (e) The ordinance must set a sunset date for the increment area,
32 which may be no more than 25 years after the first year in which tax
33 allocation revenues are collected from the increment area;

34 (f) The ordinance must identify the public improvements to be
35 financed and indicate whether the local government intends to issue
36 bonds or other obligations, payable in whole or in part, from tax
37 allocation revenues to finance the public improvement costs, and must
38 estimate the maximum amount of obligations contemplated;

1 (g) The ordinance must provide that the increment area takes
2 effect on June 1st following the adoption of the ordinance in (a) of
3 this subsection;

4 (h) The sponsoring jurisdiction may not add additional public
5 improvements to the project after adoption of the ordinance creating
6 the increment area or change the boundaries of the increment area.
7 The sponsoring jurisdiction may expand, alter, or add to the original
8 public improvements when doing so is necessary to assure the
9 originally approved improvements can be constructed or operated;

10 (i) The ordinance must impose a deadline by which commencement of
11 construction of the public improvements shall begin, which deadline
12 must be at least five years into the future and for which extensions
13 shall be made available for good cause; and

14 (j) The local government must make a finding that:

15 (i) The public improvements proposed to be paid or financed with
16 tax allocation revenues are expected to encourage private development
17 within the increment area and to increase the assessed value of real
18 property within the increment area;

19 (ii) Private development that is anticipated to occur within the
20 increment area as a result of the proposed public improvements will
21 be permitted consistent with the permitting jurisdiction's applicable
22 zoning and development standards;

23 (iii) The private development would not reasonably be expected to
24 occur solely through private investment within the reasonably
25 foreseeable future without the proposed public improvements; and

26 (iv) The increased assessed value within the increment area that
27 could reasonably be expected to occur without the proposed public
28 improvements would be less than the increase in the assessed value
29 estimated to result from the proposed development with the proposed
30 public improvements.

31 (2) In considering whether to designate an increment area, the
32 legislative body of the local government must prepare a project
33 analysis that shall include, but need not be limited to, the
34 following:

35 (a) A statement of objectives of the local government for the
36 designated increment area;

37 (b) A statement as to the property within the increment area, if
38 any, that the local government may intend to acquire;

39 (c) The duration of the increment area;

40 (d) Identification of all parcels to be included in the area;

1 (e) A description of the expected private development within the
2 increment area, including a comparison of scenarios with the proposed
3 public improvements and without the proposed public improvements;

4 (f) A description of the public improvements, estimated public
5 improvement costs, and the estimated amount of bonds or other
6 obligations expected to be issued to finance the public improvement
7 costs and repaid with tax allocation revenues;

8 (g) The assessed value of real property listed on the tax roll as
9 certified by the county assessor under RCW 84.52.080 from within the
10 increment area and an estimate of the increment value and tax
11 allocation revenues expected to be generated;

12 (h) An estimate of the job creation reasonably expected to result
13 from the public improvements and the private development expected to
14 occur in the increment area;

15 (i) An assessment of any impacts on the following:

16 (i) Affordable and low-income housing;

17 (ii) The local business community;

18 (iii) The local school districts; and

19 (iv) The local fire service, public hospital service, and
20 emergency medical services; and

21 (j) The assessment of impacts under (i) of this subsection (2)
22 must include any necessary mitigation to the local fire service,
23 public hospital service, and emergency medical services; and

24 (k) An assessment of any impacts of any other junior taxing
25 districts not referenced in (i) of this subsection (2).

26 (3) The local government may charge a private developer, who
27 agrees to participate in creating the increment area, a fee
28 sufficient to cover the cost of the project analysis and establishing
29 the increment area, including staff time, professionals and
30 consultants, and other administrative costs related to establishing
31 the increment area.

32 (4) Nothing in this section prohibits a local government from
33 entering into an agreement under chapter 39.34 RCW with another local
34 government for the administration or other activities related to tax
35 increment financing authorized under this section.

36 (5) (a) If the project analysis indicates that an increment area
37 will impact at least 20 percent of the assessed value in a public
38 hospital district, fire protection district, or regional fire
39 protection service authority, or if the public hospital district's or
40 the fire service agency's annual report, or other governing board-

1 adopted capital facilities plan, demonstrates an increase in the
2 level of service directly related to the increased development in the
3 increment area, the local government must enter into negotiations for
4 a mitigation plan with the impacted public hospital district, fire
5 protection district, or regional fire protection service authority to
6 address level of service issues in the increment area.

7 (b) If the parties cannot agree pursuant to (a) of this
8 subsection (5), the parties must proceed to arbitration to determine
9 the appropriate mitigation plan. The board of arbitrators must
10 consist of three persons: One appointed by the local government
11 seeking to designate the increment area and one appointed by the
12 junior taxing district, both of whom must be appointed within 60 days
13 of the date when arbitration is requested, and a third arbitrator who
14 must be appointed by agreement of the other two arbitrators within 90
15 days of the date when arbitration is requested. If the two are unable
16 to agree on the appointment of the third arbitrator within this 90-
17 day period, then the third arbitrator must be appointed by a judge in
18 the superior court of the county within which the largest portion of
19 the increment area is located. The determination by the board of
20 arbitrators is binding on both the local government seeking to impose
21 the increment area and the junior taxing district.

22 (6) The local government may reimburse the assessor and treasurer
23 for their costs as provided in RCW 39.114.010(6)(e).

24 (7) Prior to the adoption of an ordinance authorizing creation of
25 an increment area, the local government must:

26 (a) Hold at least two public briefings for the community solely
27 on the tax increment project that include the description of the
28 increment area, the public improvements proposed to be financed with
29 the tax allocation revenues, and a detailed estimate of tax revenues
30 for the participating local governments and taxing districts,
31 including the amounts allocated to the increment public improvements.
32 The briefings must be announced at least two weeks prior to the date
33 being held, including publishing in a legal newspaper of general
34 circulation and posting information on the local government website
35 and all local government social media sites, and must occur no
36 earlier than 90 days after submitting the project analysis to the
37 office of the treasurer and all local governments and taxing
38 districts impacted by the increment area;

1 (b) Submit the project analysis to all local governments and
2 taxing districts impacted by the increment area no less than 90 days
3 prior to the adoption of the ordinance; and

4 (c) Submit the project analysis to the office of the treasurer
5 for review and consider any comments that the treasurer may provide
6 upon completion of their review of the project analysis as provided
7 under this subsection. The treasurer must complete the review within
8 90 days of receipt of the project analysis and may consult with other
9 agencies and outside experts as necessary. Upon completing their
10 review, the treasurer must promptly provide to the local government
11 any comments regarding suggested revisions or enhancements to the
12 project analysis that the treasurer deems appropriate based on the
13 requirements in subsection (2) of this section.

21 component taxing district could have levied under RCW 84.55.092 plus
22 the additional dollar amount calculated by multiplying the regular
23 property tax rate of each component district for the preceding year
24 by the increase in assessed value in each component district

5 subsection (3)(b)(v) does not apply to levies by the state or by port
6 districts and public utility districts for the purpose of making
7 required payments of principal and interest on general indebtedness.
8 For the purposes of this subsection (3)(b)(v), "increment area" does
9 not include increment areas that are not approved by the taxing
10 district's governing body for participation in the tax increment
11 project pursuant to RCW 39.114.020(1)(c)(ii)(D).
